



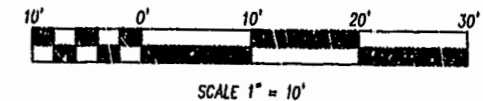
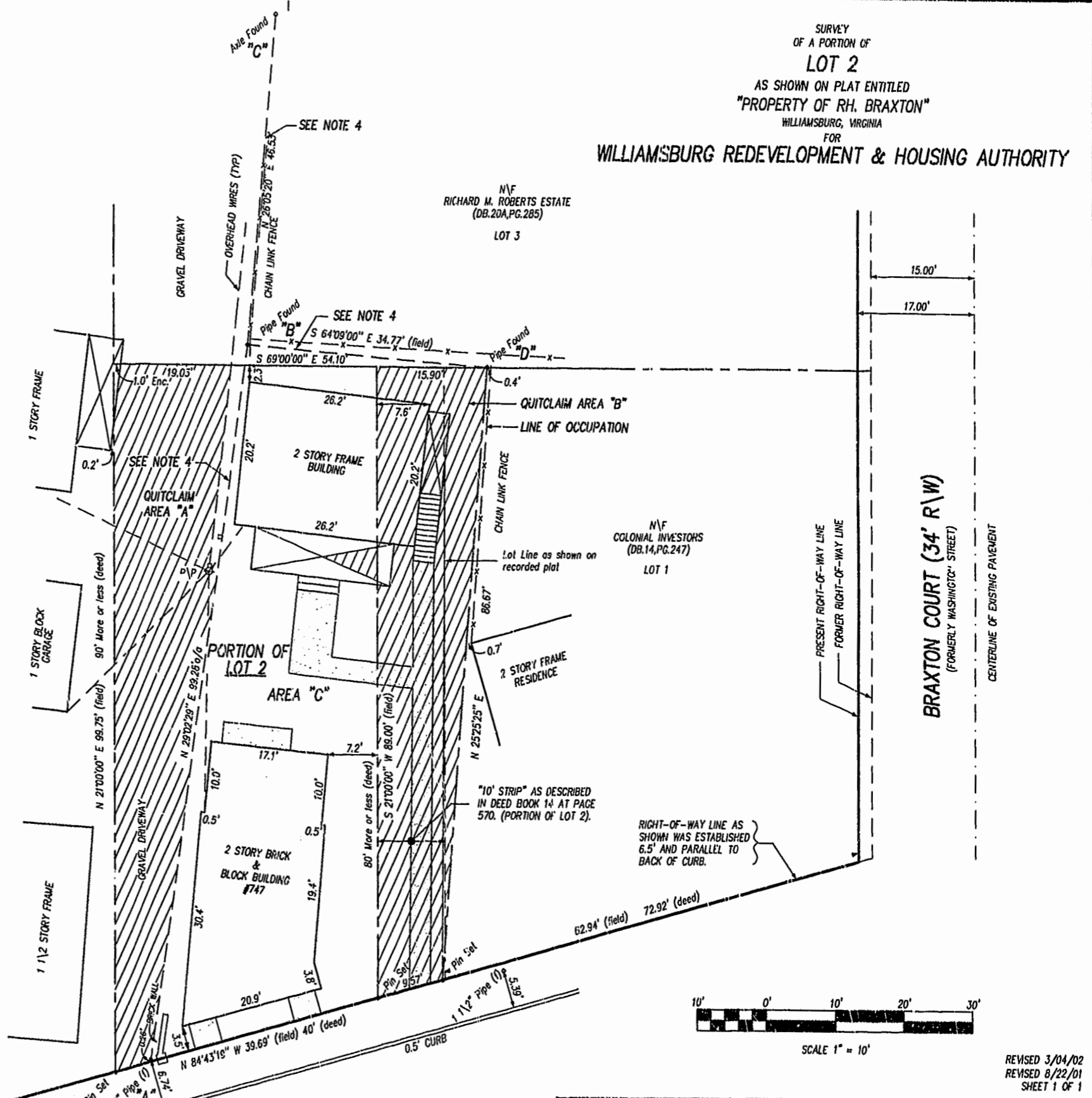
VICINITY MAP
