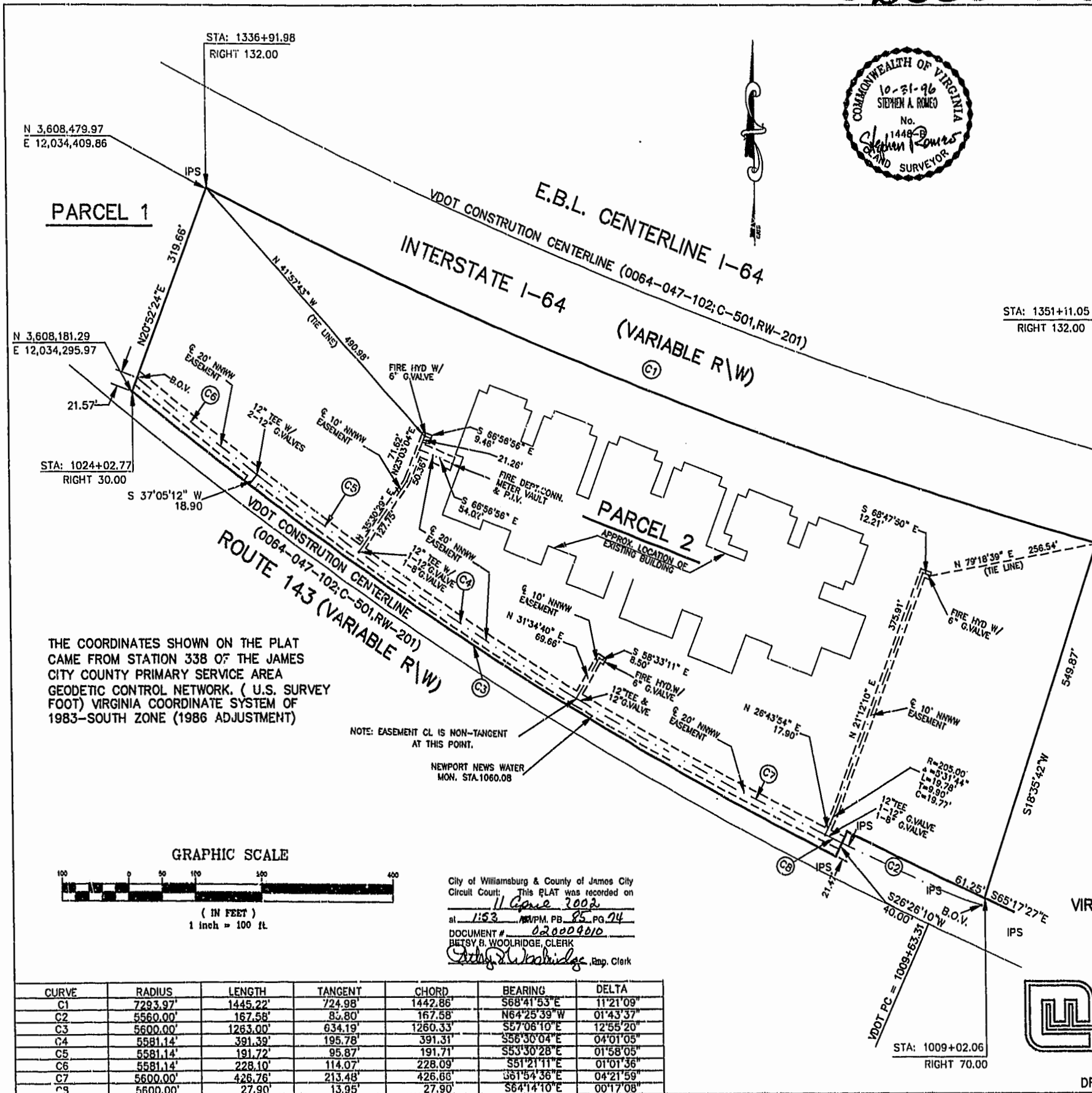


VICINITY MAP

PARCEL 2

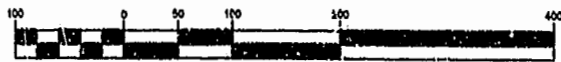
