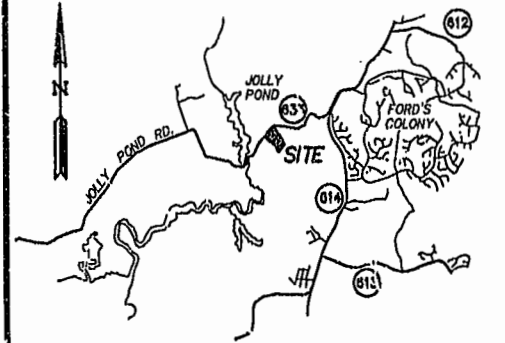

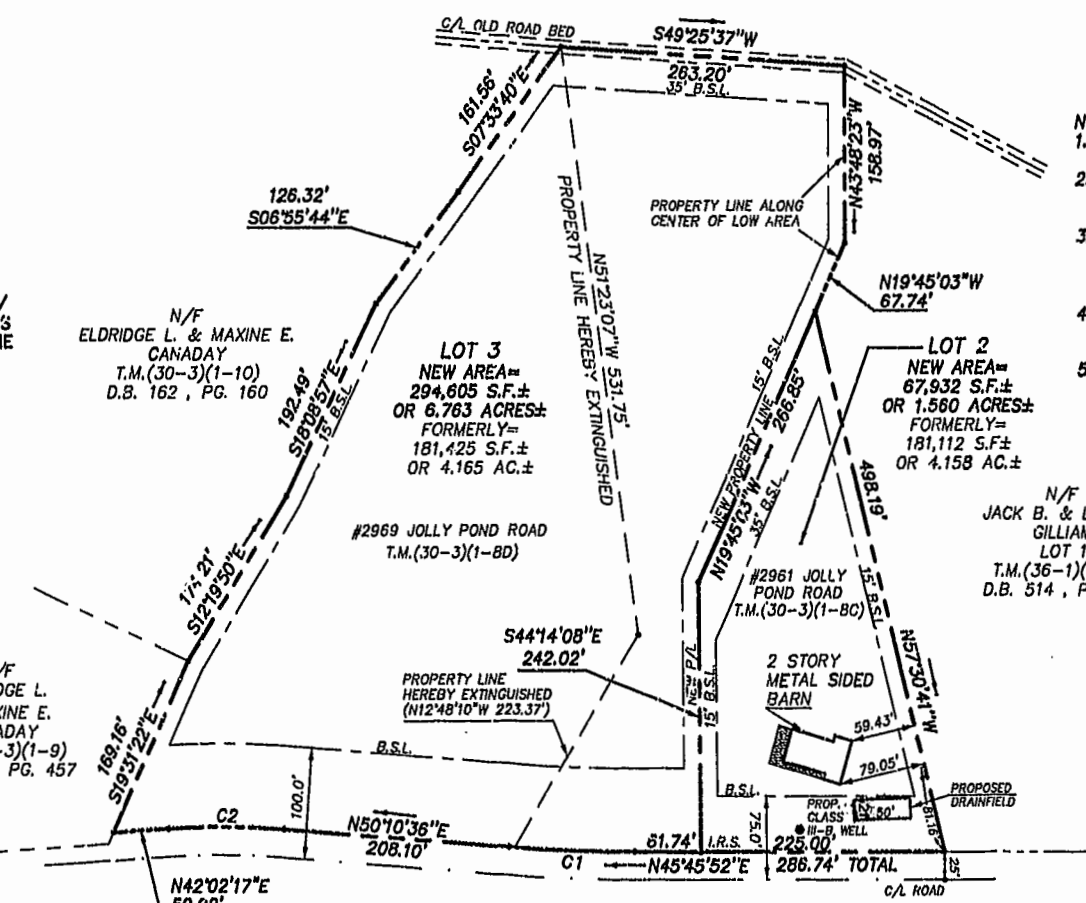

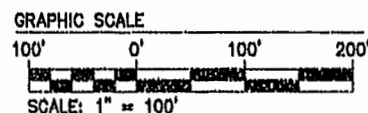


JOLLY POND ROAD ROUTE #633

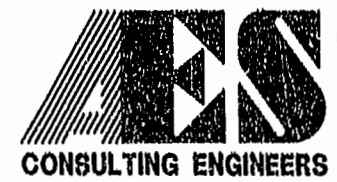


PLAT SHOWING BOUNDARY LINE ADJUSTMENT
