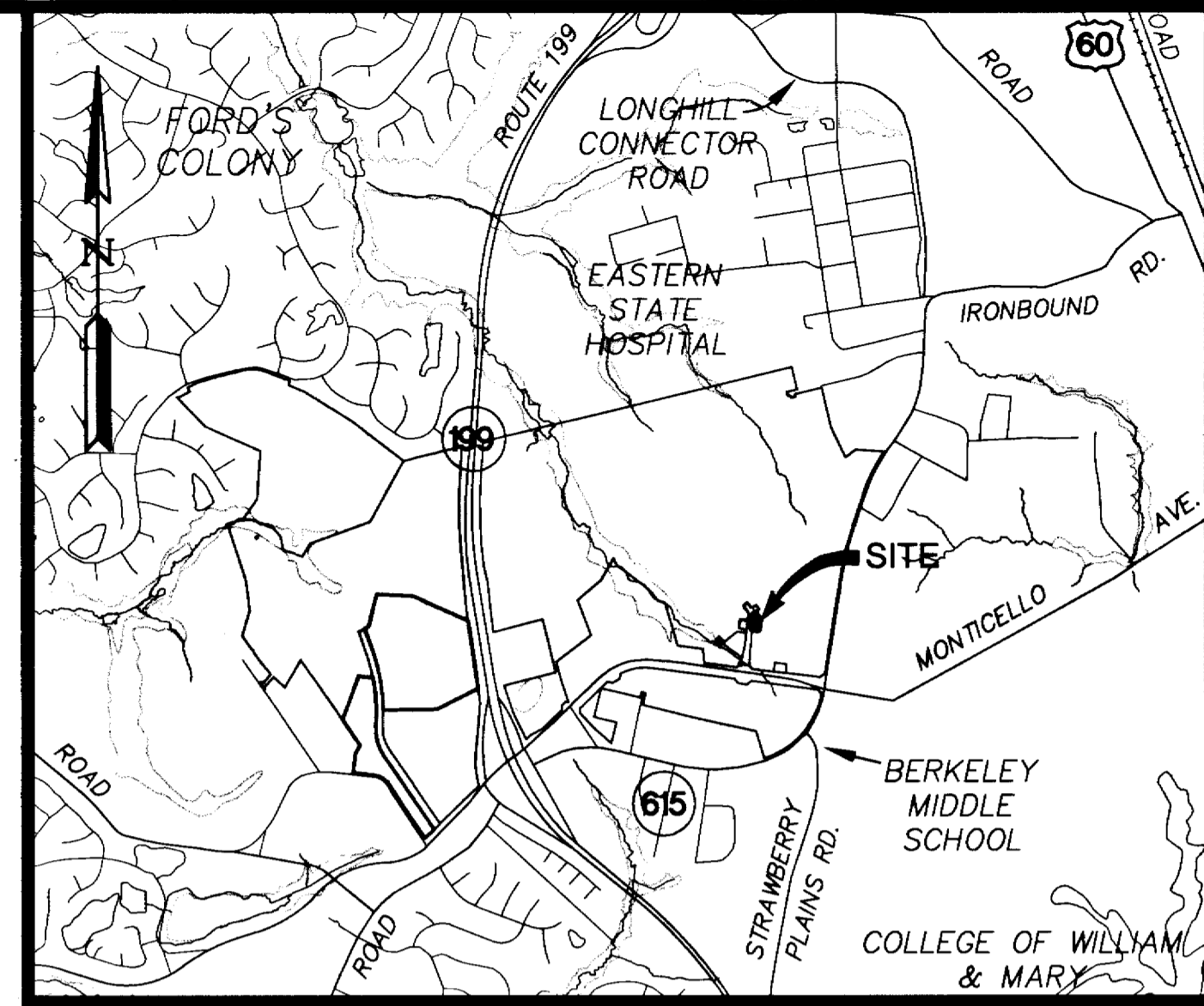

- 4. PROPERTY ADDRESS IS 5206 MONTICELLO AVE, WILLIAMSBURG, VA.

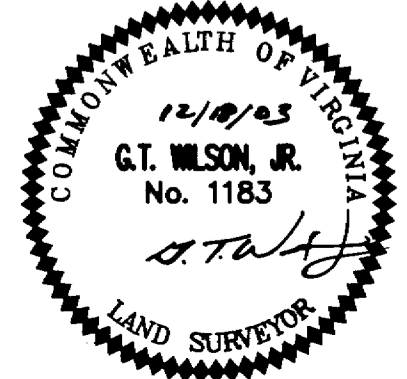
