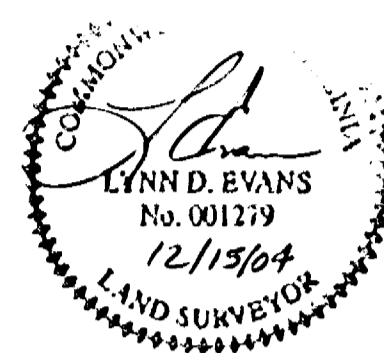

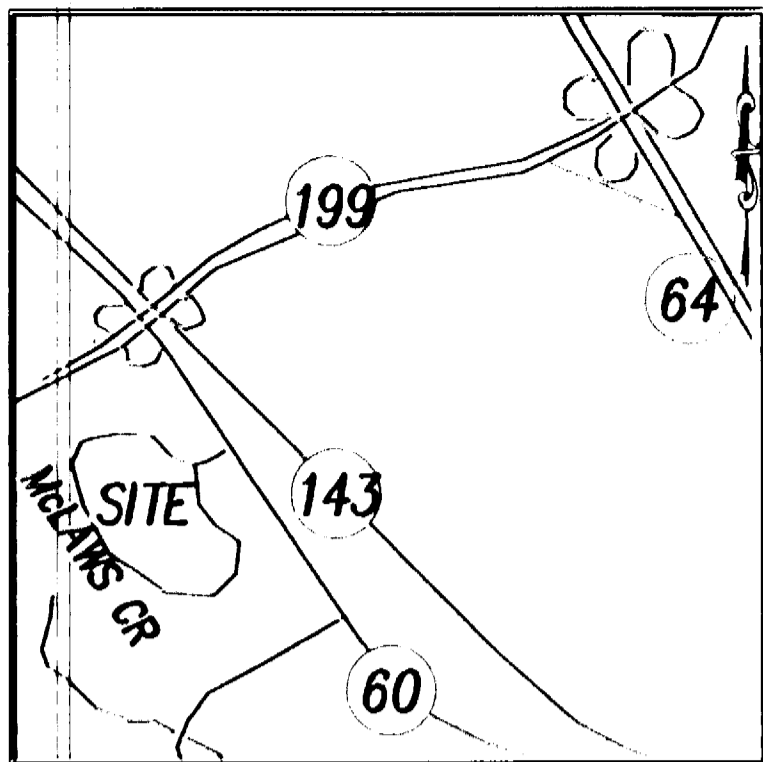

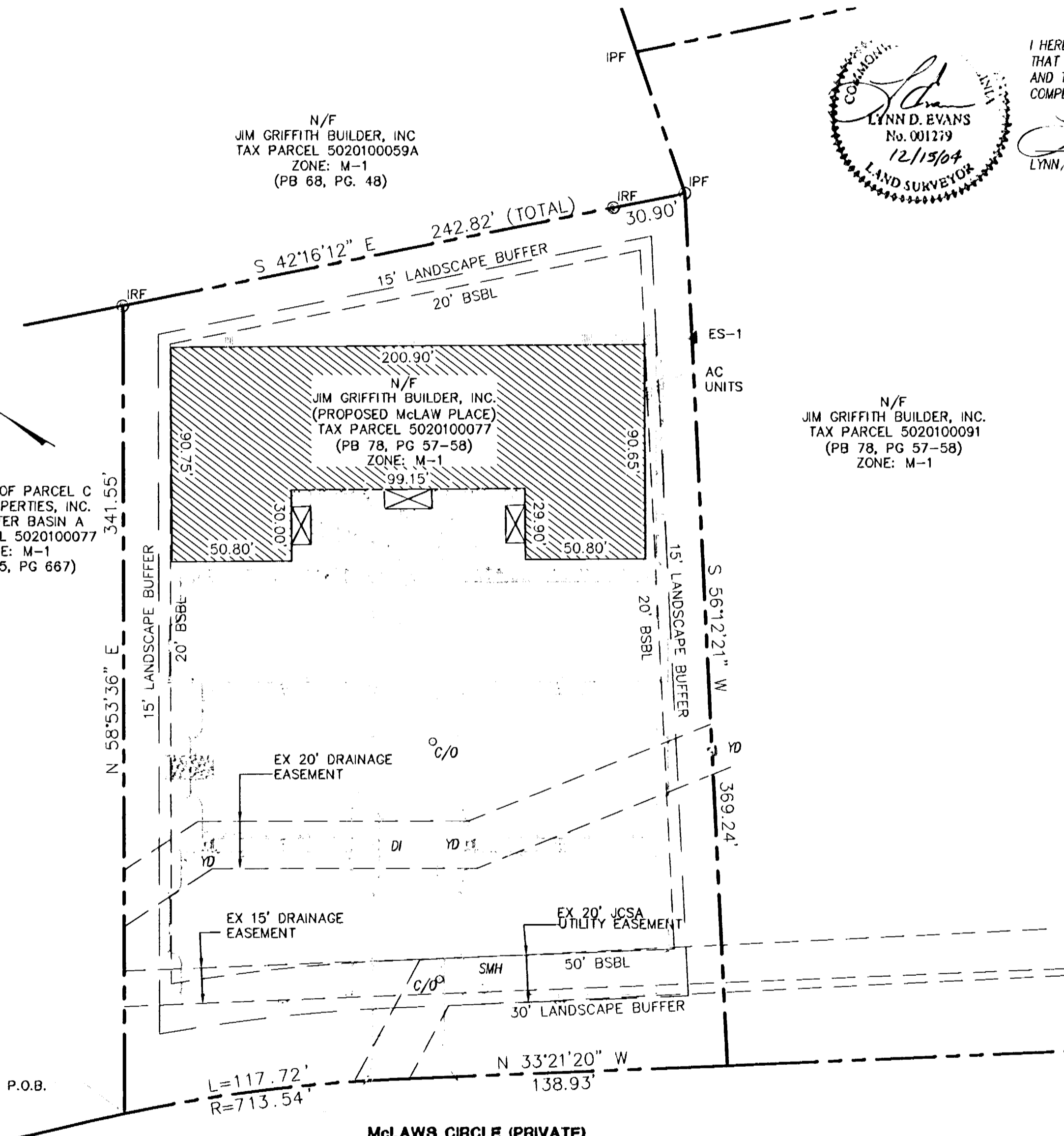
VICINITY MAP

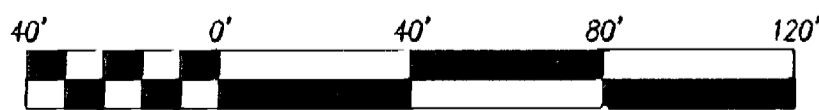
