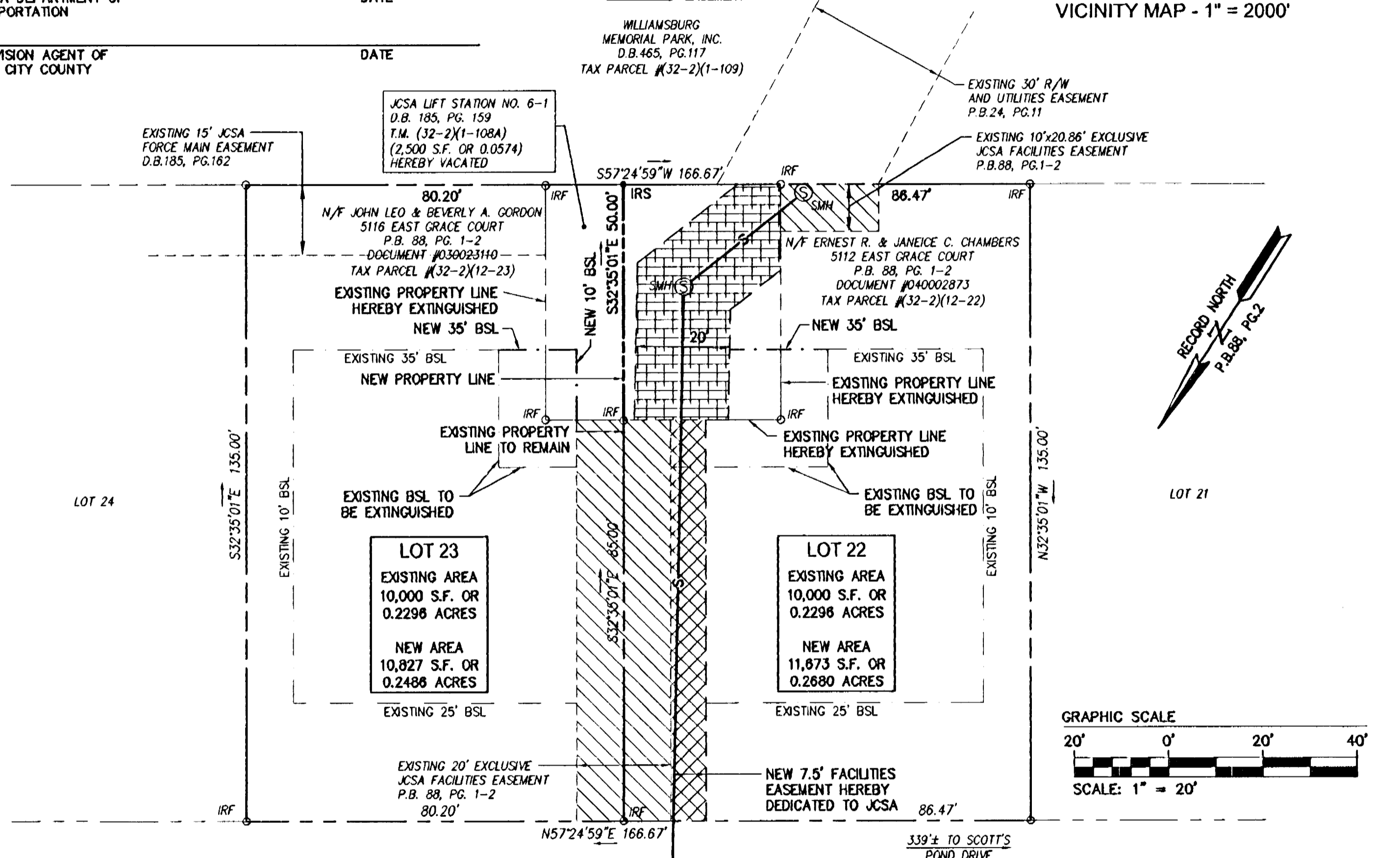

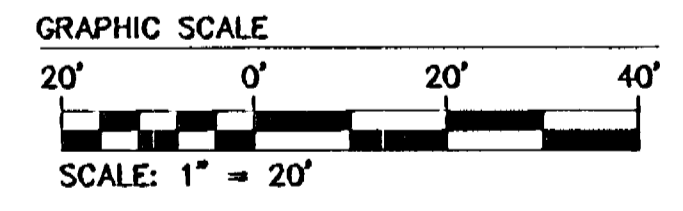

VICINITY MAP - 1" = 2000'



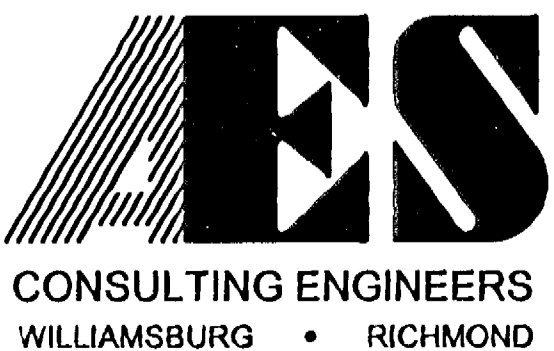

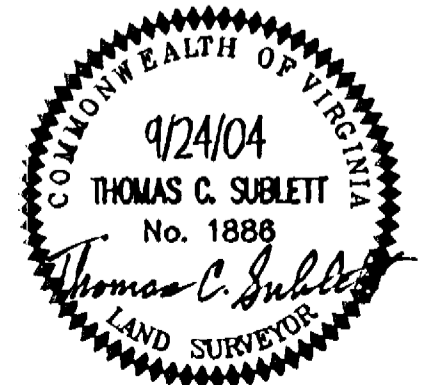
