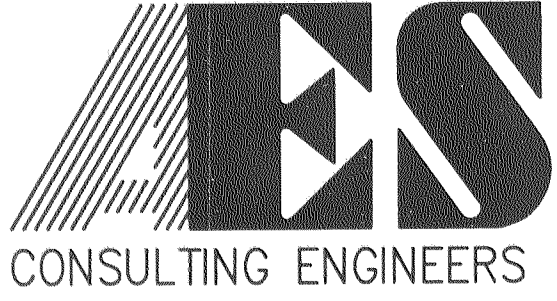

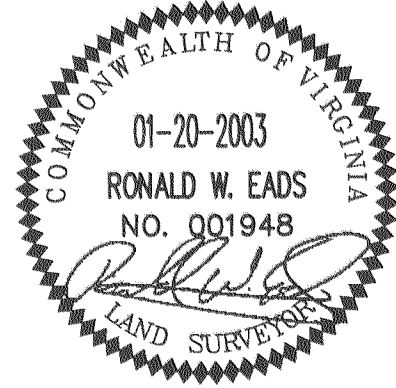
APPROXIMATE LOCATION
