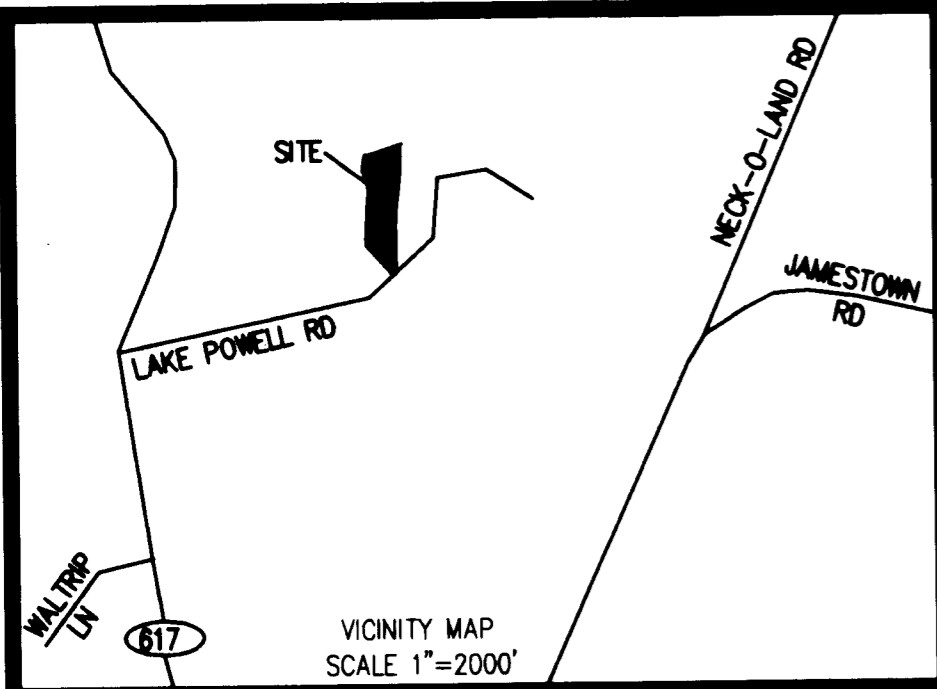

- GENERAL NOTES**
- TOTAL AREA = 8.204 ACRES+/-
  - PROPERTY SHOWN HEREON IS PARCEL ID # 4830100040
  - PROPERTY IS CURRENTLY ZONED "R8"
  - PROPERTY LIES WITHIN FLOOD ZONES X & AE (EL 8.5) PER F.I.R.M. COMMUNITY-PANEL NO. 510201 0045B, DATED FEBRUARY 6, 1991.
  - IN ACCORDANCE WITH SECTION 19-33 OF THE JAMES CITY COUNTY SUBDIVISION ORDINANCE, ALL UTILITIES SHALL BE PLACED UNDERGROUND.
  - UNLESS OTHERWISE NOTED ALL DRAINAGE EASEMENTS IF ANY DESIGNATED ON THIS PLAT SHALL REMAIN PRIVATE.
  - PROPERTY IS TO BE SERVED BY PRIVATE WATER AND SEWER.
  - ANY EXISTING UNUSED WELLS SHALL BE ABANDONED IN ACCORDANCE WITH STATE PRIVATE WELL REGULATIONS AND JAMES CITY COUNTY CODE.
  - ALL OUTDOOR SIGNS ON THE PROPERTIES WITHIN THE DISTRICT SHALL COMPLY WITH THE REGULATIONS FOR EXTERIOR SIGNS IN ARTICLE II, DIVISION 3.

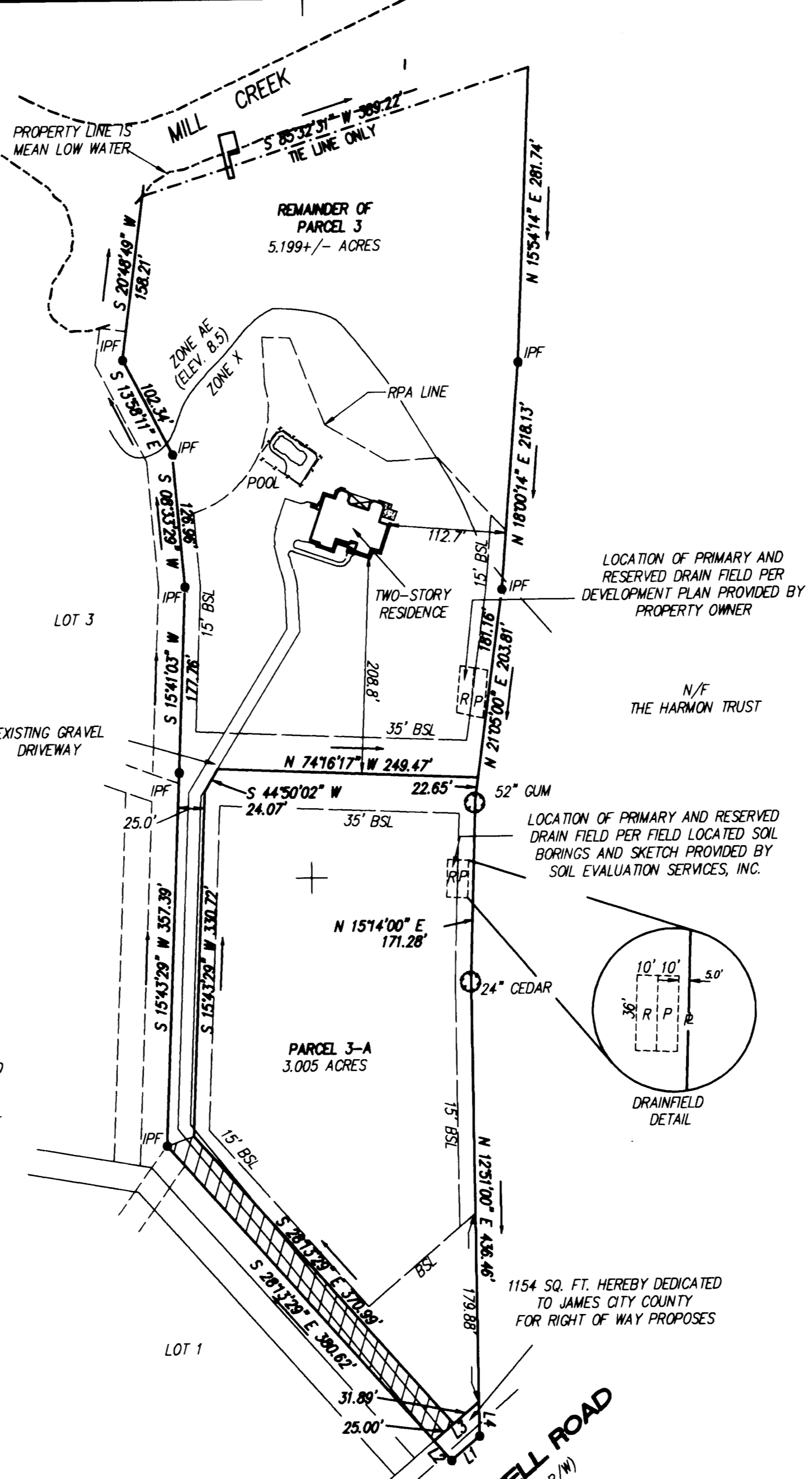
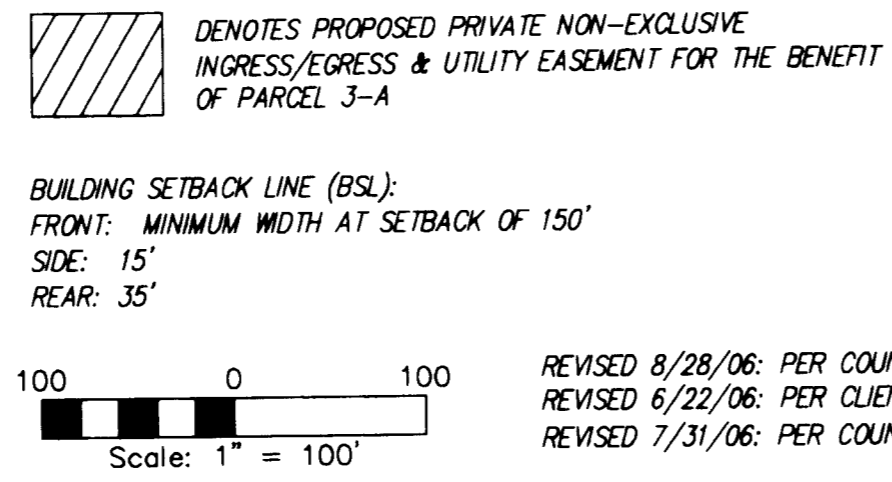

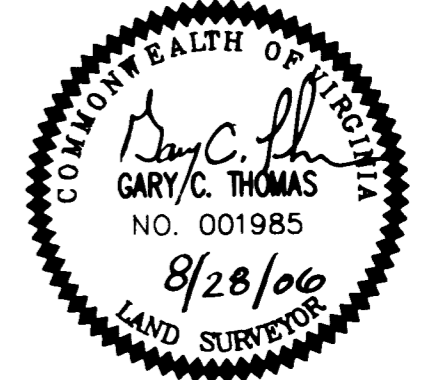
