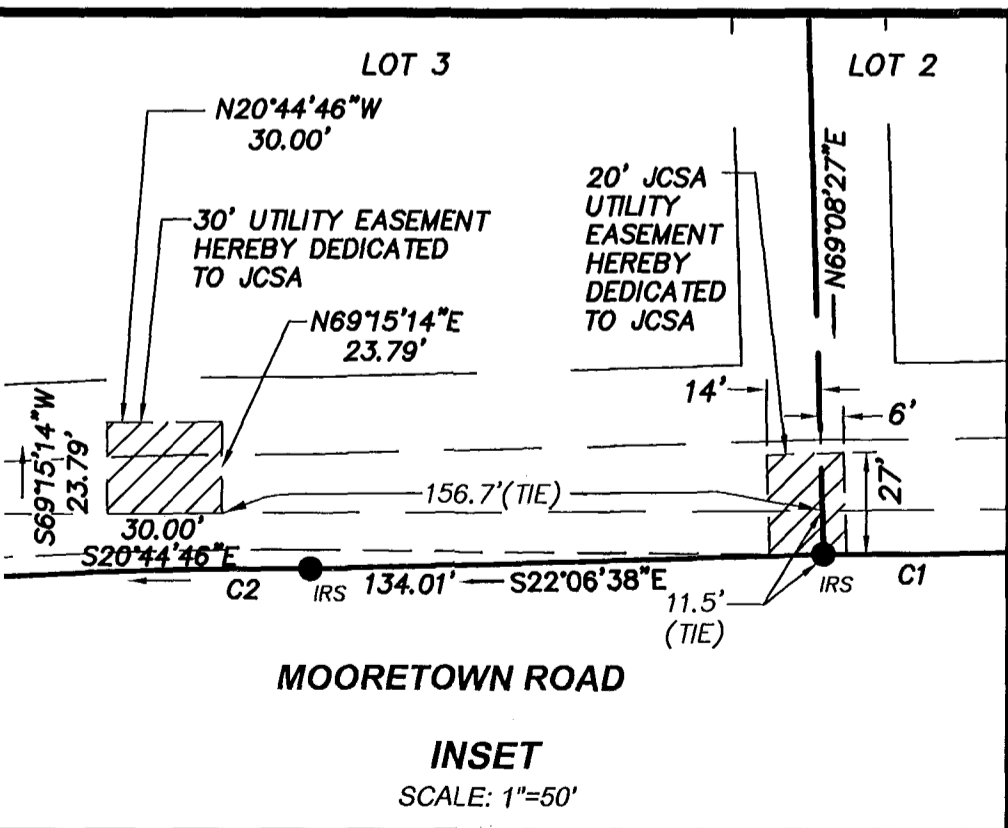

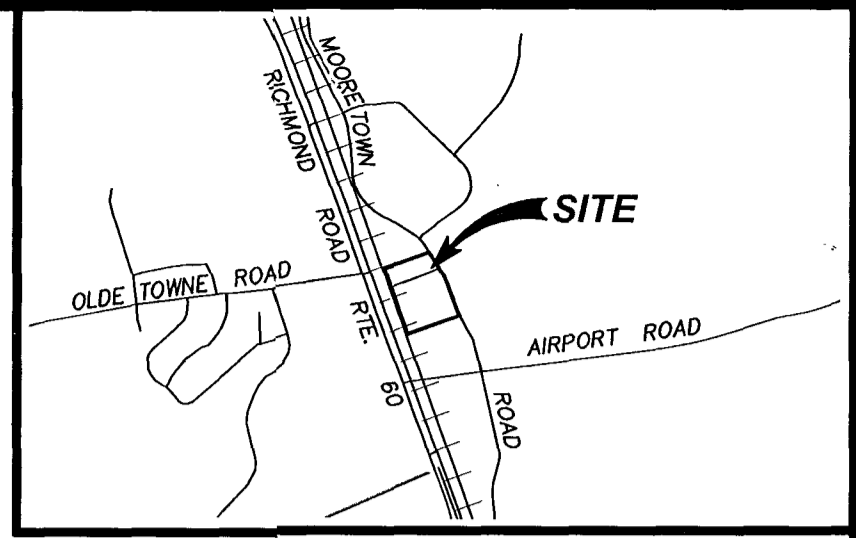

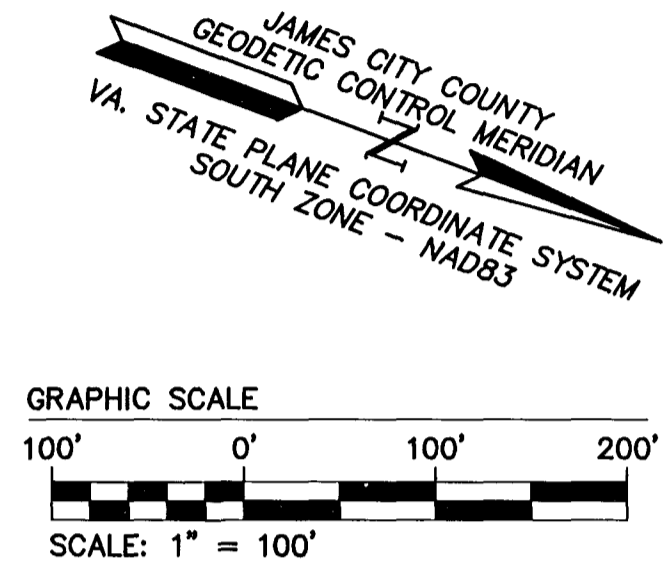
VICINITY MAP SCALE: 1"=2000'

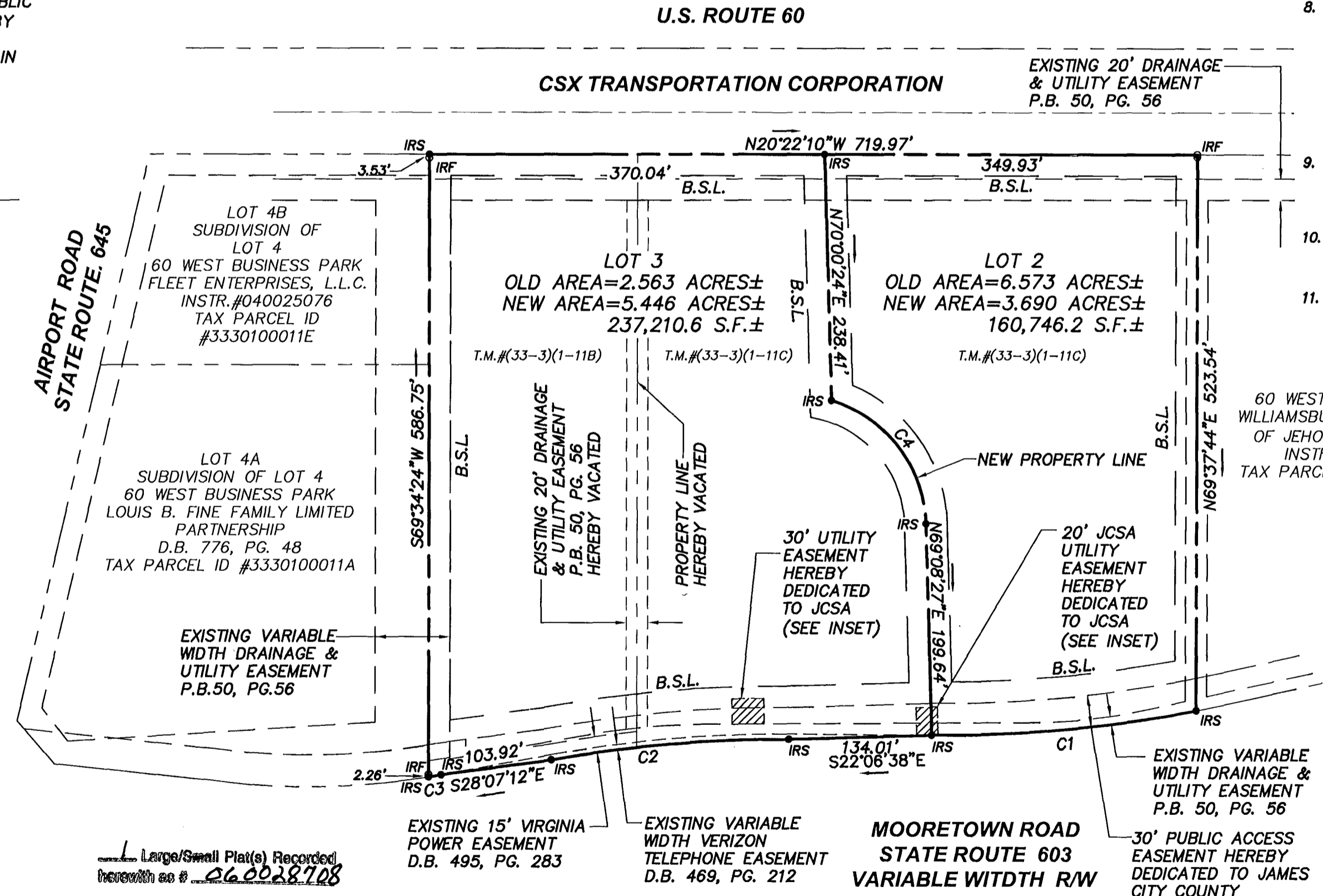
CURVE TABLE

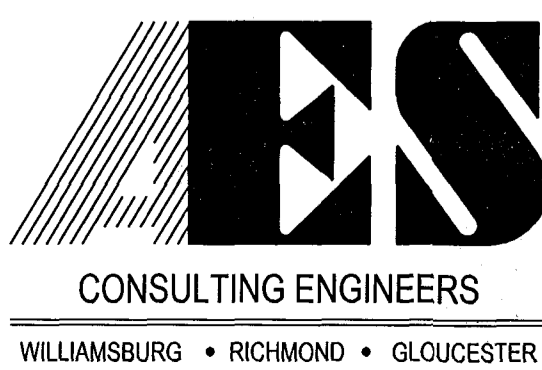

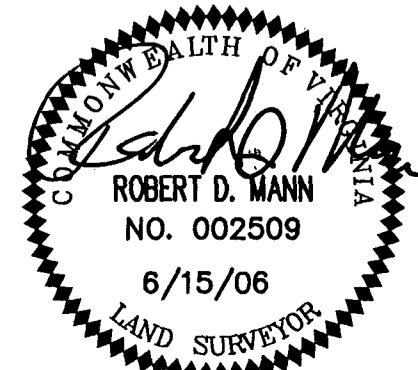
