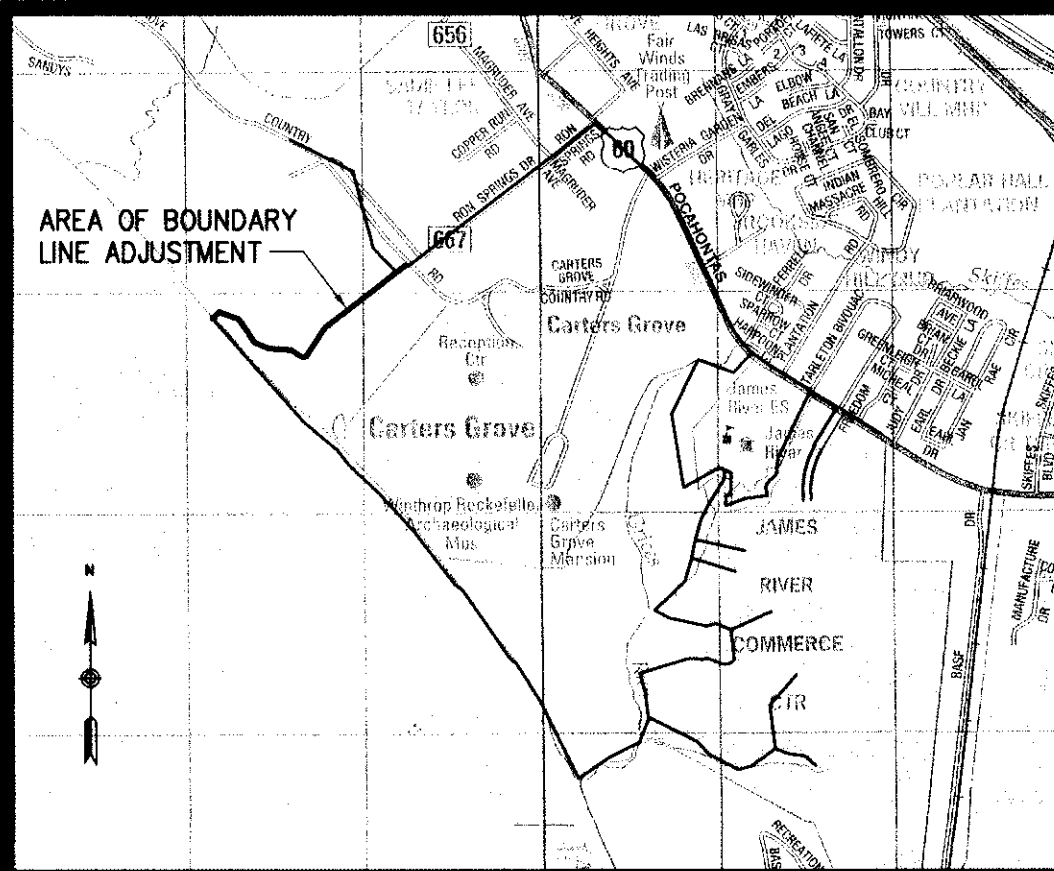

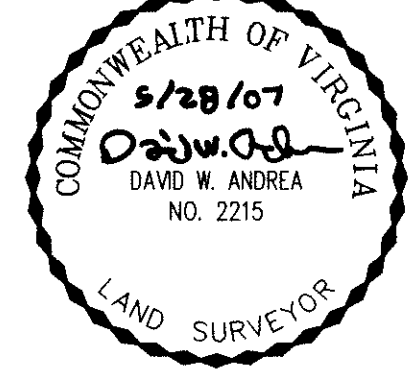
General Notes

1. THE PROPERTY SHOWN HEREON IS LISTED AS TAX PARCEL NUMBER 591-01-00-030 "CARTER GROVE" AND TAX PARCEL NUMBER 582-01-00-002 "MARTIN'S BEACH" THE RECORDS OF THE COUNTY OF JAMES CITY, VIRGINIA REAL ESTATE ASSESSMENT OFFICE.
2. THE PROPERTIES ARE ZONED R8 RURAL RESIDENTIAL DISTRICT ("CARTER'S GROVE") AND R2 GENERAL RESIDENTIAL DISTRICT ("MARTIN'S BEACH")
3. BOUNDARY INFORMATION SHOWN ON THIS PLAT ARE BASED ON JAMES CITY COUNTY GEODETIC CONTROL NETWORK MONUMENT NUMBER 326 AND 327.
4. UNLESS OTHERWISE NOTED, ALL DRAINAGE EASEMENTS DESIGNATED ON THIS PLAT SHALL REMAIN PRIVATE.
5. IN ACCORDANCE WITH SECTION 19-33 OF THE SUBDIVISION ORDINANCE, ALL UTILITIES SHALL BE PLACED UNDERGROUND.
