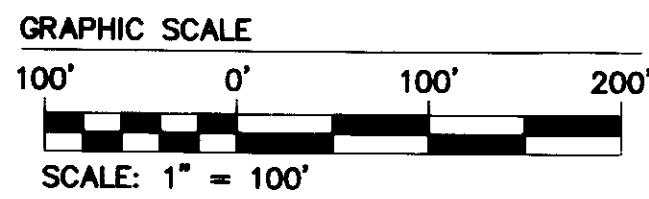

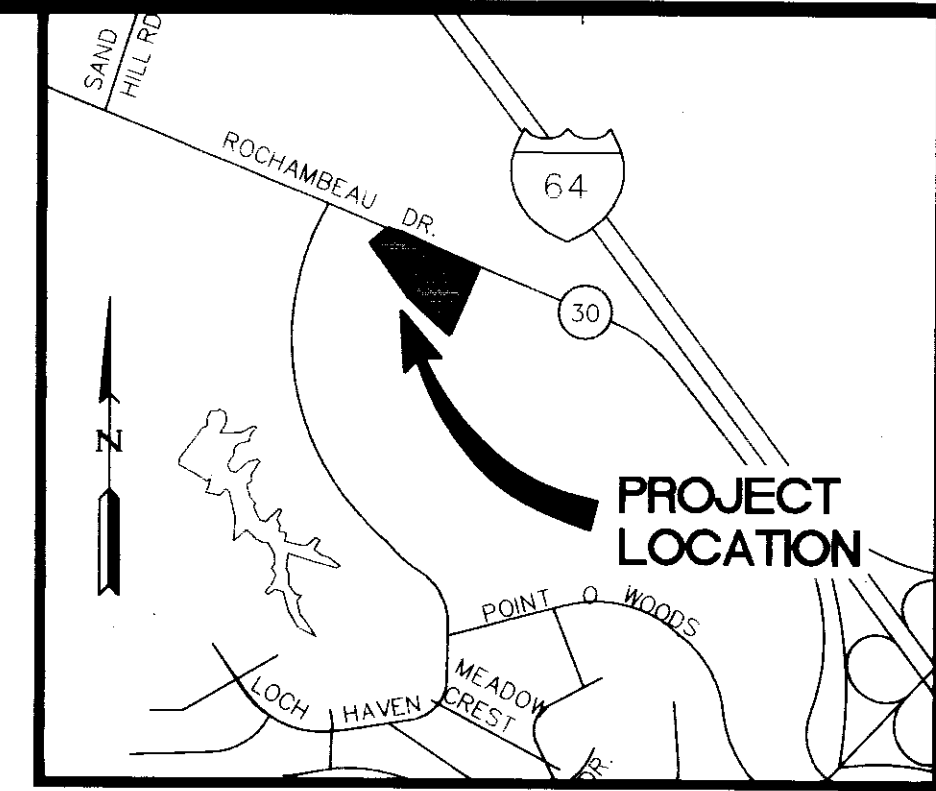
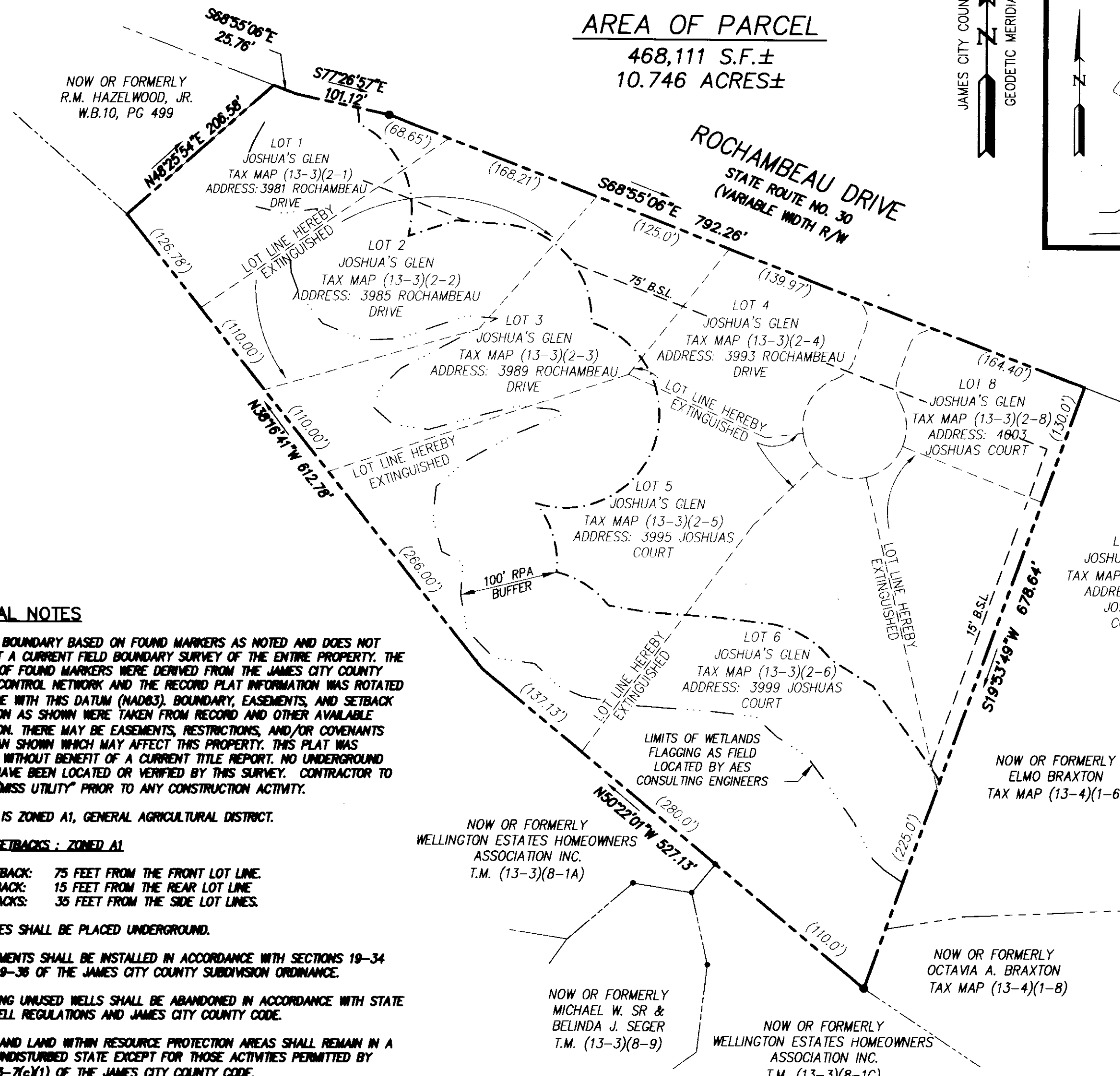
GENERAL NOTES

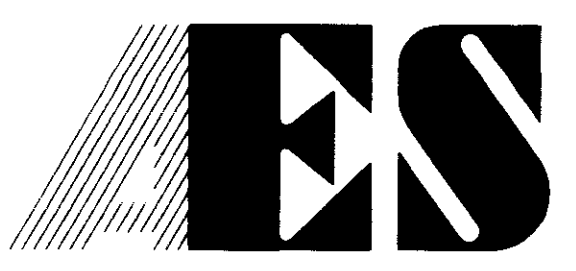

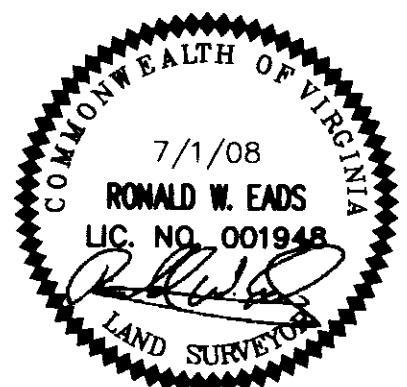
