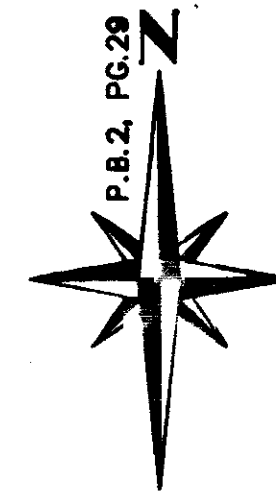


VICINITY MAP 1" = 1000'

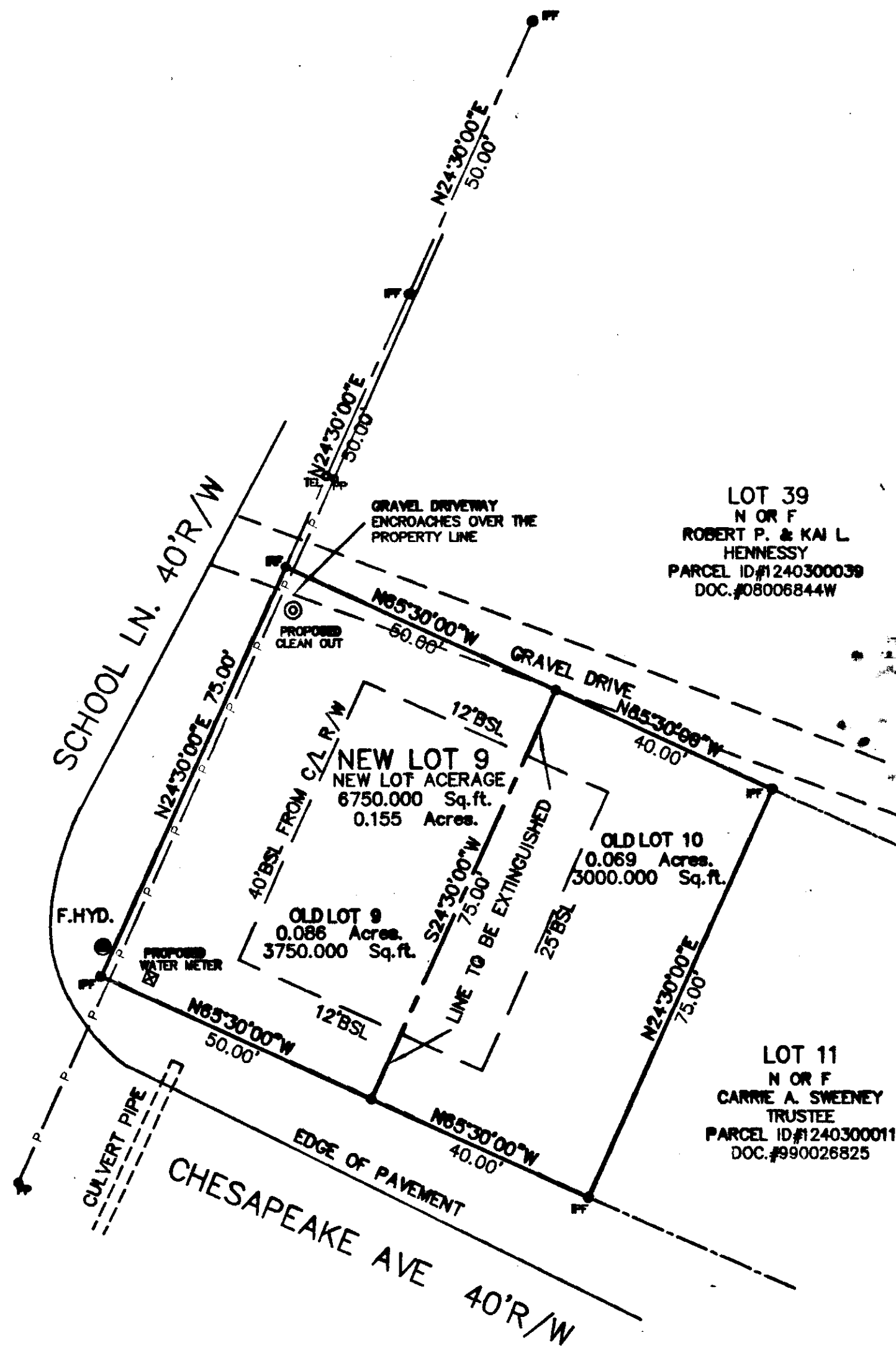

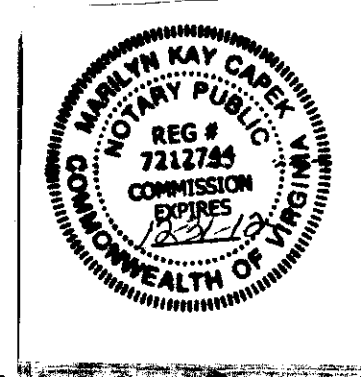

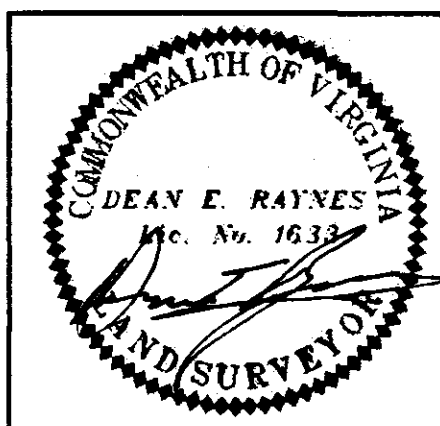
