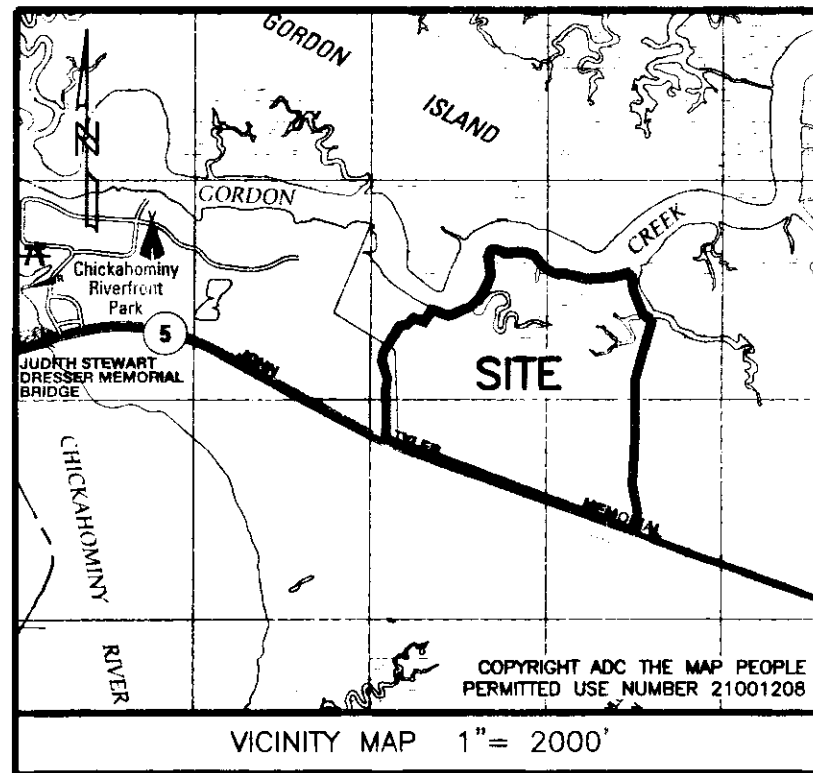

- 4) THE WETLANDS SHOWN HEREON WERE DELINEATED BY ROTH ENVIRONMENTAL, LLC IN FEBRUARY 2001, THE 100' RPA SHOWN ON THIS PLAT IS SHOWN FROM SAID WETLANDS.
