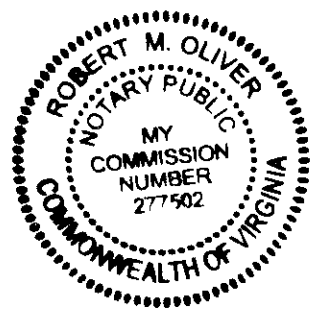

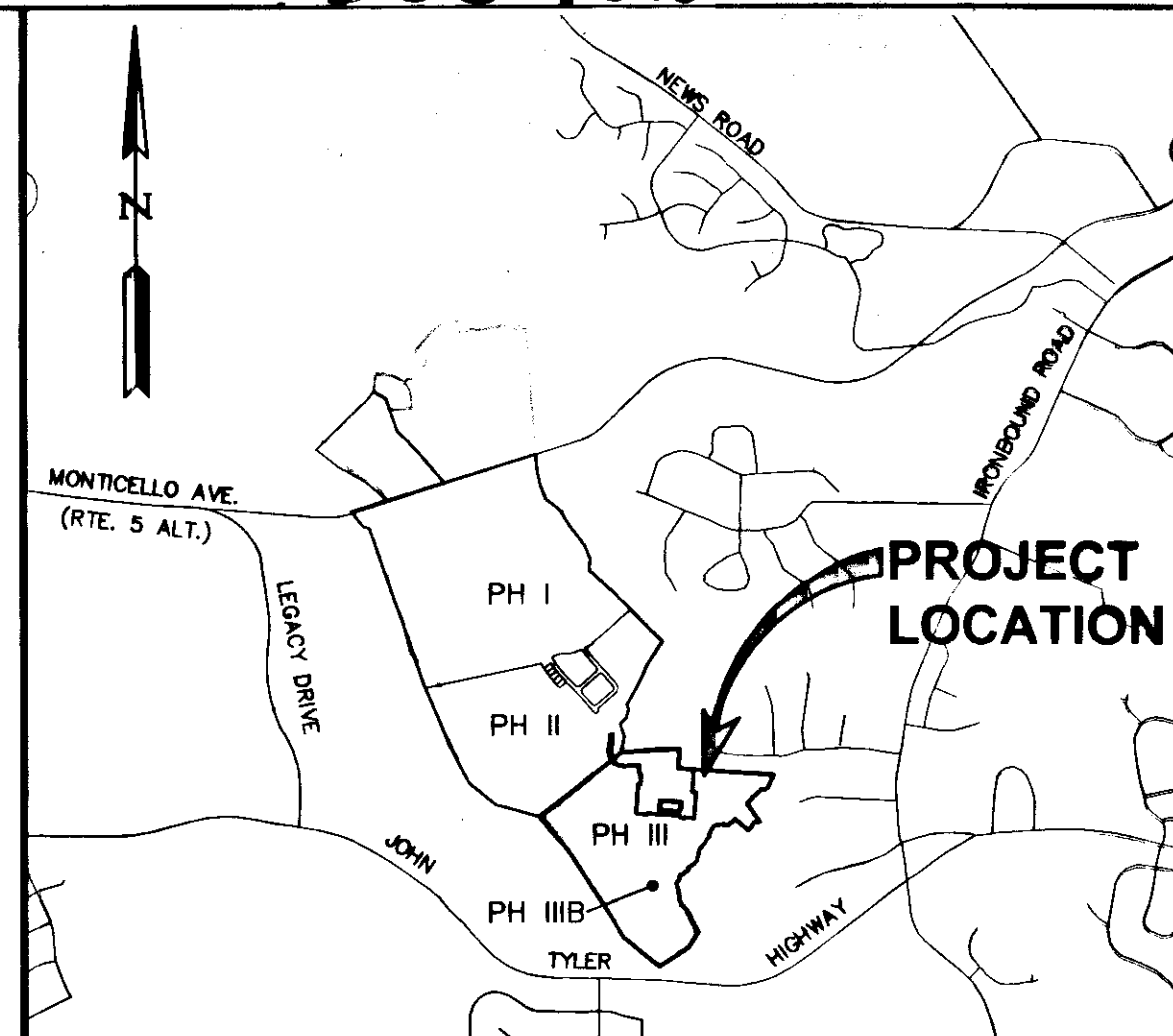

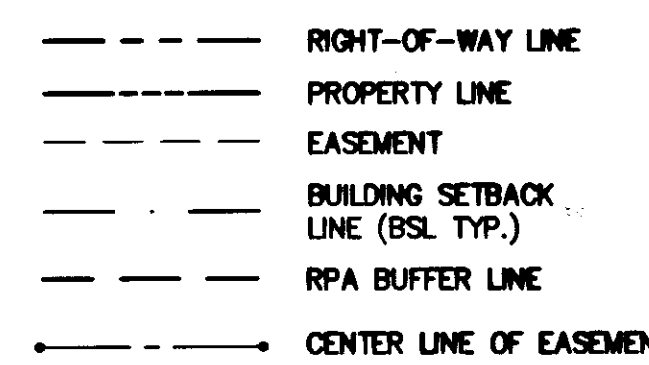


VICINITY MAP SCALE 1"=2000'
