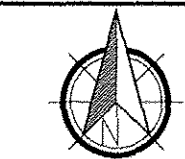
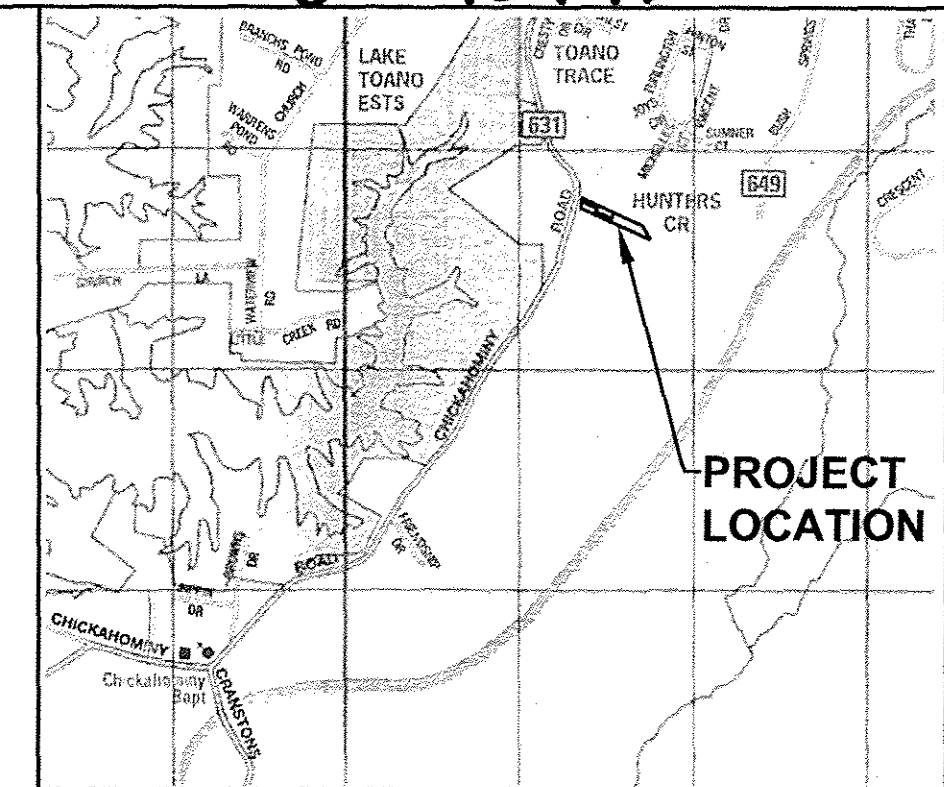
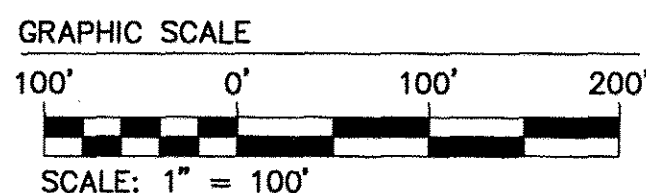
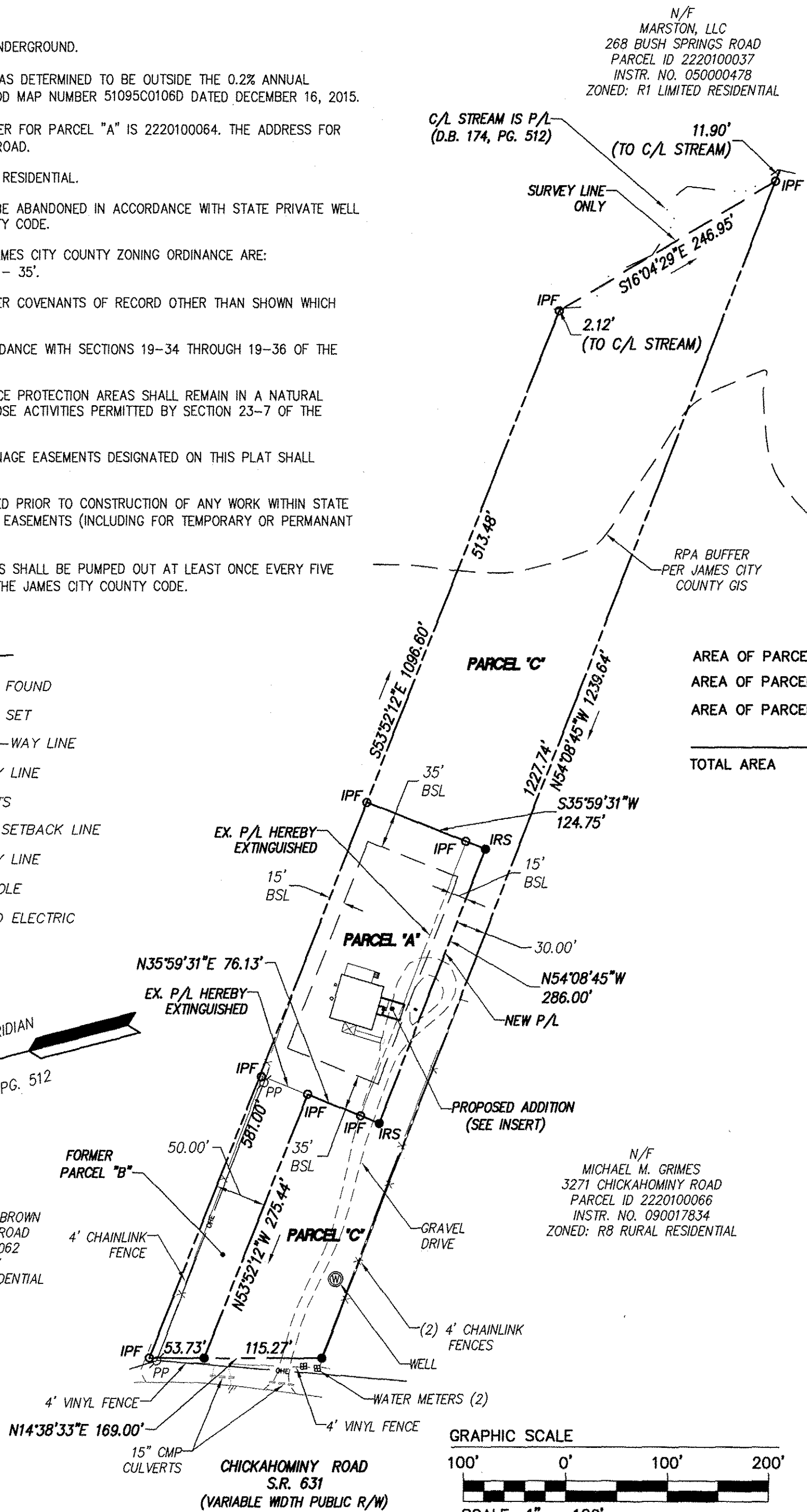
- 1. ALL UTILITIES SHALL BE INSTALLED UNDERGROUND.
2. THIS PROPERTY LIES IN ZONE X (AREAS DETERMINED TO BE OUTSIDE THE 0.2% ANNUAL CHANCE FLOODPLAIN) PER FEMA FLOOD MAP NUMBER 51095C0106D DATED DECEMBER 16, 2015.
3. THE PROPERTY TAX PARCEL ID NUMBER FOR PARCEL "A" IS 2220100064. THE ADDRESS FOR PARCEL "A" IS 3279 CHICKAHOMINY ROAD.
4. THE PARCELS ARE ZONED R8-RURAL RESIDENTIAL.

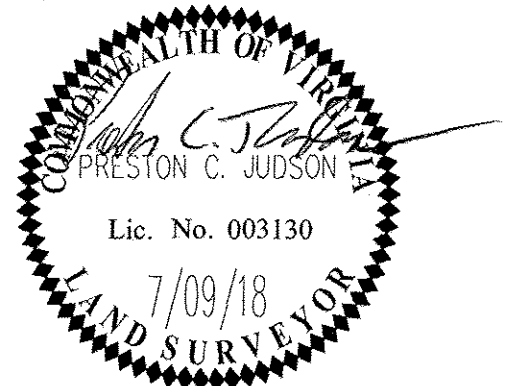
