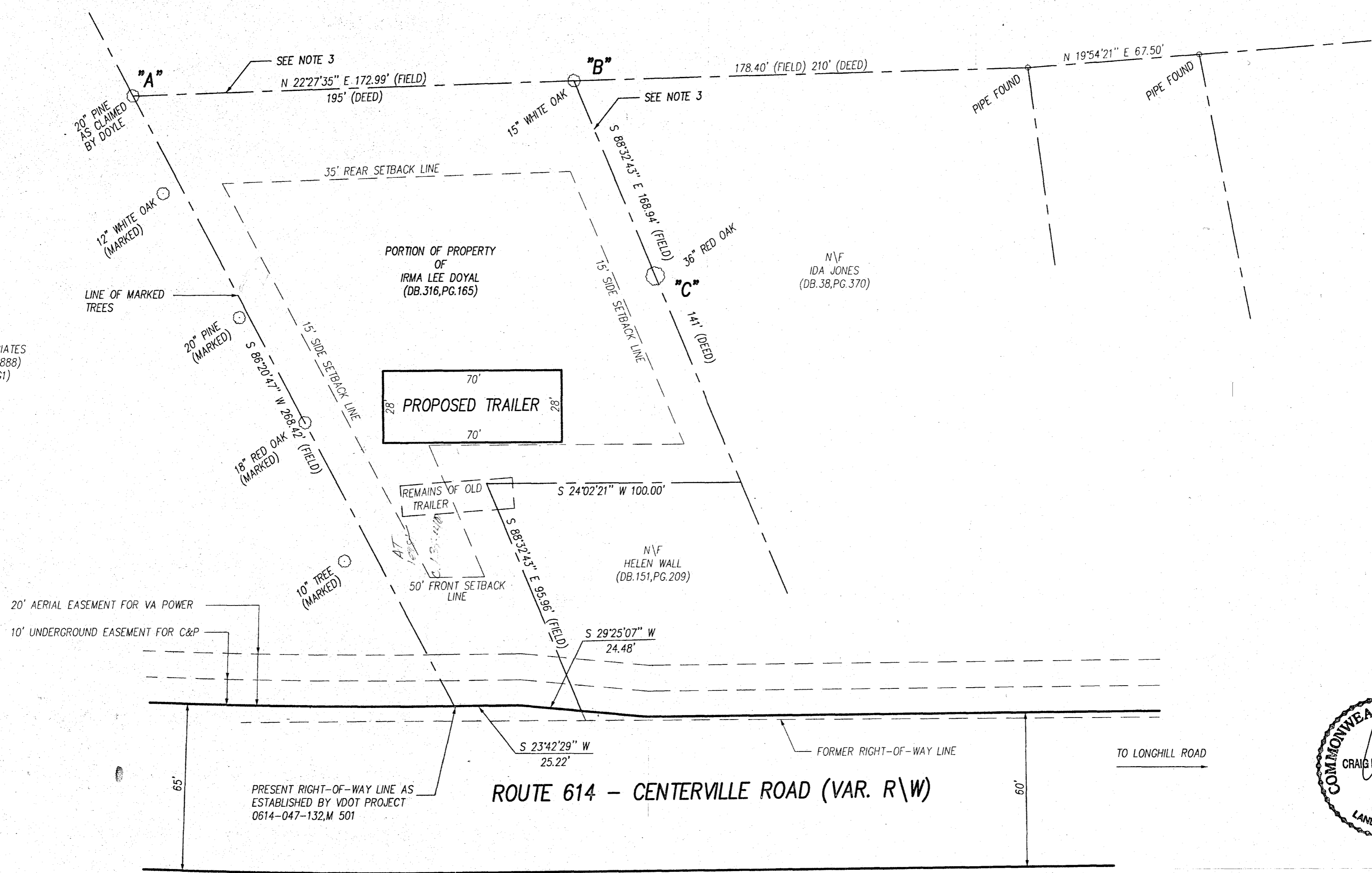


EXHIBIT SHOWING

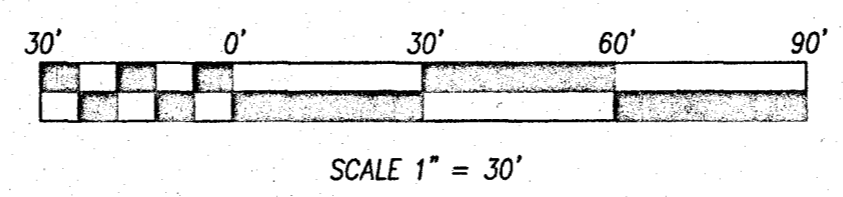
