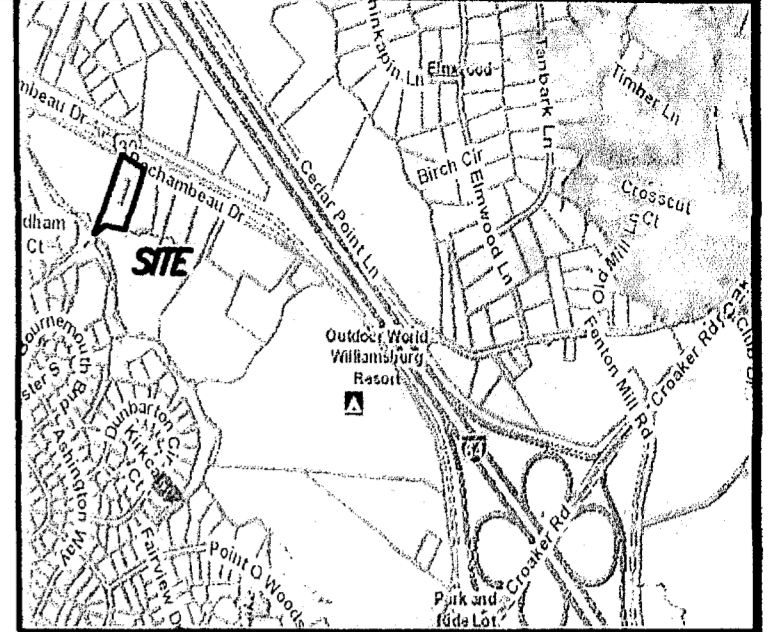

(NOW DECEASED) FROM SOUTHY BRAXTON AND BERTHA BRAXTON, HIS WIFE, BY DEED DATED NOVEMBER 6, 1952, BASED ON A 1938 LEGAL DESCRIPTION, AND RECORDED AT DEED BOOK 49, PAGE 94 IN THE LAND RECORDS OF THE CIRCUIT COURT OF JAMES CITY COUNTY.

LESS AND EXCEPT A PARCEL OF LAND DEEDED BY ELMORE (AKA ELMORE) BRAXTON AND EMMA BRAXTON, HUSBAND AND WIFE, TO WARDELL A. HAILEY AND JACQUELYN HAILEY, HUSBAND AND WIFE, BY DEED DATED SEPTEMBER 11, 1961 AND RECORDED AT DEED BOOK 82, PAGE 308 IN THE LAND RECORDS OF THE CIRCUIT COURT OF JAMES CITY COUNTY.

ACCORDING TO FAMILY TESTIMONY, ELMO BRAXTON, SR. DIED IN ABOUT 1962. THIS SURVEYOR WAS UNSUCCESSFUL IN FINDING A WILL OR ANY RECORD OF HANDING DOWN HIS PROPERTY TO HIS HEIRS.

ELMO'S SON, EDMOND CORIDGE BRAXTON, SR. REMAINED ON THE PROPERTY AND IS STILL LIVING THERE TODAY ALONG WITH ROLAND G. GRESHAM AND ANDREA A. GRESHAM.
