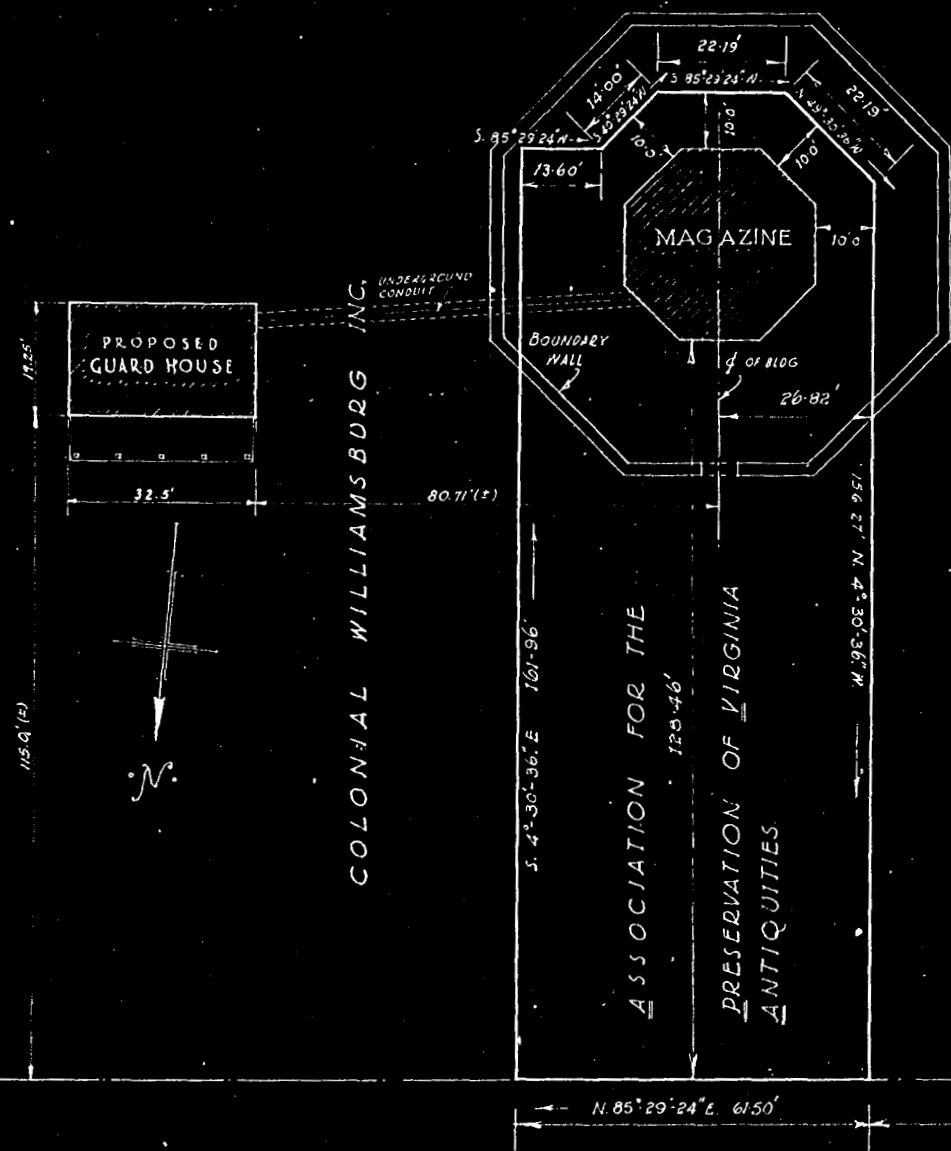

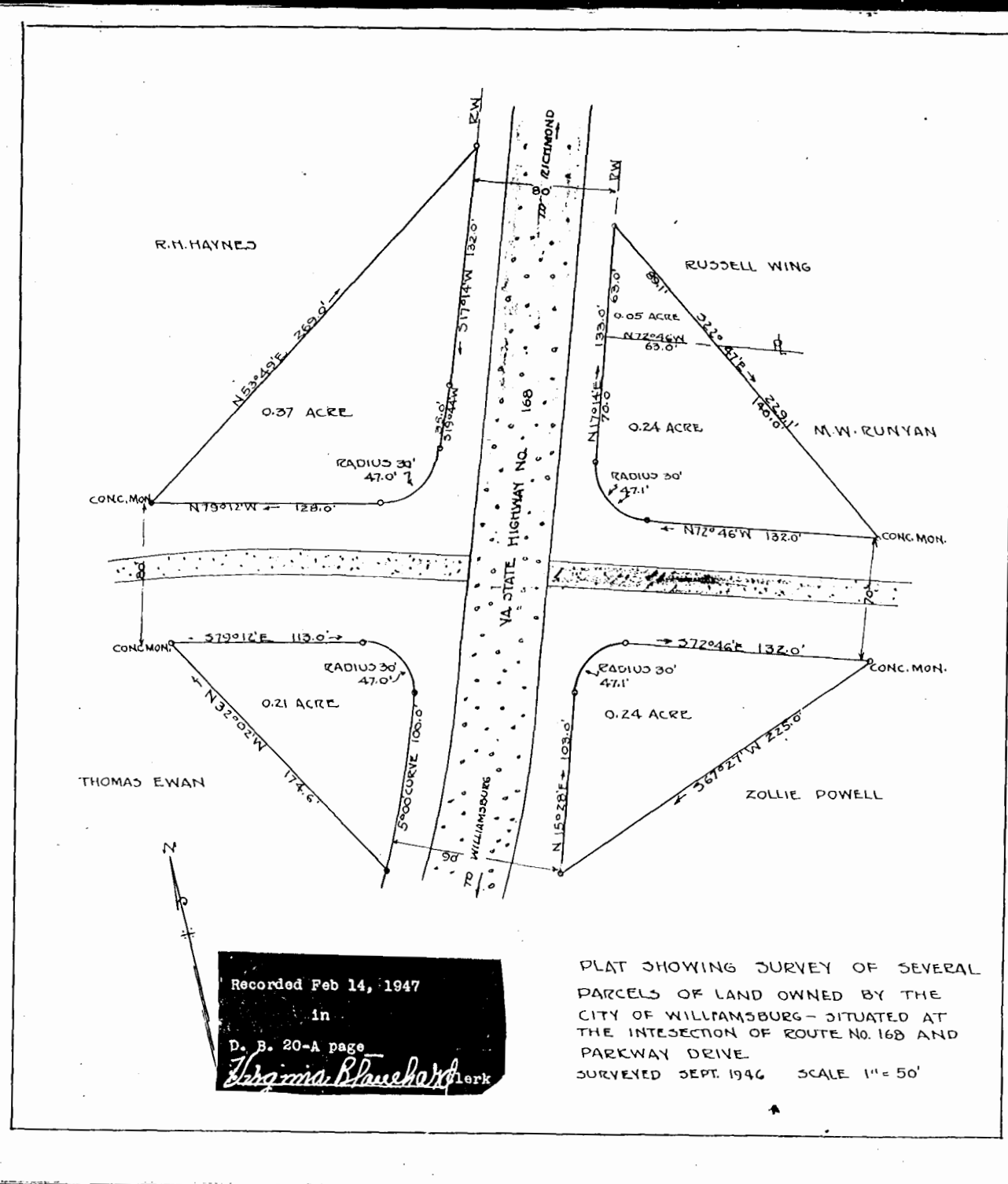

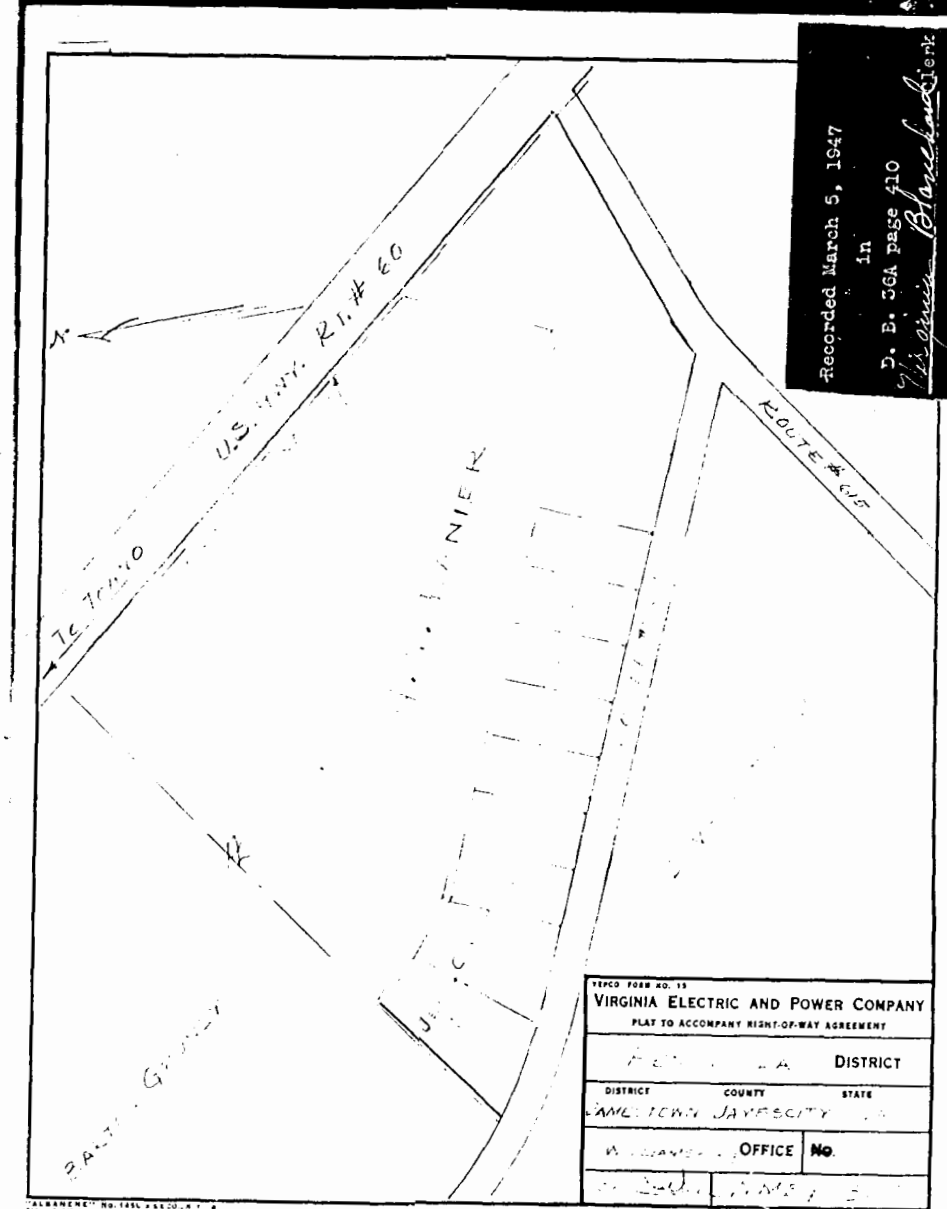
PROPOSED EAST LINE

ENGLAND STREET



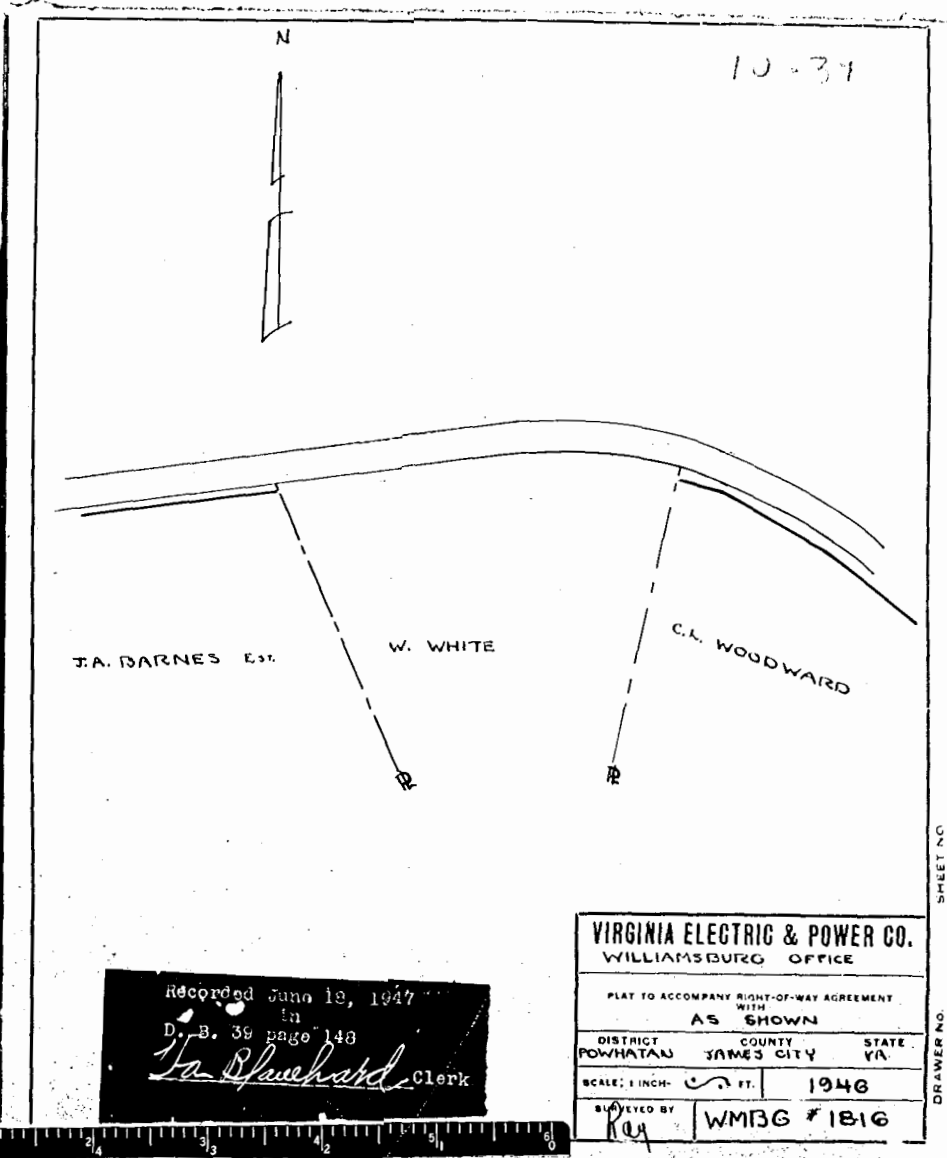
