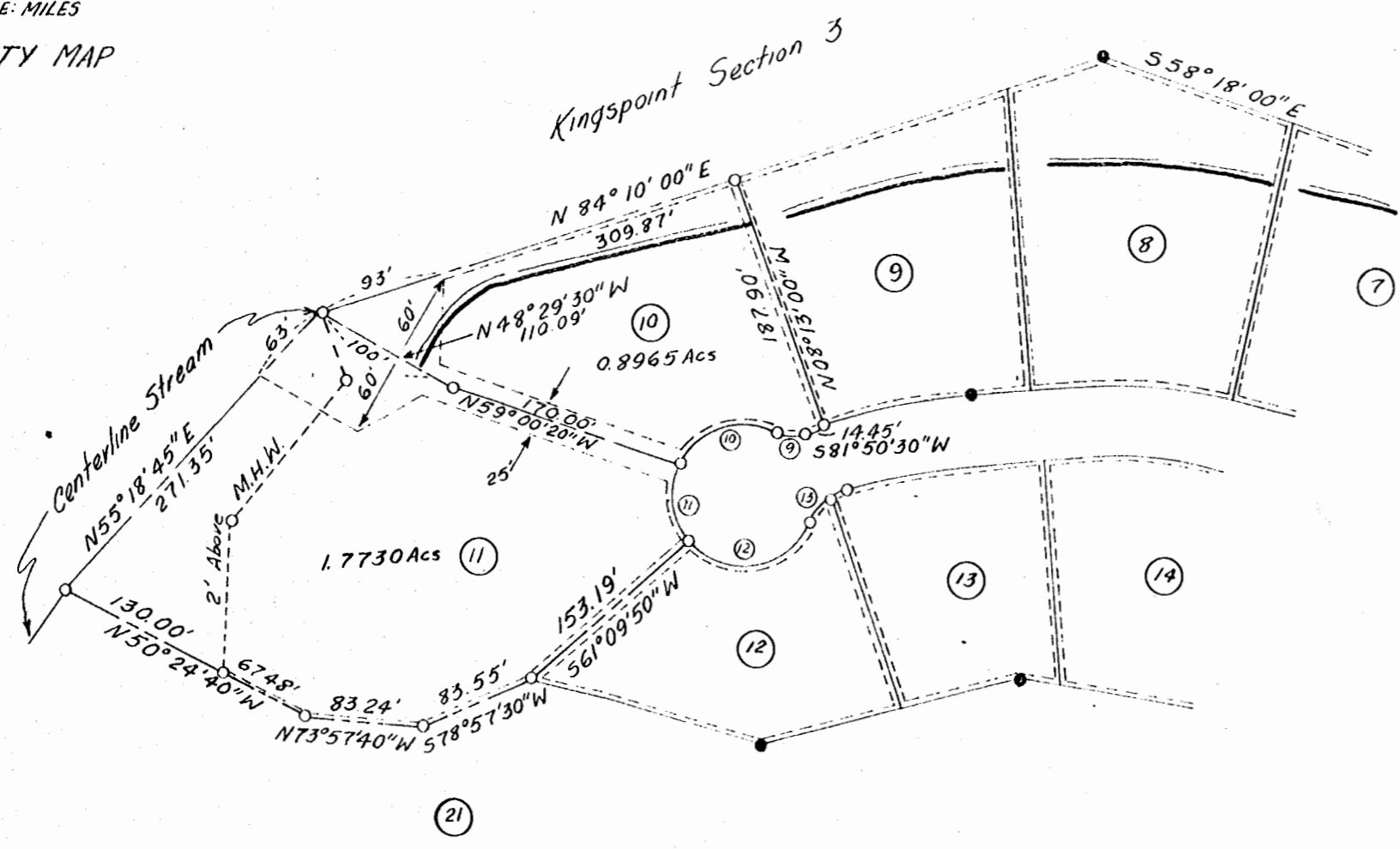
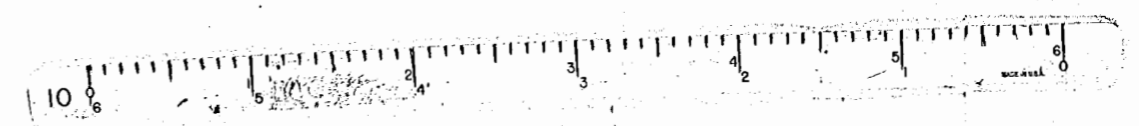


VICINITY MAP
