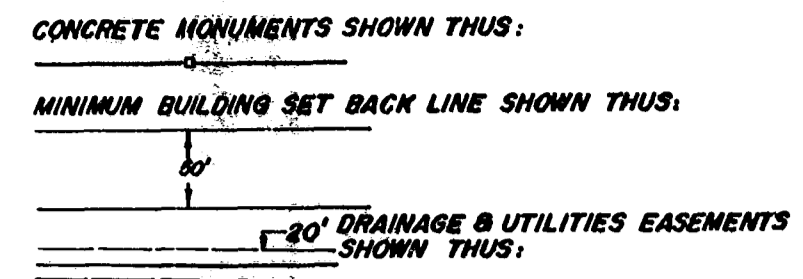


VICINITY MAP

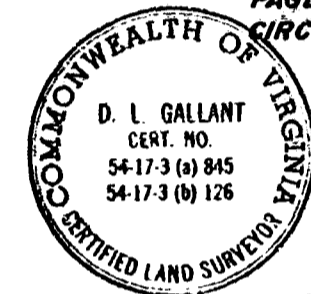

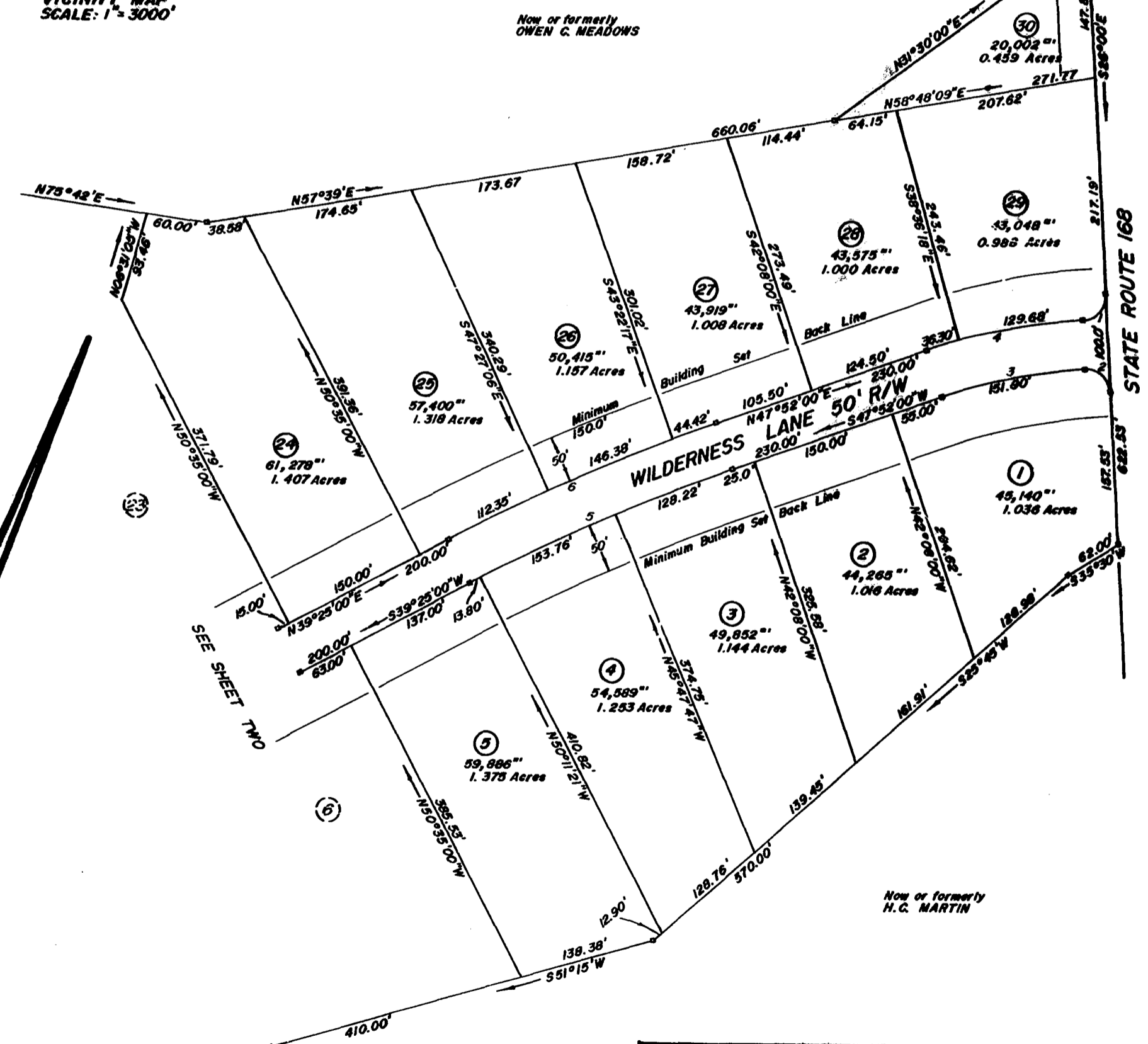
