

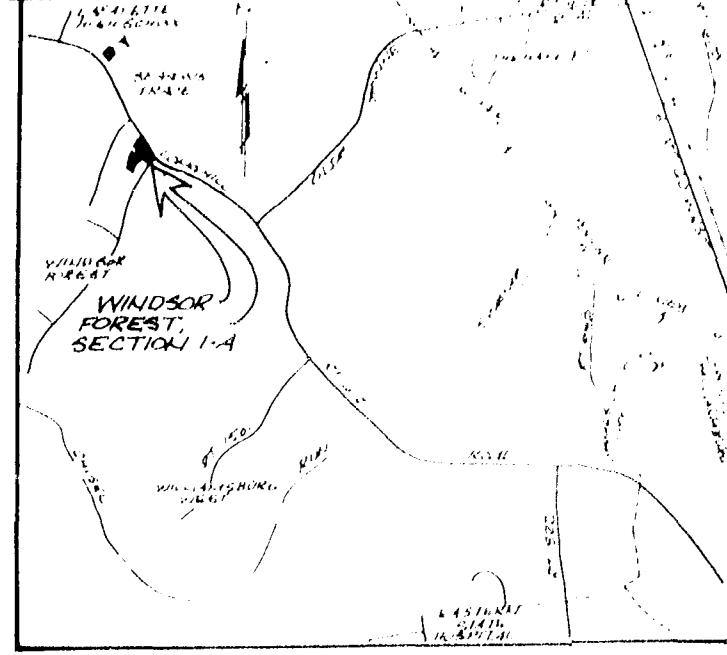
OWNER'S CONSENT & DEDICATION

Scale: 1" = 1/2 MILE

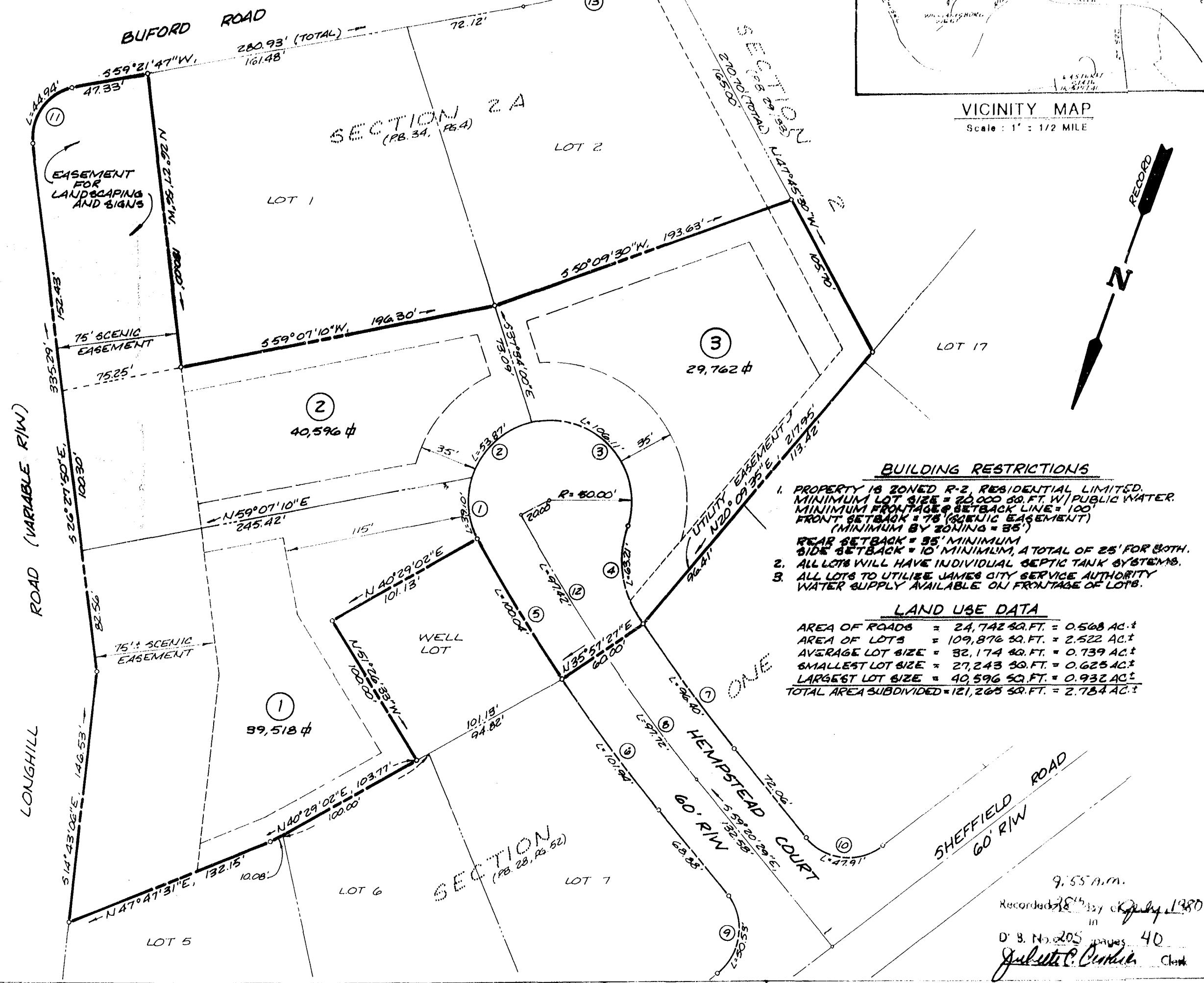

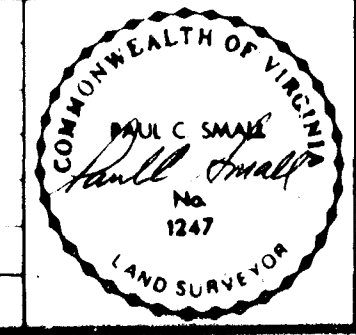
