

IN AREAS DESIGNATED LANDSCAPE PROTECTION ZONE (L.P.Z.)
NO TREES MAY BE CUT WITHOUT PRIOR APPROVAL OF THE ENVIRONMENTAL PRESERVATION BOARD (E.P.B.), OR A COMMITTEE DESIGNATED
THEREBY AND NO PERMANENT STRUCTURES MAY BE ERECTED
WHETHER ON PRIVATE PROPERTY OR COMMON AREAS, WITHOUT PRIOR
APPROVAL OF THE E.P.B. PROVIDED THAT IN THE CASE OF PRIVATE
PROPERTY AND COMMON AREAS THE FOLLOWING SHALL NOT BE
DEEMED TO BE STRUCTURES: (A) BICYCLE EQUIGSTRIAN AND PEDESTRIAN PATHS OR TRAILS, OR HELATED FACILITIES SUCH AS RETAMING
WALLS, RAIN SHELTERS, BENCHES, SIGNS, LIGHT FIXTURES, BRIDGES
AND STAIRS, AND (B) BOAT RAMPS AND OCKS, AND PROVIDED
FURTHER THAT IN THE CASE OF PRIVATE PROPERTY ONLY, THE
FOLLOWING SHALL NOT BE DEEMED TO BE STRUCTURES: (A) CONTILE VERED PORTIONS OF BUILDINGS, (B) COLUMINS, OR POST SUPPORTS
OF DECKS, AND (C) TERRACES AND PATIOS, IT SHOULD BE NOTED
THAT THE CONDITIONS, OVENANTS AND RESTRICTIONS CONTAIN
ADDITIONAL RESTRICTIONS ON PROPERTY IMPROVEMENTS.
