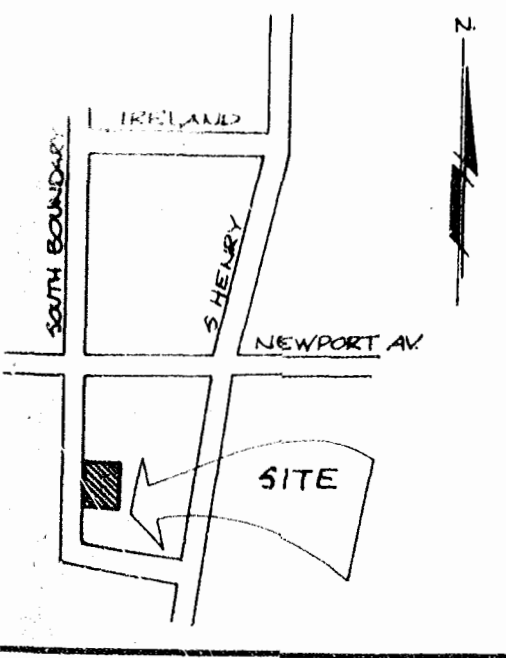

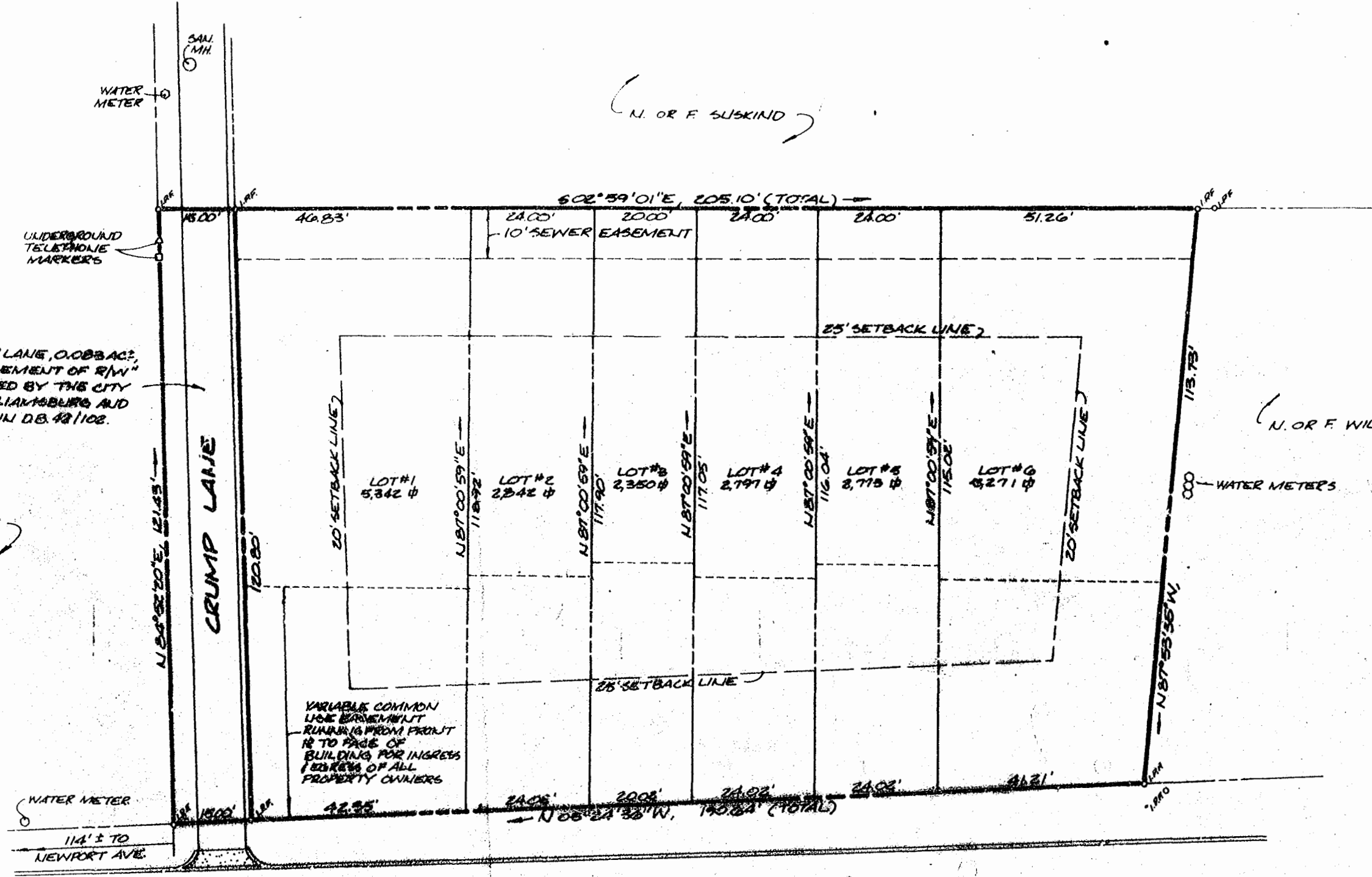
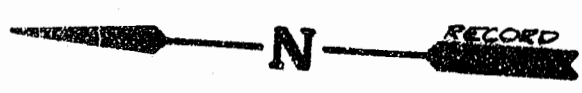

LOCATION MAP



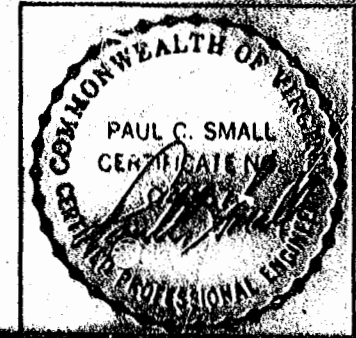

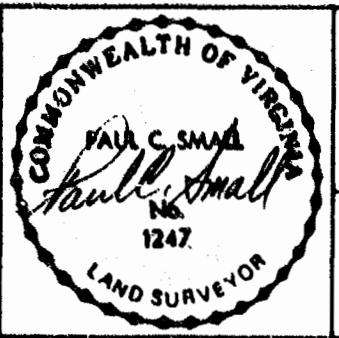
