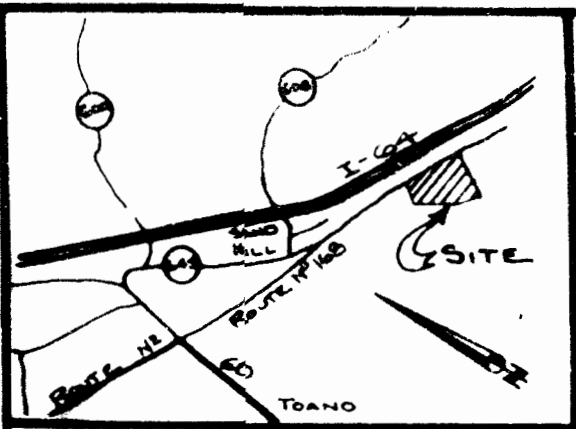




LOCATION MAP

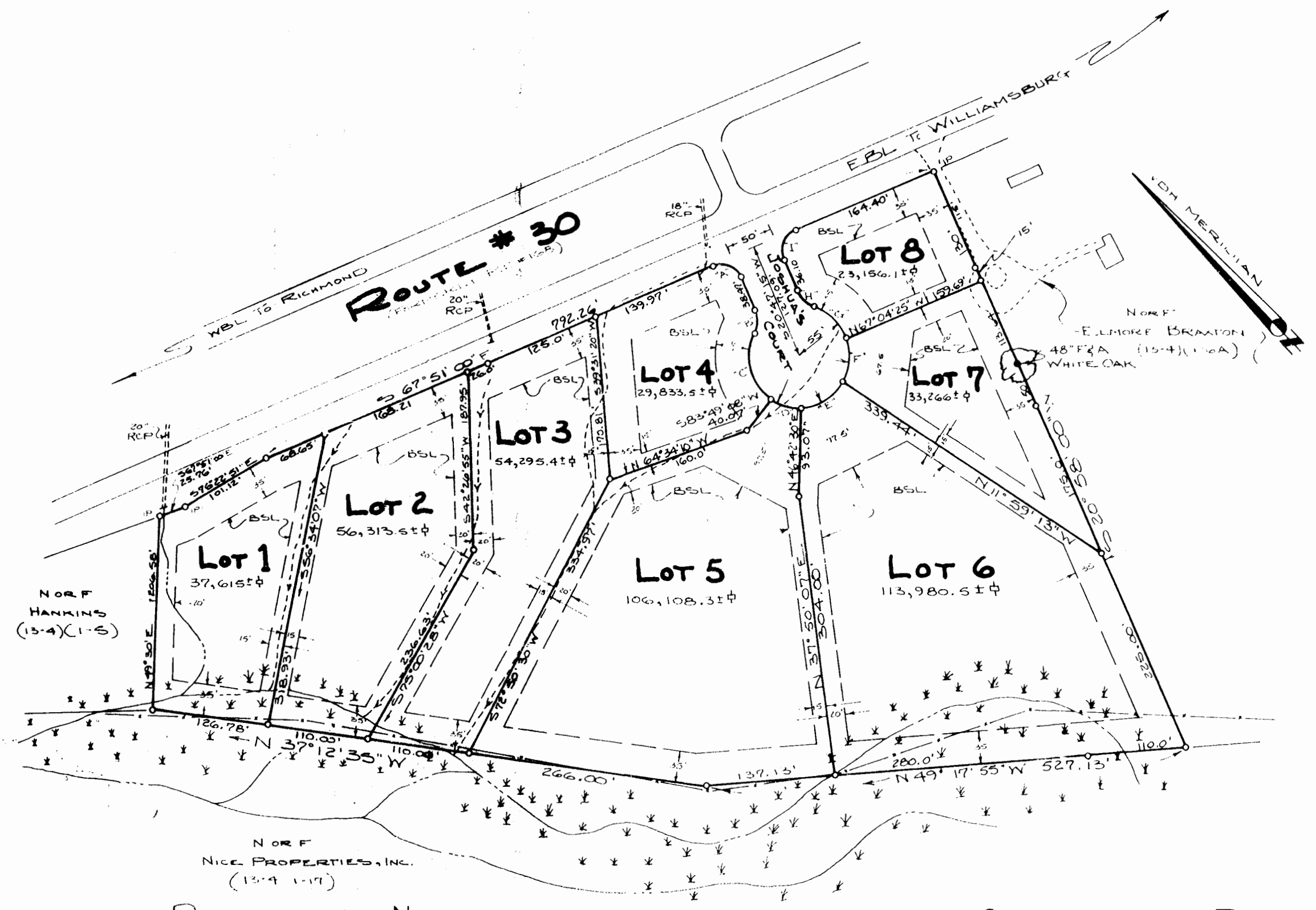
