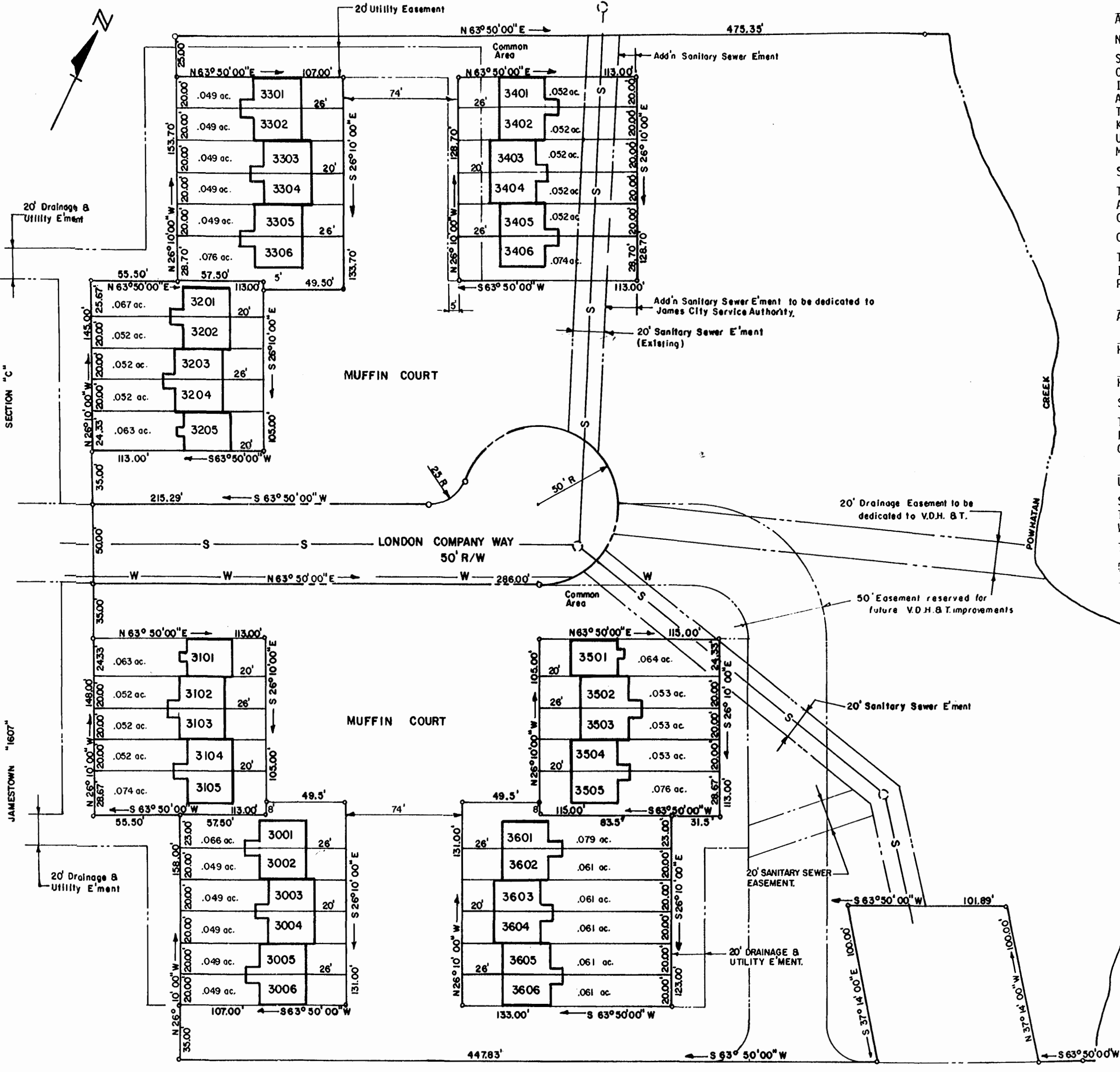

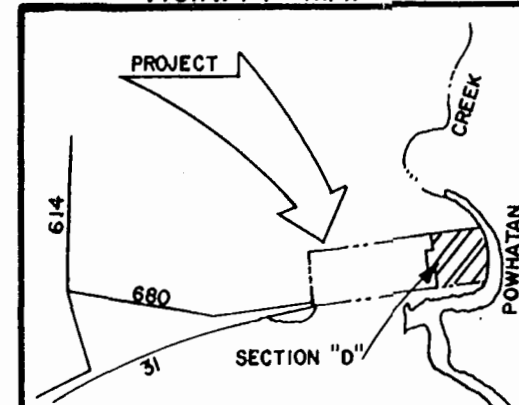

 VIRGINIA

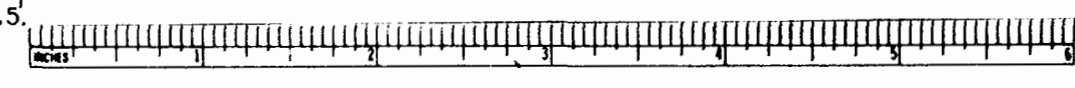
