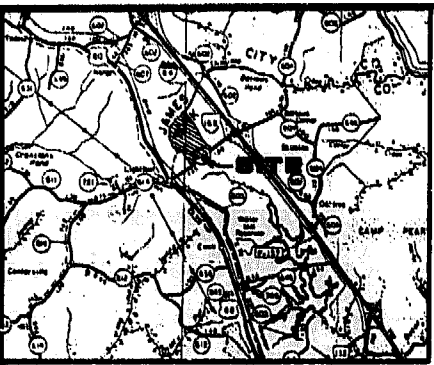


PARCEL C OF THE PROPERTY OF

SCALE: 1" = 2 MILES

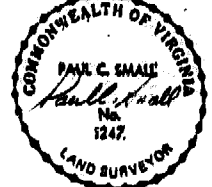

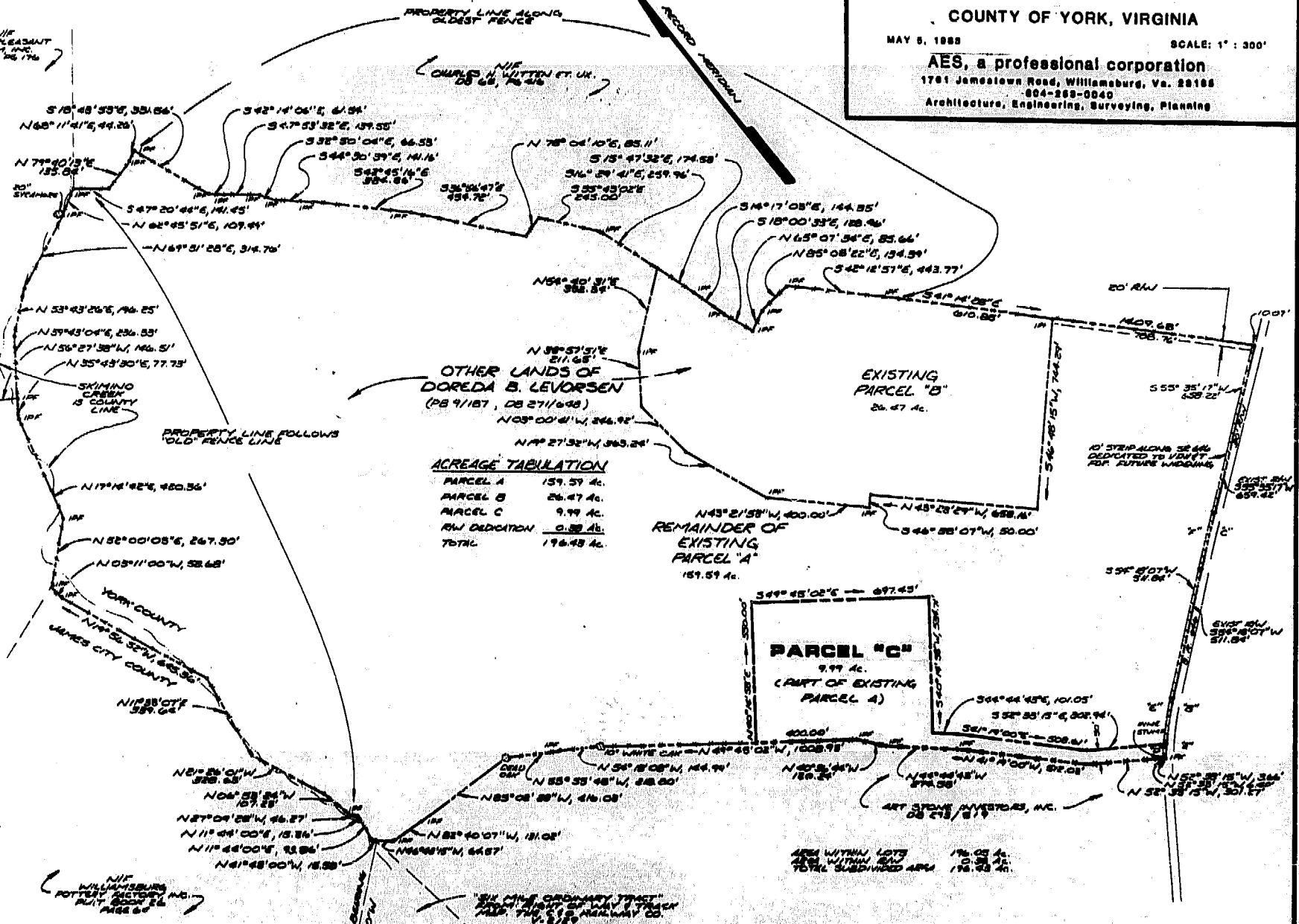
