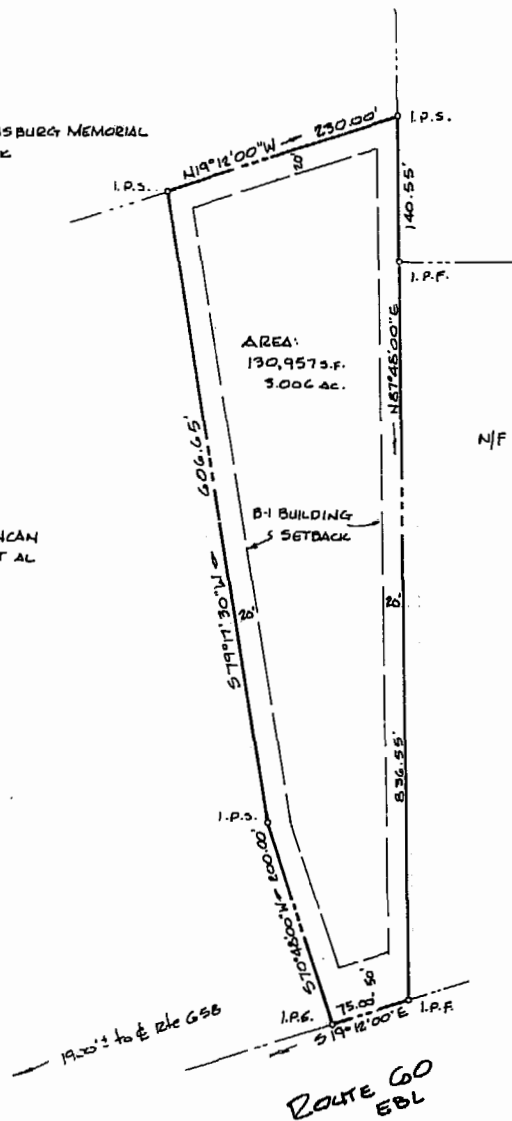


LOCATION MAP

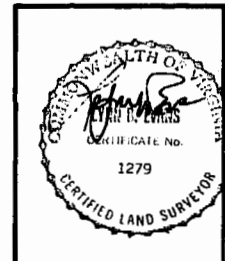
