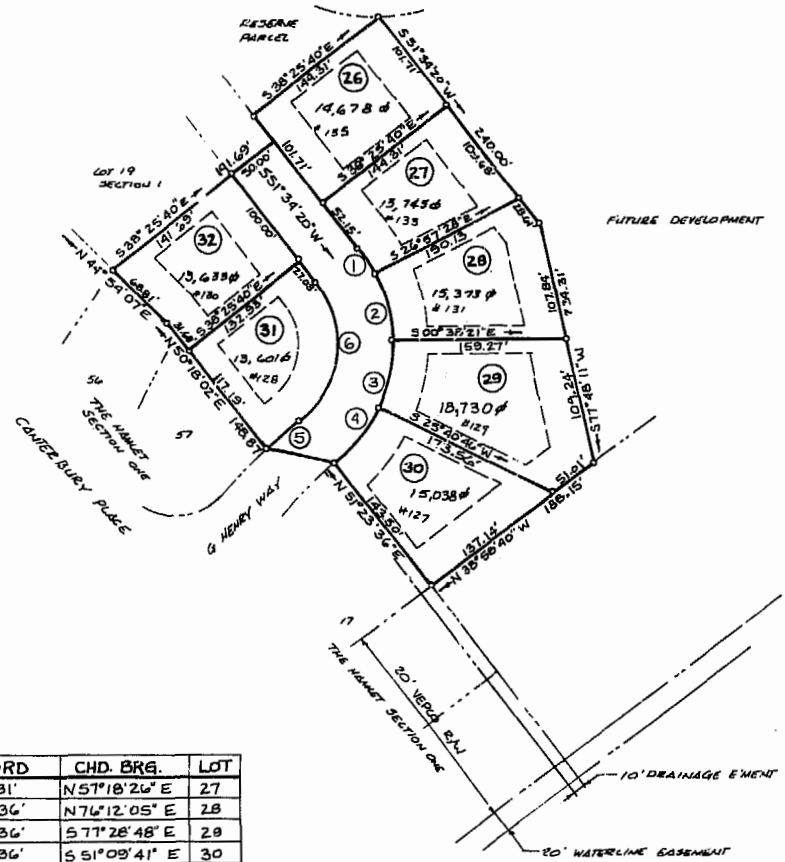
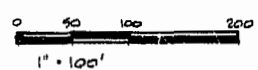


LOCATION MAP
