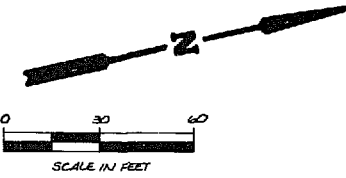




LOCATION MAP

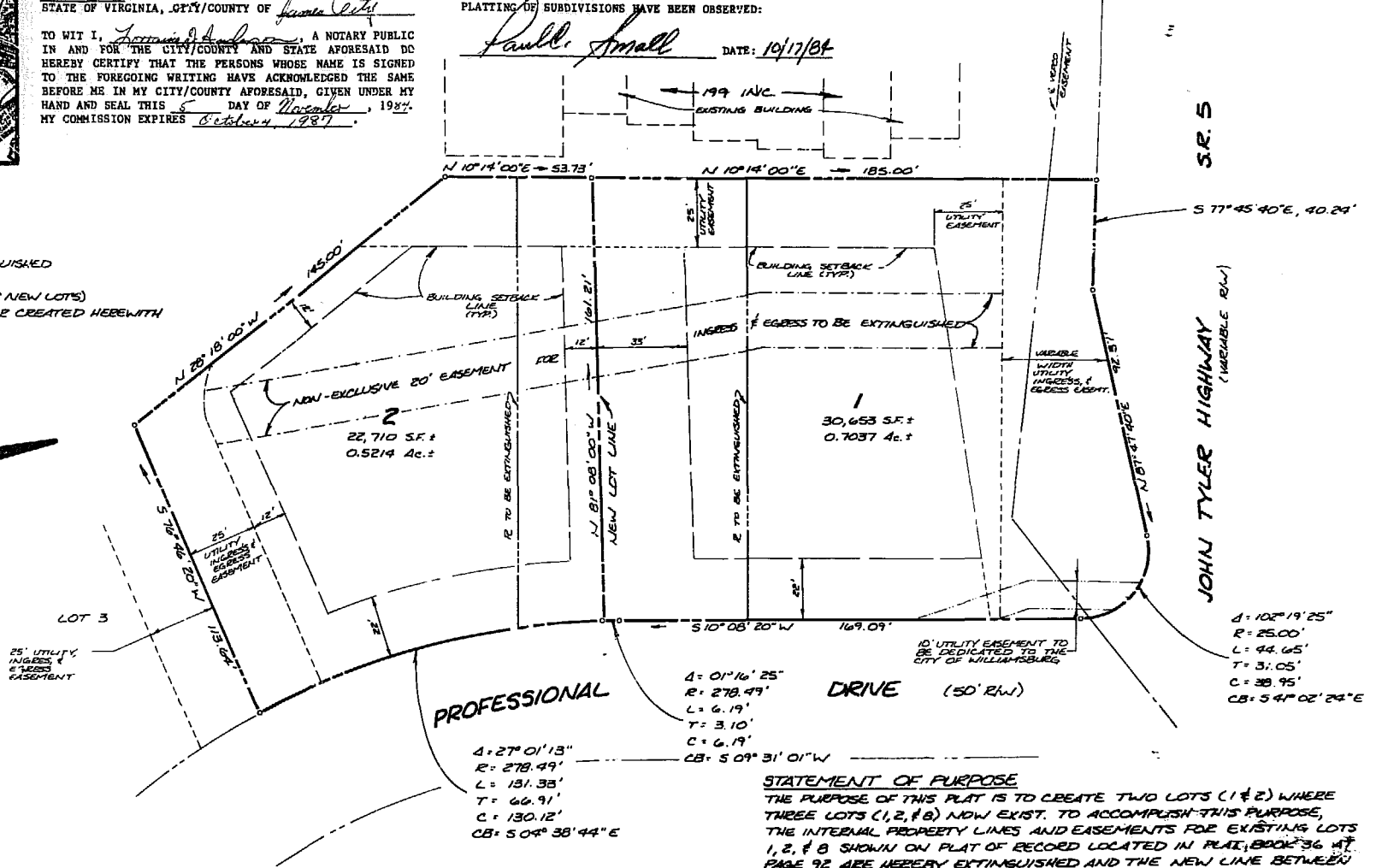
