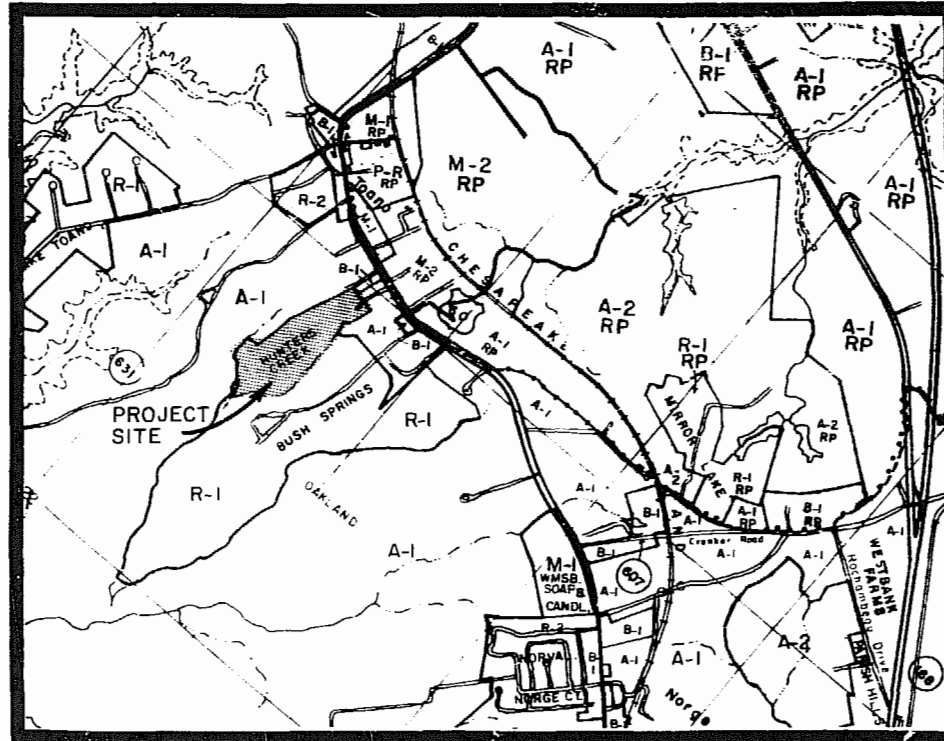


# HUNTER'S CREEK SUBDIVISION
