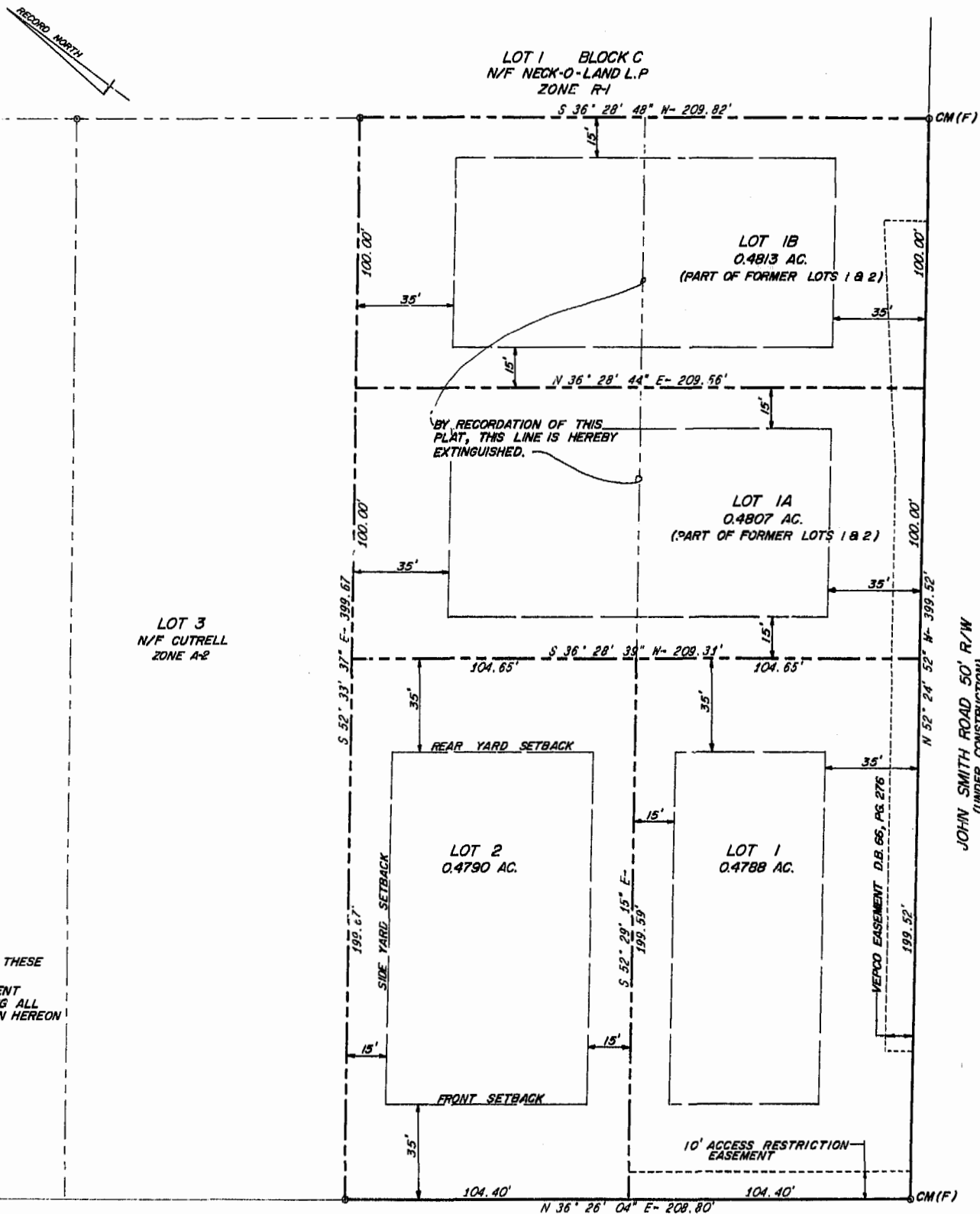


VICINITY MAP
1"=2,000'

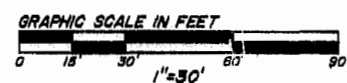
