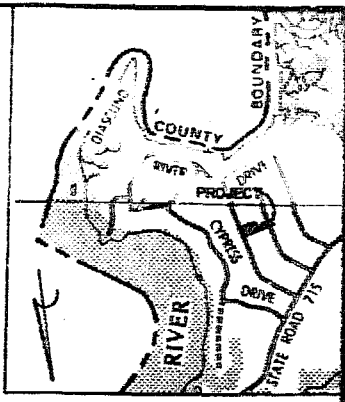


**OWNER'S CERTIFICATE**

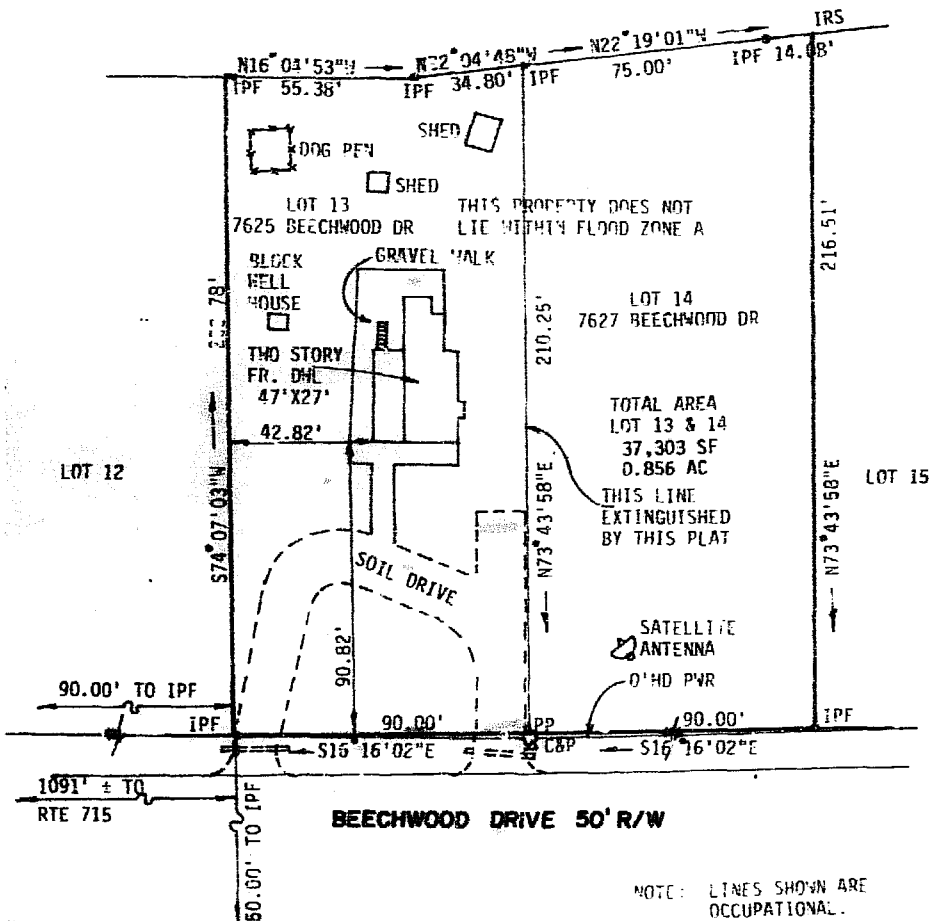
