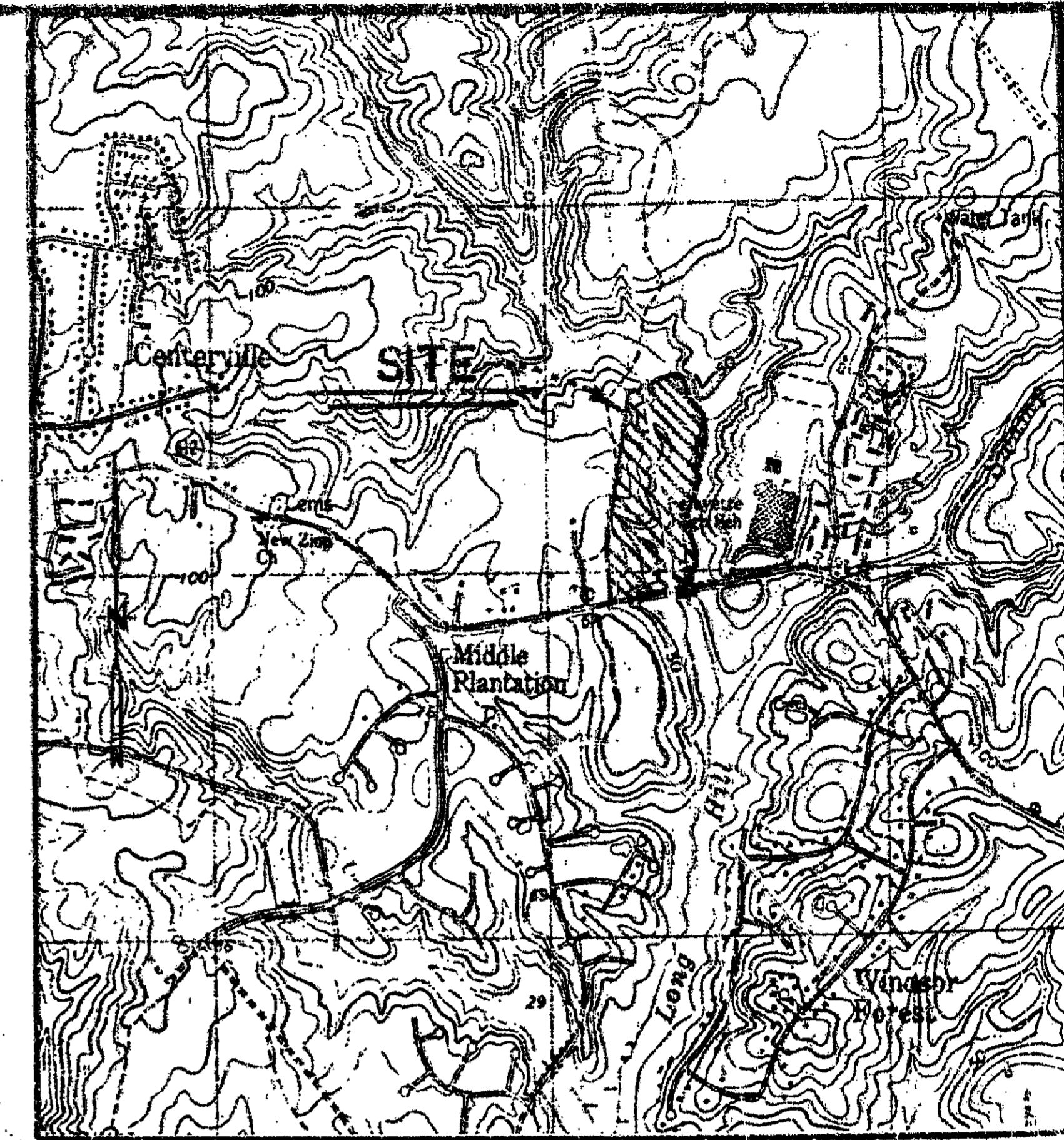

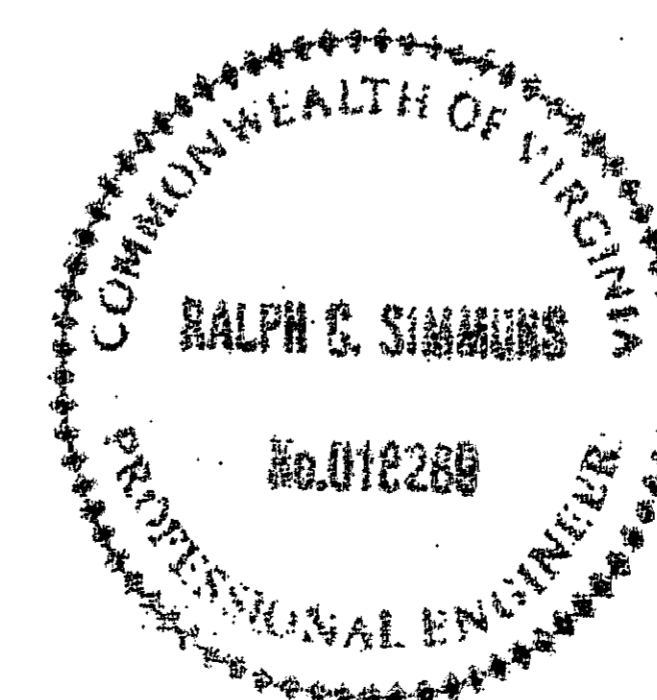
Vicinity Map

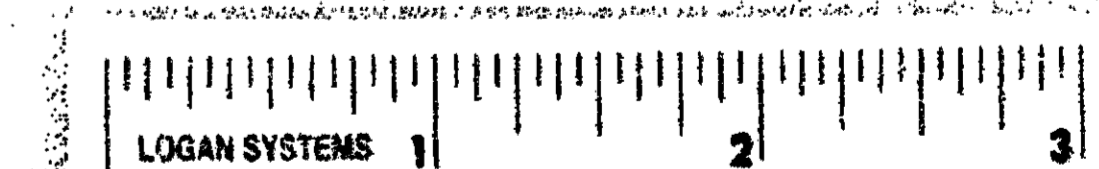
