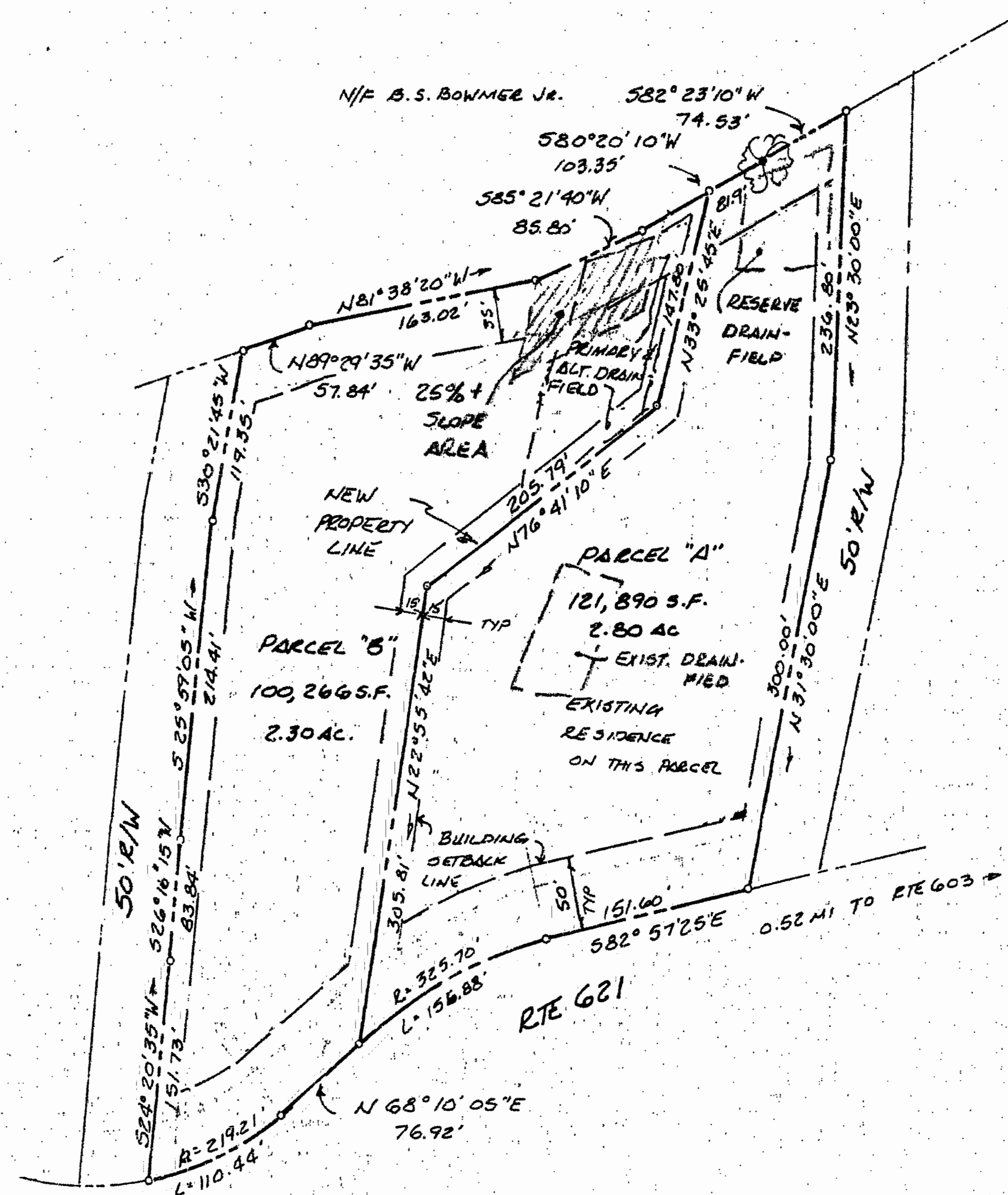

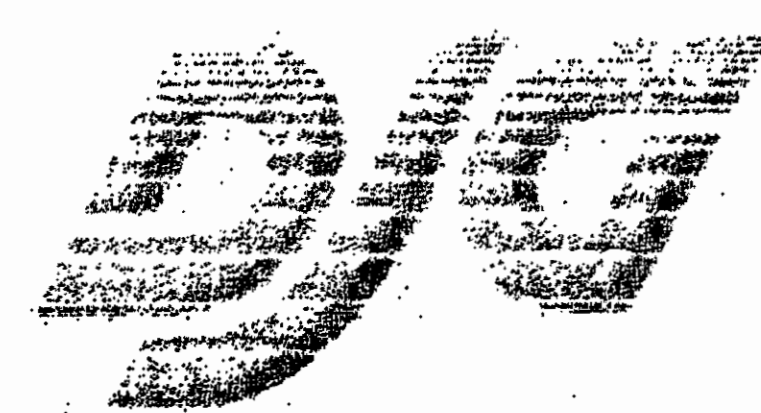

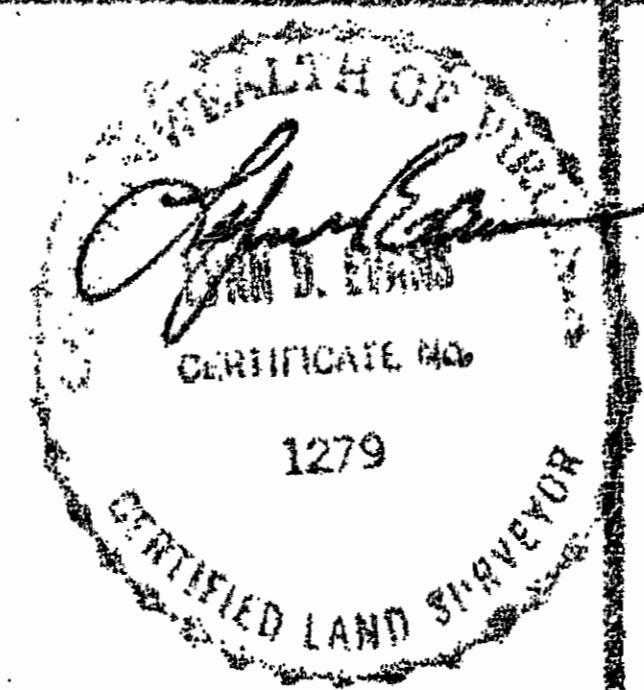
70X MAP (2-4) PARCEL (1-63)
