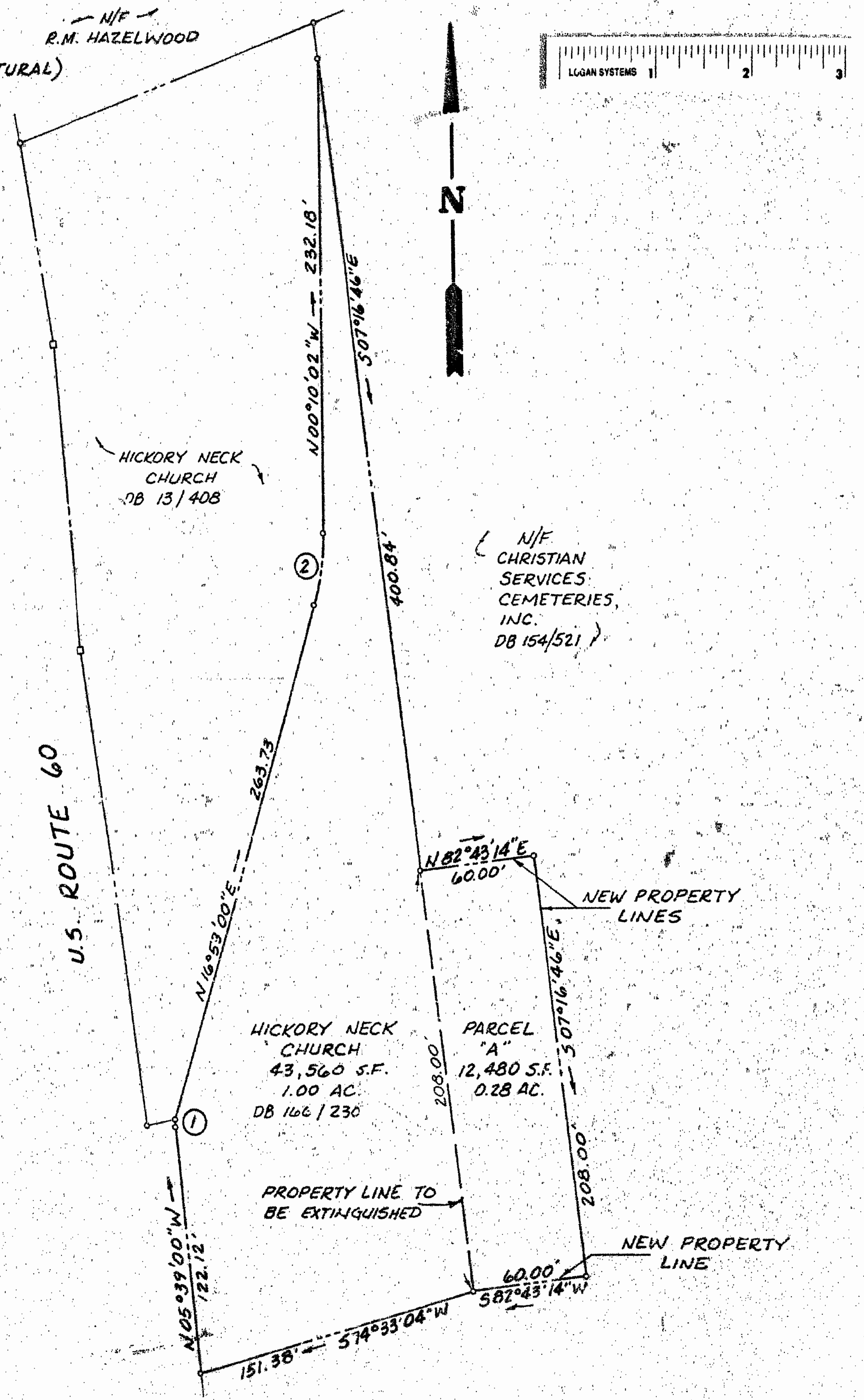


VICINITY MAP SCALE: 1" = 2000'

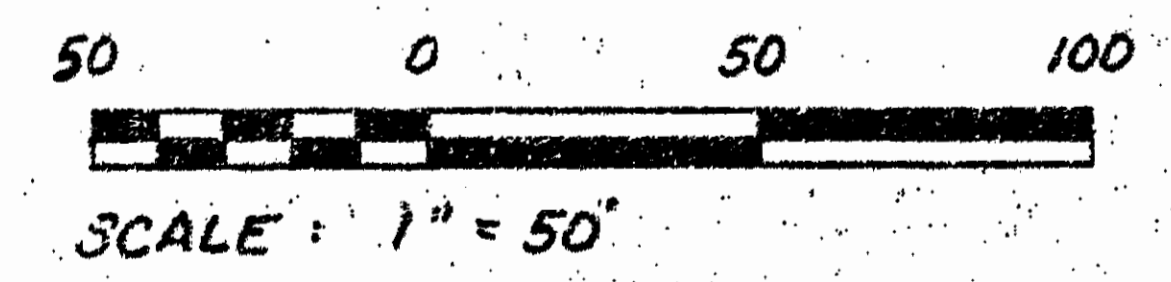
