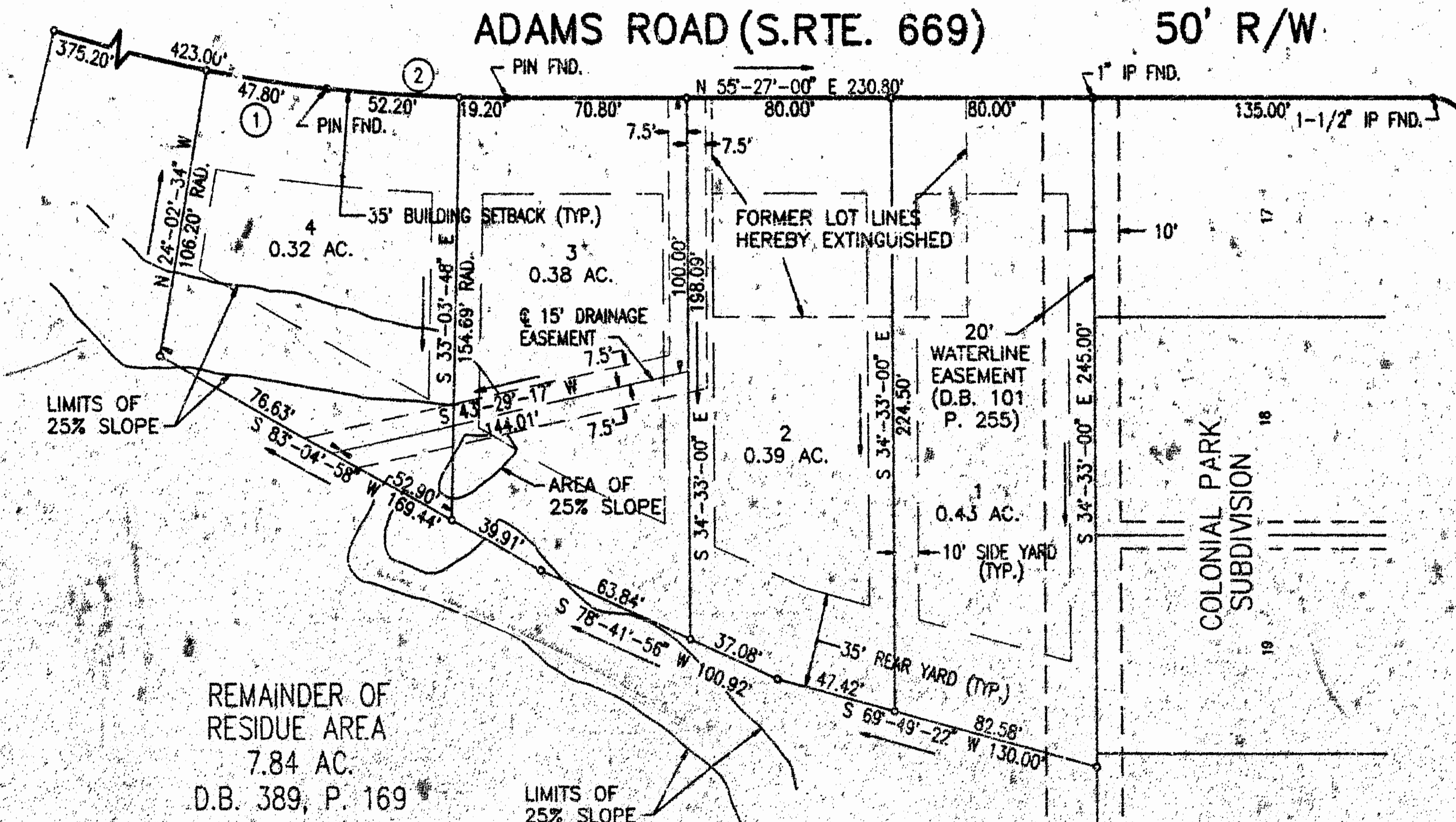


TYLER DRIVE

50' R/W



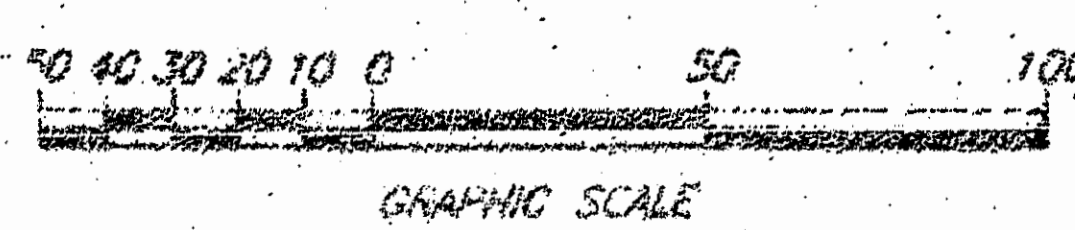
MADISON ROAD 50' R/W
