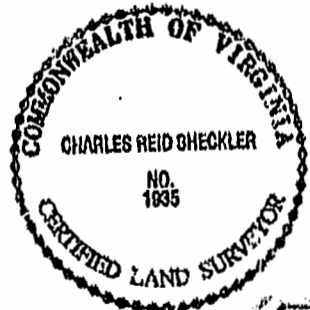

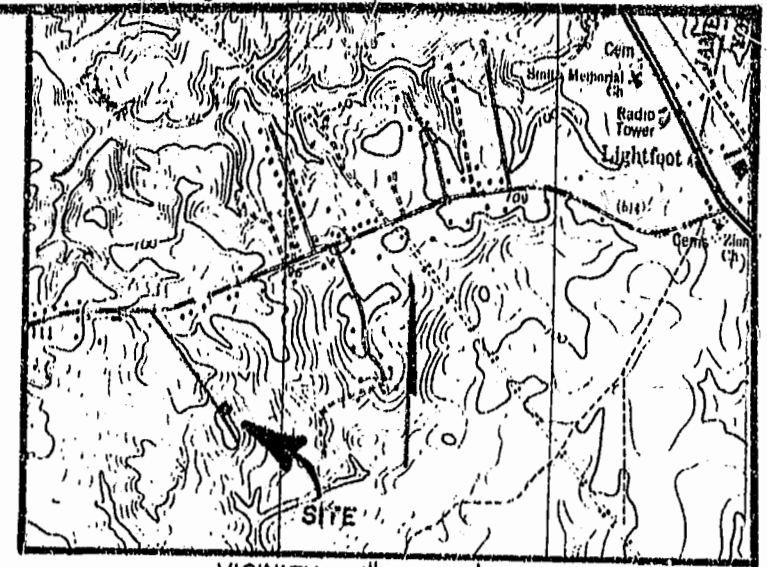

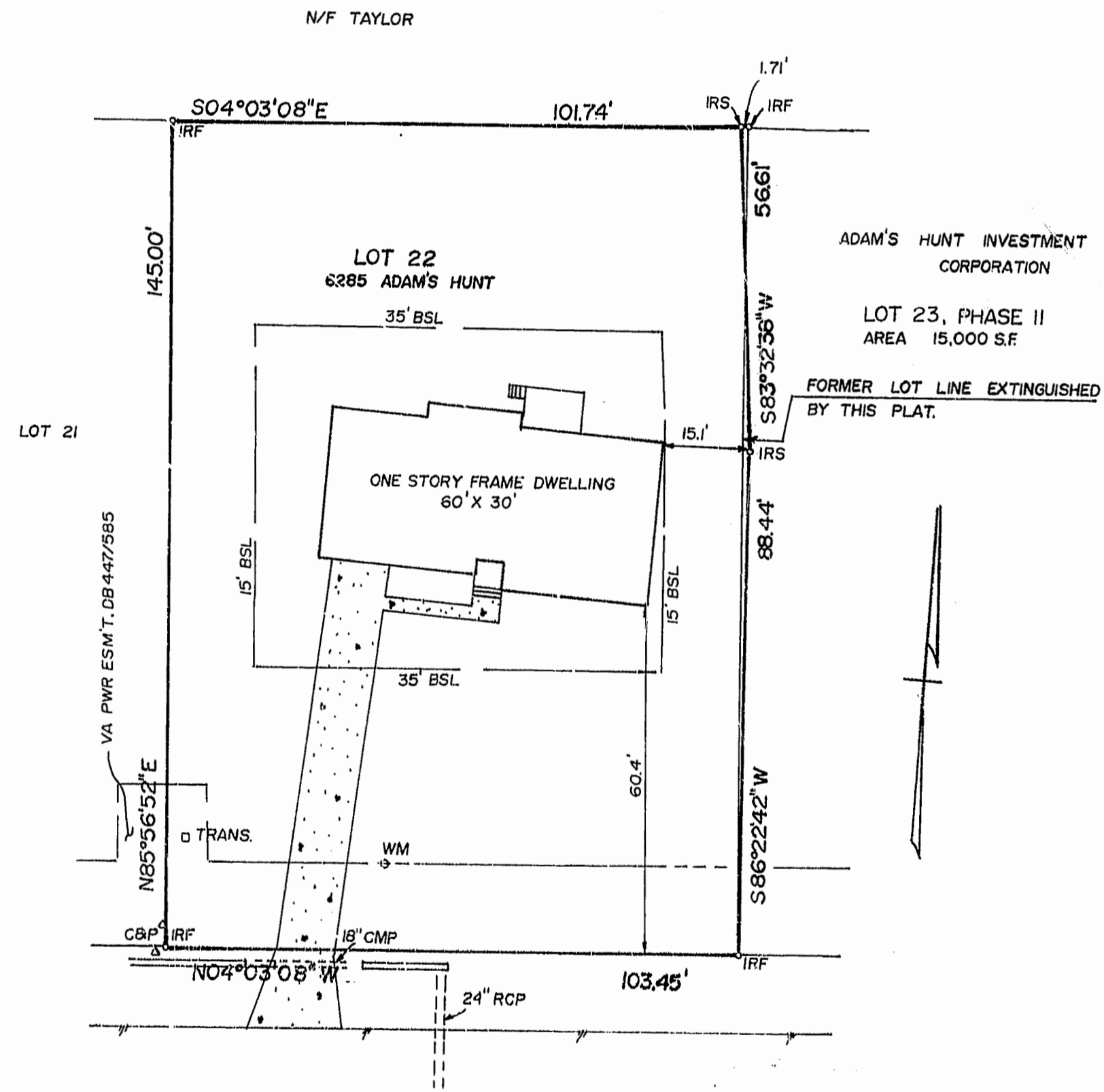

NEW AREA 15,000 S.F. 0.34 AC.

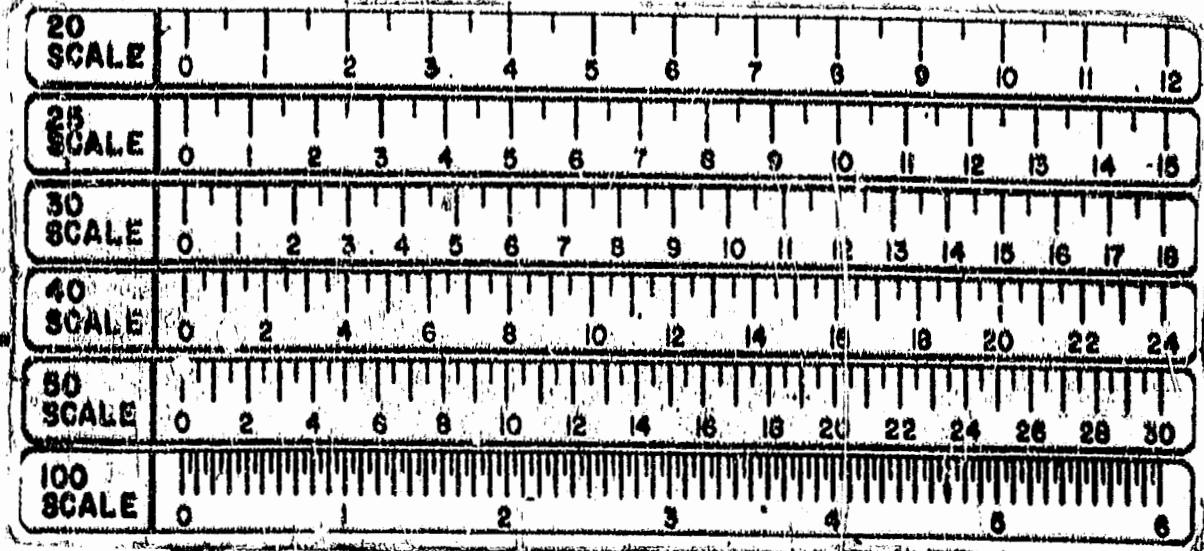
