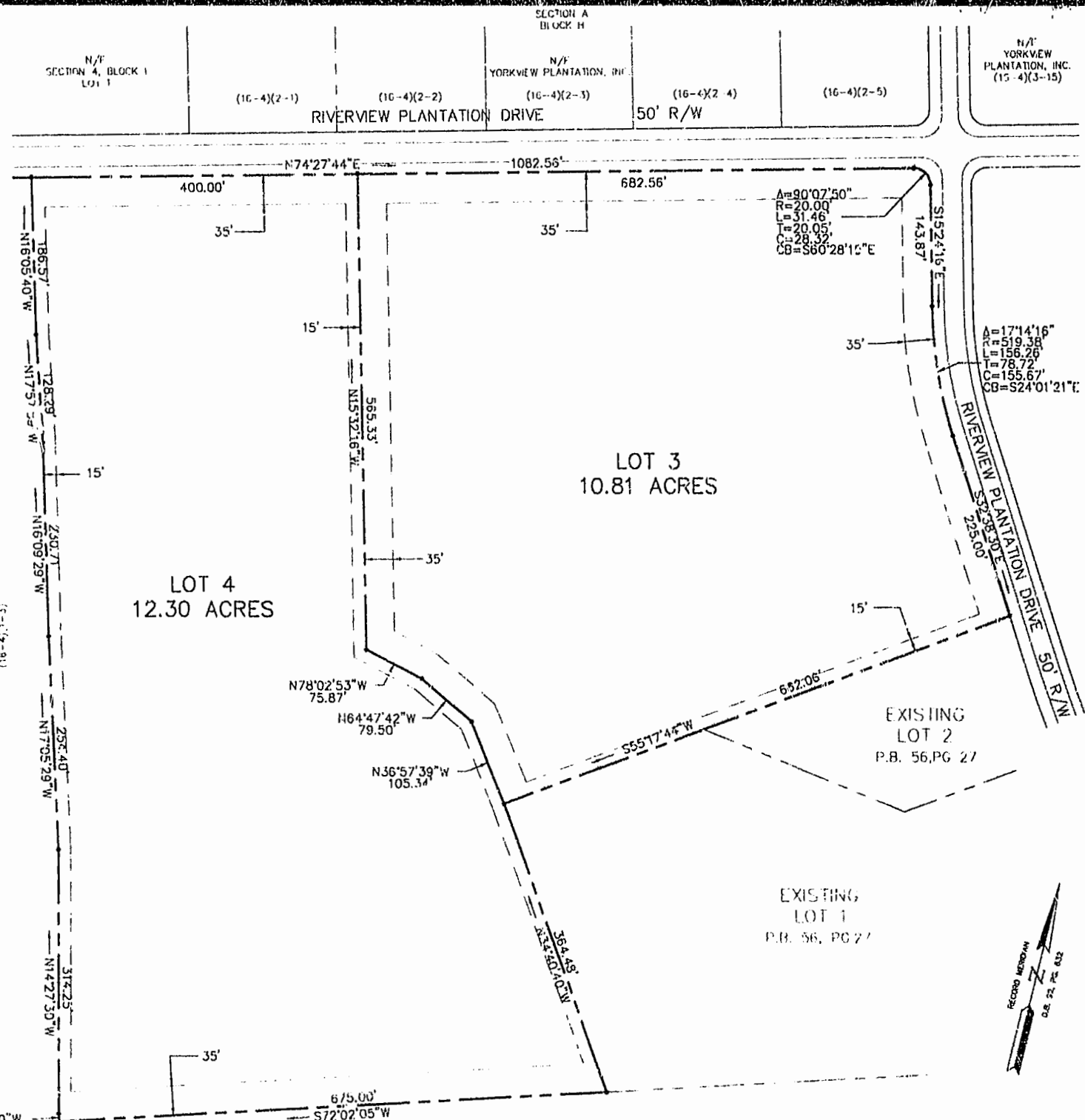


LOCATION MAP

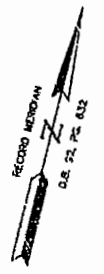

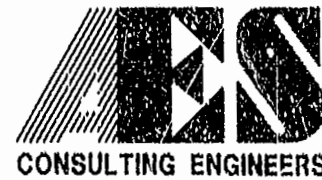
