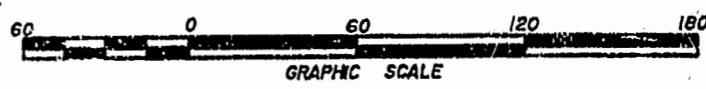


CERTIFICATE OF SOURCE OF TITLE:
