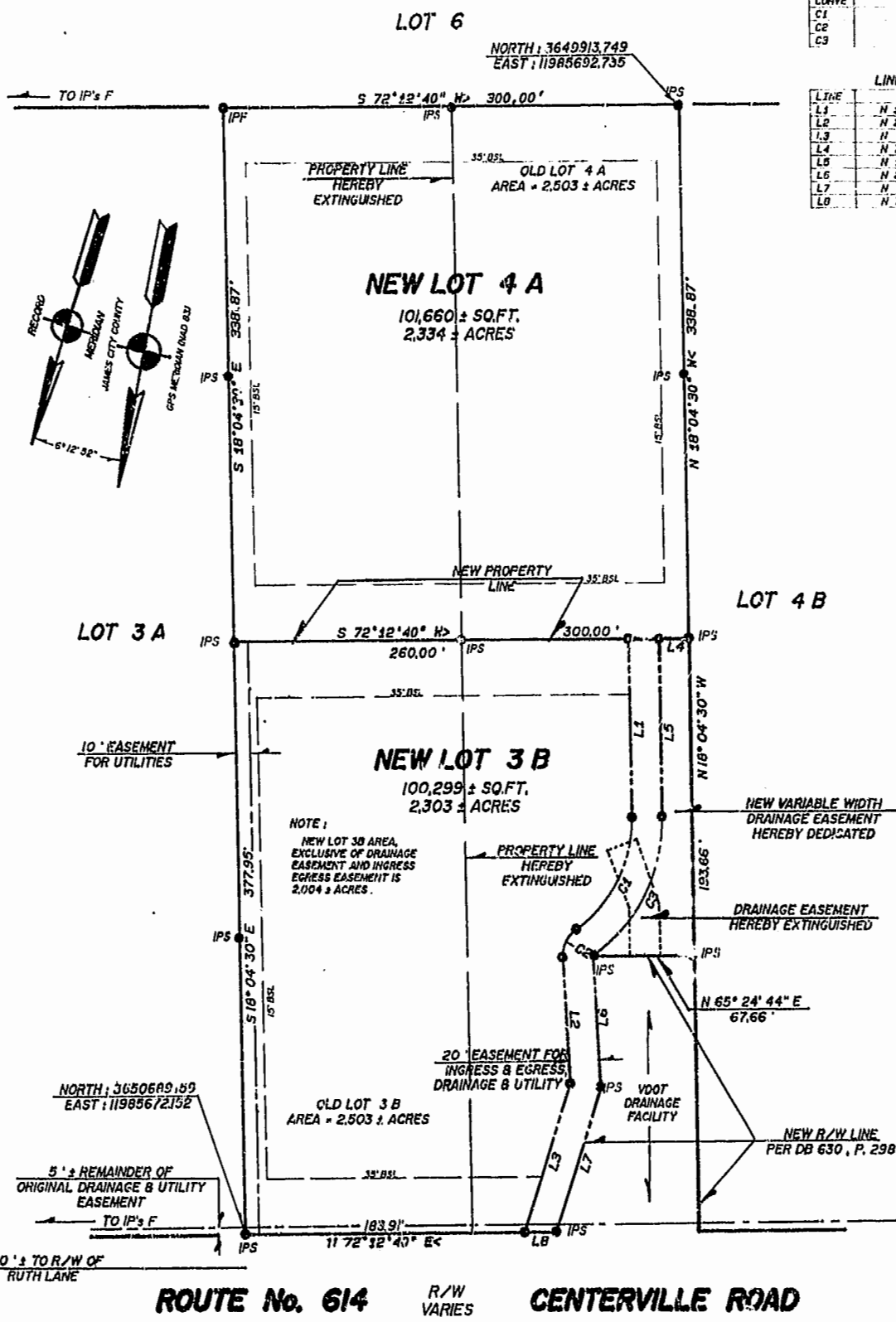

EACH LOT OR PARCEL OF PROPERTY SHALL FRONT A ROAD WHICH IS PART OF THE TRANSPORTATION DEPARTMENT ROAD SYSTEM OR SHALL FRONT UPON A PRIVATE DRIVE OR ROAD WHICH IS IN A RIGHT-OF-WAY TWENTY FEET IN WIDTH. SUCH RIGHT-OF-WAY SHALL REMAIN PRIVATE AND SHALL INCLUDE A DRIVEWAY WITHIN IT CONSISTING OF, AT A MINIMUM, AN ALL WEATHER SURFACE OF ROCK, STONE OR GRAVEL, WITH A MINIMUM DEPTH OF THREE INCHES AND A MINIMUM WIDTH OF TEN FEET. THE RIGHT-OF-WAY SHALL BE MAINTAINED BY THE ADJACENT PROPERTY OWNERS IN A CONDITION PASSABLE AT ALL TIMES. THE PROVISION OF AN ALL WEATHER DRIVE SHALL BE GUARANTEED IN ACCORDANCE WITH SECTION 17-6B. AN EROSION AND SEDIMENT CONTROL PLAN WITH APPROPRIATE SURETY SHALL BE SUBMITTED FOR APPROVAL IF THE PROPOSED RIGHT-OF-WAY AND DRIVE CONSTRUCTION DISTURBS MORE THAN 2,800 SQUARE FEET.
