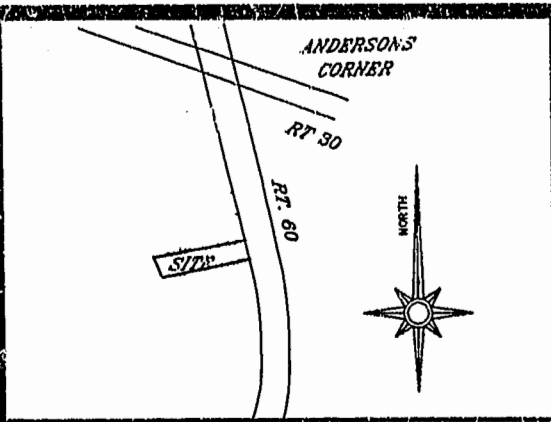
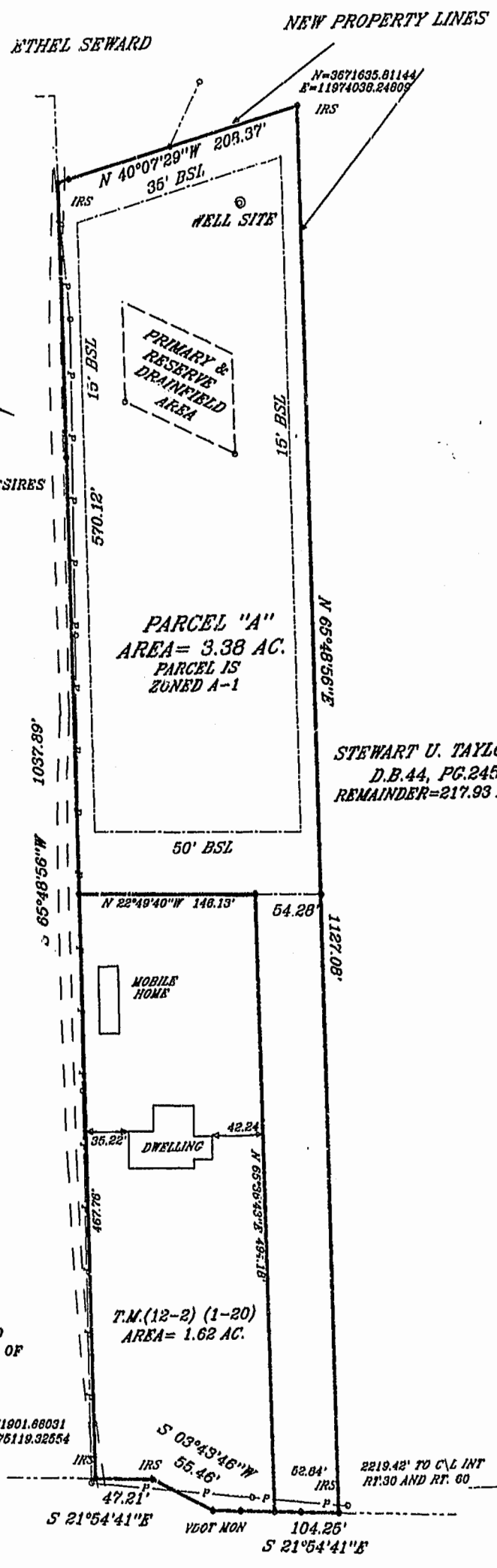
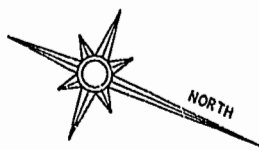




VICINITY MAP

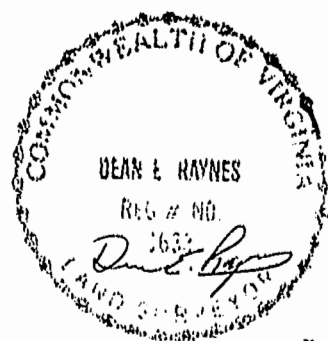
