THE DISK IS LOCATED ON THE EAST SIDE OF U.S. ROUTE 60 (POCAHONTAS TRAIL) APPROXIMATELY 120' SOUTH OF WISTERIA DRIVE (THE ENTRANCE TO COUNTRY VILLAGE MOBILE HOME PARK) IN THE NORTH END OF A MEDIAN ADJACENT TO THE 7-11 STORE PARKING LOT, 25.2' NORTH OF UTILITY POLE #CE57, 3.9' NORTHEAST OF THE WEST CURB OF THE MEDIAN, 5.7' SOUTHEAST OF THE CENTER OF THE CURB RETURN, AND 5.1' SOUTHWEST OF THE EAST CURB OF THE MEDIAN.
