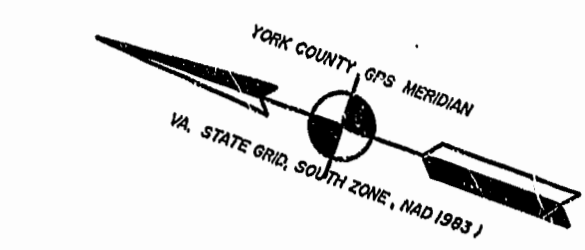


LOCATION MAP

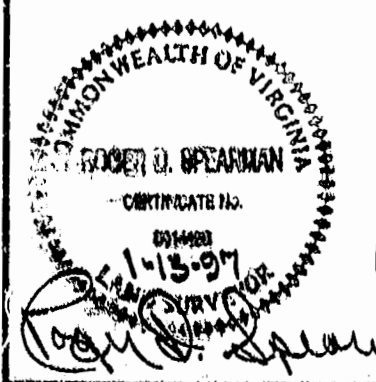

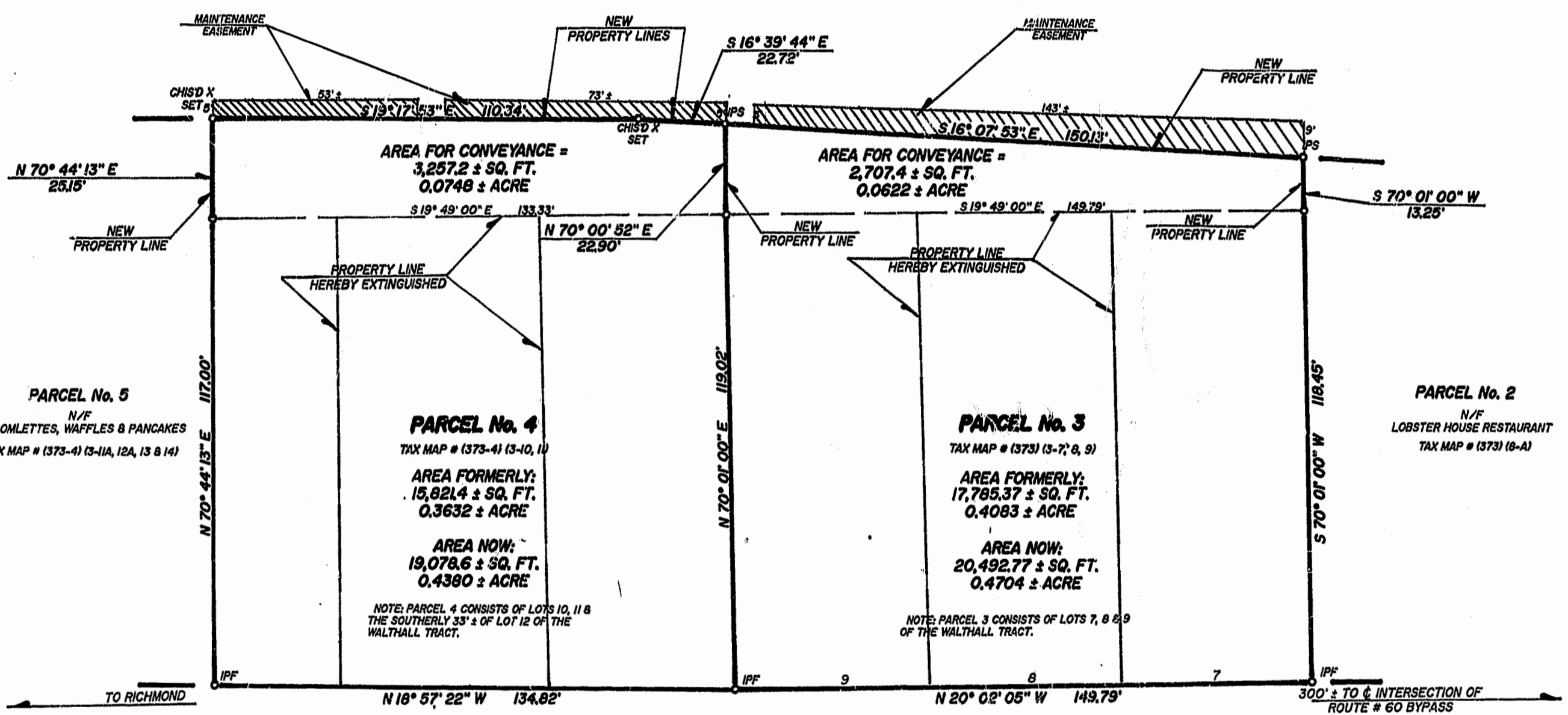
