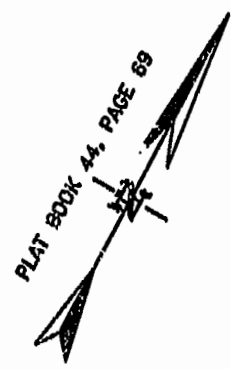
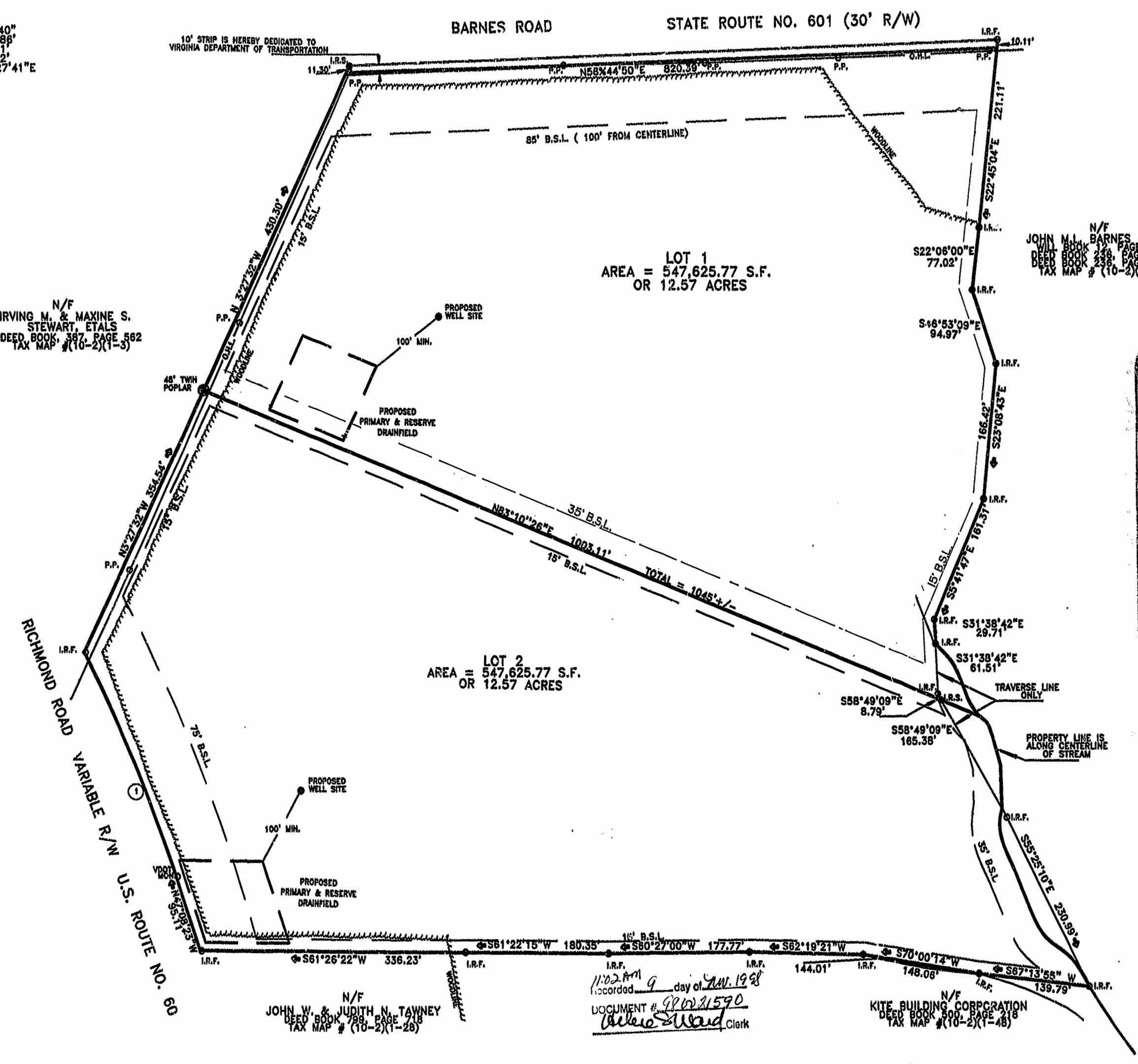




VICINITY MAP

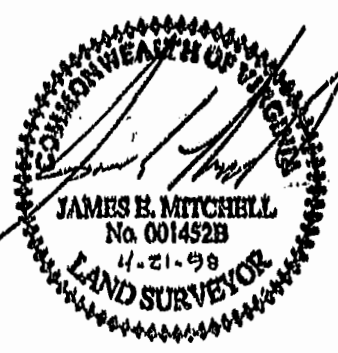
