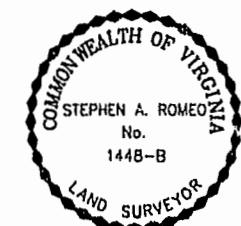


- NOTES**
1. AS EXCEPTED FROM D.B. 198, PG. 789 "... 2. Except as hereinafter provided in paragraph 6, and subject to the other provisions hereof, with respect to the road constructed by Badische Corporation on said property and continuing over other property of Badische Corporation located at the easternmost end of said property and continuing to the intersection of said road with Blow Flats Road, Nora I. Cole, her successors and assigns, shall have the non-exclusive right to use said road in common with Badische Corporation, the right to construct drive-ways adjoining or intersecting said road, and the right to construct other roads intersecting said road."
 2. ALL UTILITIES SHALL BE PLACED UNDERGROUND.
 3. THE ACCESS ROAD THAT CONNECTS THE NEWLY CREATED PARCEL TO BLOW FLATS ROAD SHALL BE PAVED.

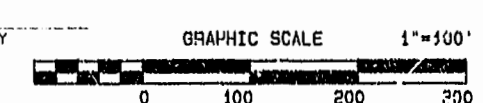
