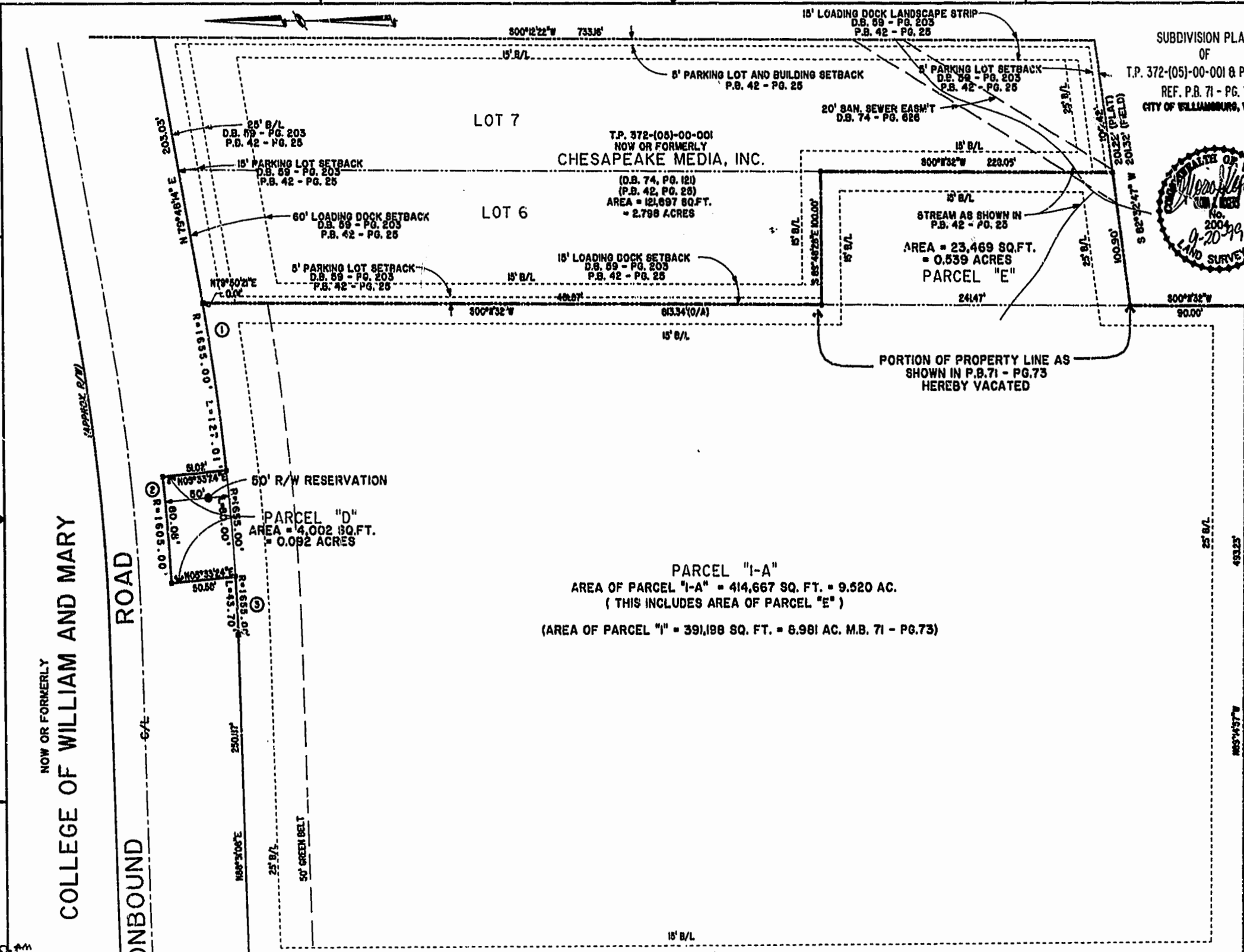


SUBDIVISION PLAT
