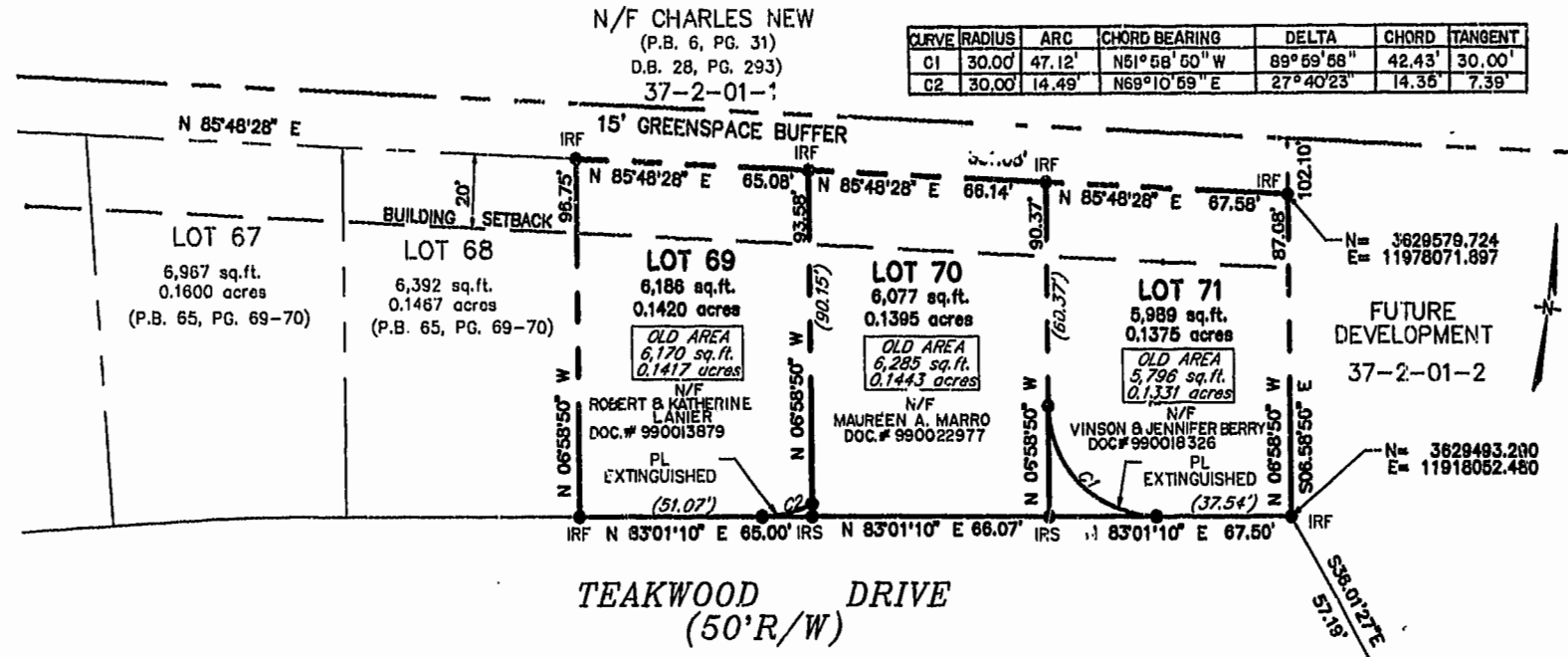


VICINITY MAP

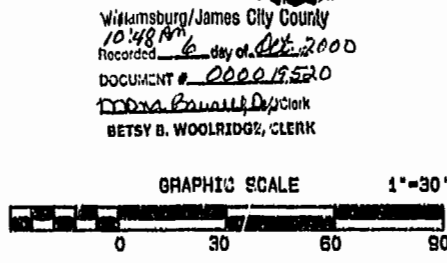
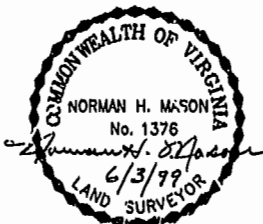
