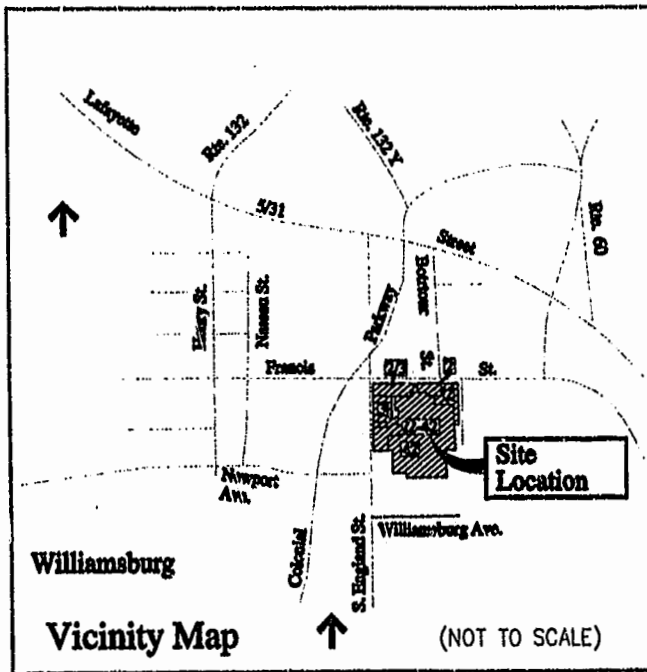

1. THIS PLAT IS INTENDED TO CREATE A 15' WATERLINE EASEMENT TO BE CONVEYED TO THE CITY OF WILLIAMSBURG, VIRGINIA THROUGH THE PROPERTY OF THE COLONIAL WILLIAMSBURG FOUNDATION..
2. LEGAL REFERENCES: PARCEL BOUNDARY INFORMATION COMPILED FROM "VACATION AND COMBINATION PLAT, THE COLONIAL WILLIAMSBURG FOUNDATION, WILLIAMSBURG INN, CITY OF WILLIAMSBURG, VIRGINIA BY VANASSE HANGEN BRUSTLIN, INC., FRANK G. MUNDY, II, L.S., DATED AUGUST 9, 2000, REVISED NOVEMBER 29, 2000" AND NOT ON A CURRENT FIELD BOUNDARY SURVEY. 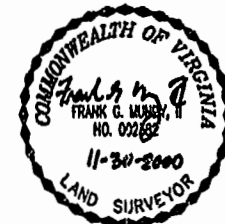

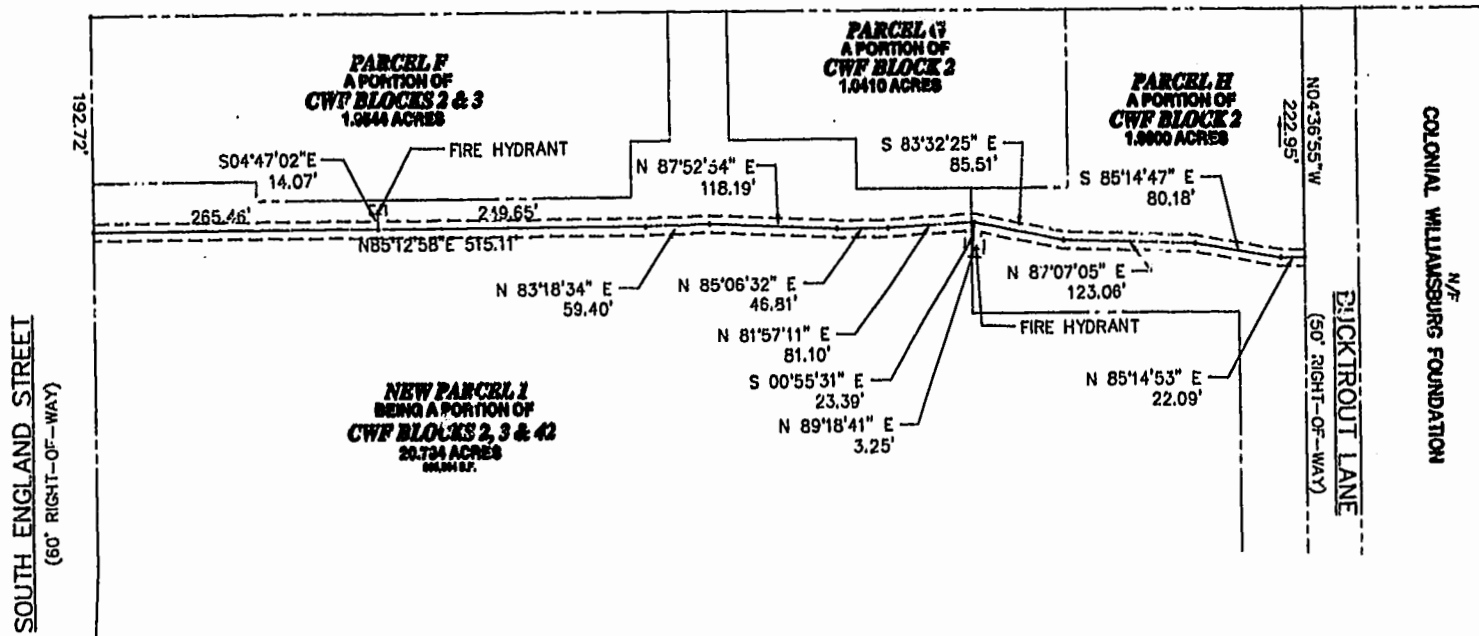
Surveyor's Certification
