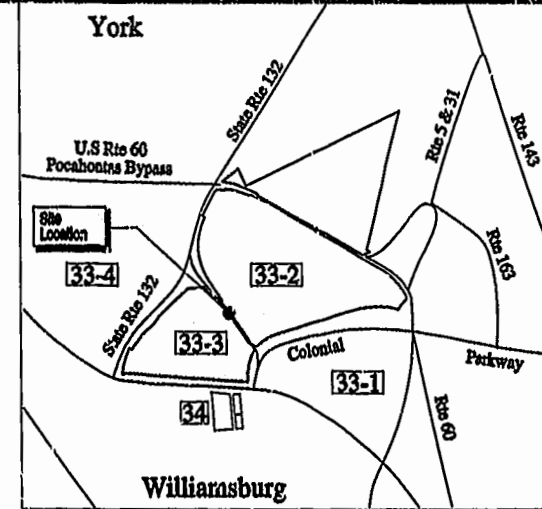

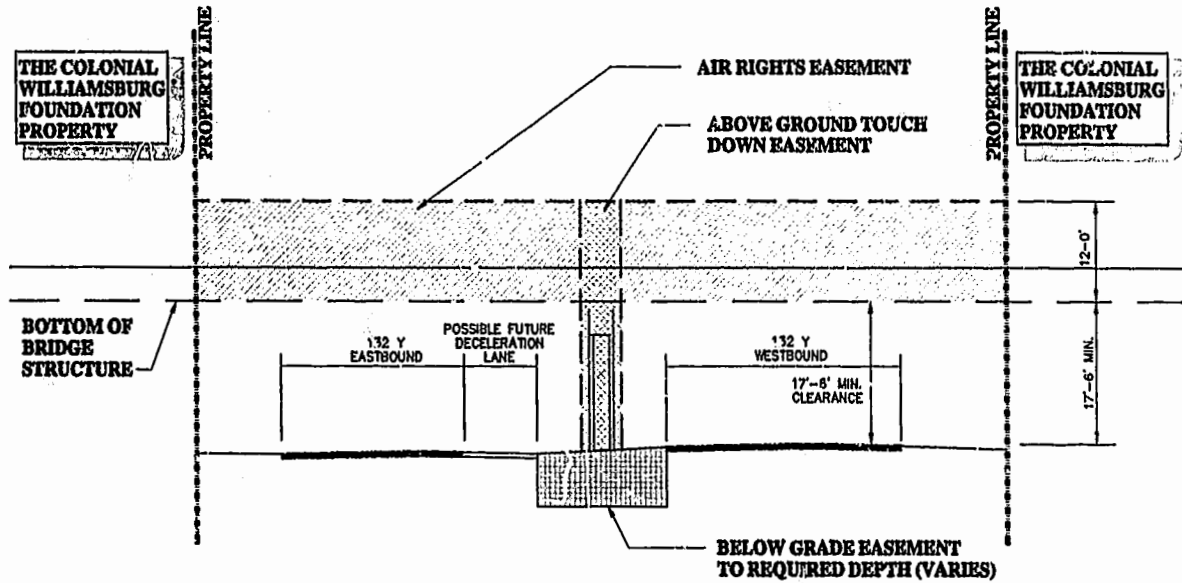
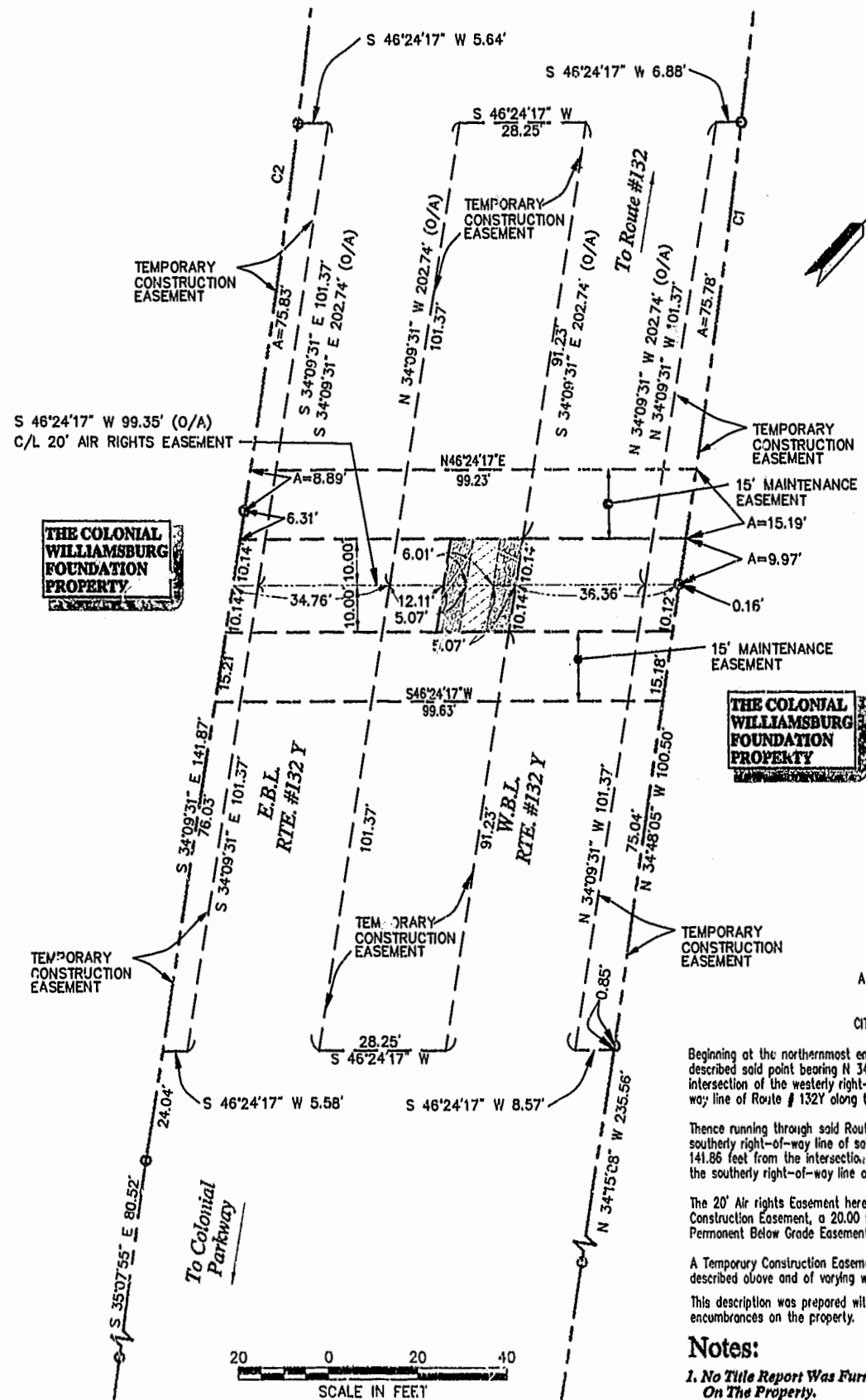

 A 20 FOOT AIR RIGHTS EASEMENT
 ACROSS
 ROUTE # 132Y
 CITY OF WILLIAMSBURG, VIRGINIA

Beginning at the northernmost end of the centerline of a proposed 20.00 foot Air Rights Easement herein described said point bearing N 34° 15' 08" W 235.56 feet and N 34° 48' 05" W 100.34 feet from the intersection of the westerly right-of-way line of the Colonial National Parkway and the northerly right-of-way line of Route # 132Y along the line of the Colonial Williamsburg Foundation;

Thence running through said Route # 132Y S 46° 24' 17" W 99.35 feet to a point, said point being on the southerly right-of-way line of said Route # 132Y and bearing N 35° 07' 55" W 80.52 feet and N 3° 09' 31" W 141.86 feet from the intersection of the westerly right-of-way line of the Colonial National Parkway and the southerly right-of-way line of Route # 132Y along the line of the Colonial Williamsburg Foundation.

The 20' Air rights Easement herein described is 20.00 feet wide and also encompasses a Temporary Construction Easement, a 20.00 foot wide Permanent Touchdown Easement and a 20.00 foot wide Permanent Below Grade Easement as shown in more detail on the attached Plat.

A Temporary Construction Easement has been defined as 100' to each side of the easement centerline described above and of varying width as shown on the attached Plat.

This description was prepared without the benefit of a title report and does not, therefore, indicate all encumbrances on the property.

Notes:

1. No Title Report Was Furnished, Therefore, This Plat May Not Show All Encumbrances On The Property.
