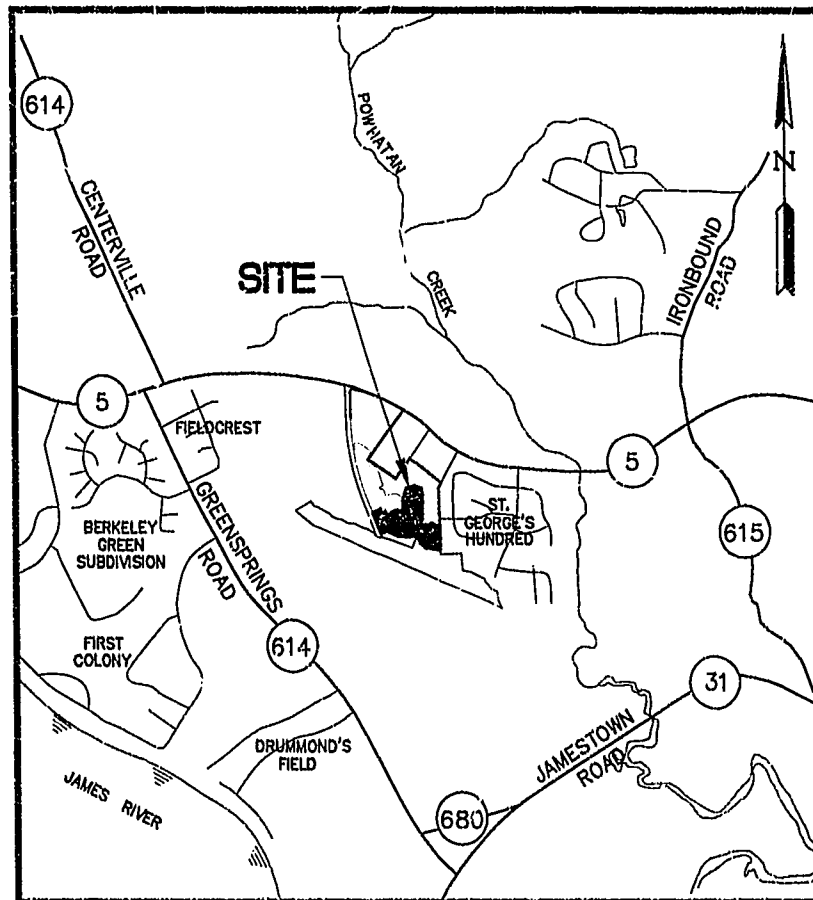

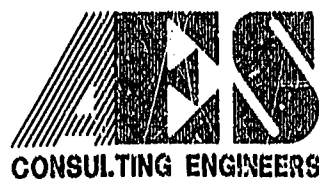
LOCATION MAP
